### TECHNICAL LEGISLATION:

- T-1 Late Technical Planning Proposals require 90% ADOPTED
- T-2 Distance event regulations at Southeastern Championships DEFEATED
- T-3 Alternate women and men's heats in the 800 and 1500 freestyles. ADOPTED
- T-4 Approve morning only choice for the 1500 and 1650 freestyles. DEFEATED
- T-5 Approve 10 minute breaks prior to the 11 & 12 800/1000 and 1500/1650. APPROVED
- T-6 Go back to standard 8 place scoring AMENDED AND ADOPTED
- T-7 Require 15 & 16 qualifying times to be slower than 17 & 18 times. DEFEATED
