# Southeastern Swimming House of Delegates Meeting April 26, 2003

Meeting Called to order at 8:35 by Brian Wrighton, sitting in for Mark Walker.

Meeting began with introduction of the new executive secretary, Tom Healy. Roll Call. See teams present above.

A motion was made to approve minutes from fall meeting. Passed unanimously with no changes.

#### **Old Business:**

Terri Rice reported about the US Swimming registration increases. Regular athletes currently pay \$25 per year to US Swimming as part of their LSC dues. The total, including the SES charge, is presently \$30. The regular athlete charge by US Swimming is going to increase to \$40 for 2004. It will increase another \$1.00 each year until 2014, making the total collected by US Swimming \$50. Executive Board recommends the LSC leave their fees collected the same.

There was a motion to keep the LSC fee at \$5.00 for next year in conjunction with the USS fee of \$40. This will make the total due from regular athletes \$45.00. Passed.

A motion was made to charge the seasonal athlete dues to \$23.50. This reflects an increase of the US Swimming fee from \$12.50 to \$20 USS and the normal \$3.50 LSC fee. Motion passed.

# **Officer's Reports**:

Admin Vice Chair (Brian Wrighton for Mark Walker) - Presented the changes of section 3.2 Duties of Officers to the Board. Specifically, changes to the Executive Secretary job description. These changes include communication and a presence at technical planning meetings to record and answer questions. It is a non-voting presence. Motion made to accept the changes to 3.2 Duties of Officers. Motion passed.

Registration (Tom Healy) – A report was given to include all current registration numbers. Numbers came from Karen Darmondy, interim Executive Secretary.

Treasurers Report (Clark Hammond) – SEE PRINTED REPORT. Distributed profit and Loss Statement for September 2002 through March 2003.

Congratulations to John Hartman for being named NAIA Coach of the Year.

Technical Chair (John Morse) – THERE IS A CHANGE IN ZONE SELECTION. There are only six athletes being selected from each age group, instead of seven. The selection process will remain the same for the first five (point value) and the sixth slot will be the filled using the previous process for used for slot 6-7.

The discussion about a three-day format for Championship Meets was tabled until next meeting.

There was concern was expressed about safety at Southeastern

Championships during warm-ups. A committee was formed to report on this issue next meeting.

Relays will be limited to 1 per team at next Southeastern Championship Meet.

New SES time standards were approved.

Any swimmer entered in Districts may swim on a relay.

Restating intent to have two courses for Southeastern meet.

There was a question about the wording in Aquatics Guide proposal 2.3 Season Schedule, changing to a 120 mile limit instead of 150 miles. It was reported by Ed DeBruyn that this would reduce conflict between teams hosting meets in large cities that fall into these mileage constraints. This will begin with long course season.

Technical planning recommended approval of email results change. Technical planning recommended against Alice Wagner's proposal to change dates of House of Delegates meeting for fall.

Technical planning recommended approval of Chris Snyder's proposal to abolish summer districts beginning 2004.

An accident report was given for this LSC for 2002. Accidents were fewer in 2002 compared to the previous year

The new Marshall vest was displayed. The vest is strongly recommended by the SES Executive Board.
