Policy and Procedures.

It is currently required for a person to be MR-EX to serve on Officials Committee. New policy is a MR-Q may be elected with the understanding that they become a MR-EX within 2 years.

Elected member of the committee may be removed with support of SES Chair and 2/3 majority of committee members.

Discussed how to advertise OQMs and encourage officials participation in these meets with aim to increase members with national certifications

Discussed process of how committee members are able to update certifications of officials in their region and other administrative responsibilities. Discussed various methods of tracking sessions worked by apprentices and how to

Discussed the selection of committee chair and possible changes needed to current procedure. Currently the chair is elected for a 2 year term and may be re-elected for one additional 2 year term. Some felt there was possible conflict with the 3 year term for committee members. After discussion it was agreed that no change is currently needed.
