Those who received the previous extensions to July 1, 2021 will automatically be extended to September 1, 2021 without any further action required.

It is important to note courses which can be completed online, such as membership requirements and other certifications, must be updated on or before its current expiration date. These courses include Athlete Protection Training, background checks, Coaches Advantage Training, and online Safety Training for Swim Coaches.
