## **Old Business:**

#### - LEAP

 LEAP 1 certification is completed for the next 4 years. Discussed at the BOD conference call meeting to examine the difficulty in obtaining a LEAP 2 certification. This would allow us to obtain funds from USA Swimming for getting the certification.

#### Southern Zones

- Will be in Cary, NC this upcoming year August 2 6. The following year it will be back in Tupelo, MS.
- Will be getting a new committee together to begin planning for Cary, NC.
- Everything went well from Scott Wilson's end on paying bills and collecting money.

#### USA Convention

- WV represented well at Convention by sending 3 representatives and 2 athletes. Tom Phillips, Derek Weaver, and Toni Woollweever were the representatives and Noah Woollweever and Bryce Weaver were the athlete representatives.
- The mayor of Tupelo came to speak at the Convention about the air quality and that changes would be made prior to the next Southern Zones meet in 2017. Tupelo was the only team to come forward and bid

- on the 2017 Southern Zones meet. Derek believes it will again be the first week of August in 2017.
- Consent Agenda was a big topic at convention. Most LSC's are having the subcommittees meet prior to the HOD meeting and then it is the memberships' responsibility to review the minutes from those meetings prior to the HOD meeting. Minnesota has seen an increase in participation on the HOD meeting since implementing the consent agenda. It has significantly shortened the HOD meetings which causes more people to attend.
- Officially more clarification on deck changing, bullying, and allowing the wearing of 2 swim caps.
- Next year's conference is in Atlanta, GA September 25-28.
- Really pushing for a 20% athlete representation on all committees and boards in LSCs.

## **New Business:**

- Southern Zones times submissions policy
  - Recommendation to use actual long course times available and ONLY use converted short course times if long course times are unavailable.
  - Proposal to change "short course best times to say long course best times" and add new entry "long course best times will be used first and short course times will be converted only if the swimmer does not have a long course time in that event".
  - Motion to accept recommendation by Greg Olson. Seconded by Bryce Weaver. All ayes.
- Clarifying voting privileges for multiple site teams
  - All teams regardless of satellite groups has 3 votes.
- Officials Chair
  - Sonia Chambers is wishing to resign as the officials chair. Derek Weaver has been willing to accept that position as officials chair. Motion by Greg Olson to accept Derek Weaver as the new officials chair. Seconded by Bryce Weaver. All ayes.
  - Derek will be attending the Officials Conference in Dallas, Tx.
- Waive all membership fees for officials

- Suggestion that once officials are educated that the teams send in their officials to the LSC to get their fees waived for background checks and non-athlete fee. Follow the same process as the background check policy. Teams be responsible for their officials reimbursement.
- Cost for officials so far would be roughly \$2,500 \$3,100.
- Teams would have to submit a list of officials for reimbursement to the officials chair. A form would be generated to be reviewed with the officials chair, registrar, and treasurer. Begins 2016.
- Unattached officials would contact the officials chair directly for reimbursement.
- Motion to reimburse all new and existing officials by the LSC as submitted by the clubs to the LSC. The cost would consist of the annual non-athlete membership fee to the LSC. The unattached officials will submit directly to the officials chair. Motion by Greg Olson. Seconded by Bryce Weaver. All ayes.

## - WVS LC State Champs Venue

- Recommended Long Course from BOD to hold the meet July 8-10 in Christiansburg, VA.
- Motion by Greg Olson, seconded by Ashley Peters. All ayes.
