- **Meet Sanctions (Eric Anger)** 4 teams have been doing sanctions; they are all online and email Eric for sanctions meet file and meet manager file
- Officials (Rob Clevenger) thankful for plenty of WV officials to cover for SC champs and hoping to have plenty of coverage for LC Champs; positives for USA Swimming looking to streamline officials process for all LSCs for the official initial requirement and to maintain, currently in collection phase from all LSC to make it more uniform; also

looking for a fast track to go from 0 – deck ref in ~18 months for some lower level LSC meets:

- Records (Sarah Nisewarner) after SC state champs most of the SC records
 accounted for except for some relays; LC state meet records are updated for last year
 but need to be in the MM file upcoming meet; the actual STATE records are needing to
 be researched more; Sarah received a list from Clarissa Sutton from a long time ago, will
 need some more research to finalize and updated.
- Registration/Registrar (Lora Snodgrass) still some tweaks and updates; registration continues to be online for both athletes, nonathletes, and clubs
- Safe Sport (Erin Ballard) nothing new to report
- Southern Zones (Tara Kurilchick-Green) 35 swimmers committed to attending; 4 chaperones; 4 coaches; bus and hotel are booked; Zone meet packet came out 4/15 and will get posted to website; GroupMe has been set up to communicate with parents; working on securing team practice; theme is Candy Land contacted Ryan Zundell to work on shirt designs
- SWIMS (Melissa McGlothen) teams will continue to submit meet results for approval; if there are corrections to meet results afterwards those need to be done in the original met file to upload; it was discussed that teams are able to build their meets in SWIMS for sanctions and can upload results/approve (show up in the USA Swimming TIMES search) will inquire if a team has the ability to do this, do results still need to be submitted to approve by chair?
- Operational Risk Committee/Safety Chair (Pinar Nalcakan) nothing to report;
- Governance Chair (Dana Morr) as this is his first meet in this role, goal is to check on policy and bylaws to make sure it follows from USA Swimming; will look through policy/by laws and suggest things that need to get updated; will need to ask for some volunteers to be on committee to get representation to other teams

Old Business:

- Long Course State Meet review and planning 19 over will be allowed to have their own heat for finals; athlete cap is currently 500 (last year was 301); motion for 2023 meet will be capped at 400 and WV teams will get first priority and non WV teams after (emails will be sent to visiting team about their order); unsure of cost as of 4/16
- **Bids for vendors** Swim-and-Tri is a one year agreement; we got 20% commission from their apparel sales for doing the meet; if we did a 3 year agreement we can do 30% commission from their business

New Business:

- Review SC State Meet and future planning
 - Pros- senior recognition on FB and at meet; awards went smoothly; meet ran smoothly

- Cons long session timeline before the decision was made to move 10-unders to separate session; best interest of swimmers however long for coaches/officials/volunteers.
