### Scholarship Rules & Guidelines:

- 1. Limited funds are available for scholarships each swim season. Scholarships are (1) not guaranteed, (2) offered at TSM Aquatics' discretion, and (3) can be discontinued if the club finances are no longer able to support them.
- 2. These guidelines provide the board with a process to rank applicants against the team's current scholarship funds. The team may provide a Tier 1 or a Tier 2 scholarship, **dependent on the total annual scholarship budget**.
- 3. Scholarships are **for Program Dues only**. Annual Patron, TSM Hosted Support Fees, and other related program fees and equipment chargebacks are excluded from support.
- 4. Scholarships awarded will be **posted retroactively (for each billing month)** after the board approves the scholarships during the first meeting following the scholarship submission deadline on September 7th.
- 5. **Applicants must apply on an annual basis** by September 7th of each year, or at the time they join. Registered and continuing athletes will have a priority over new or athletes with pending registrations. Preference is given to applicants who have been awarded in the prior team season. Renewal is not guaranteed and is based on current club financial position. **Scholarship recipients are reviewed each quarter** against the funds available and to ensure they are meeting the participation requirements, as noted below.
- 6. As a condition of their award, TSM scholarship recipients agree to attend practices and meets/games as required for their group. Failure to comply with the condition may result in the loss of the scholarship. Scholarship recipients are encouraged to review the training and meet/game expectations for their respective groups.
- 7. As with all TSM families, the families of scholarship athletes are expected to provide volunteer time to the club. This includes the following requirements (as applicable): timing at swim meets, fulfillment of volunteer requirements at home swim meets/games, and participation in various fundraising activities including participation in the annual fundraiser (Splash for Cash). Additional donations of time and energy are encouraged to support TSM.
- 8. Applicants who are not awarded the scholarship, but otherwise qualify, will be put on a **waiting list** for that year only. The board will review the waiting list should current award recipients leave or fail to meet requirements and, if funds are available, award the appropriate scholarship amount to the next qualified recipient.
- 9. All applications are treated individually and confidentially.
