- A. Treasurer's Report- Chris MacCurdy
 - a. Currently in the bank: \$15,557.37.
 - b. The following are still outstanding collections:
 - i. DM Sr. Circuit # 1 surcharges & \$ 150.00 meet host fee
 - ii. A & M- Sr. Circuit # 2 paid \$ 620.00 in surcharges, still outstanding \$ 150.00 meet host fee and \$ 120.00 in surcharges
 - iii. TXLA/ U.T.- Sr. Circuit # 3 surcharges & \$ 150.00 meet host fee--- hopefully they have received from the State of Texas Comptrollers Office our Texas ID Number as a vendor so they can pay.

 - d. In order to be granted non-profit status we needed to add a dissolution section to our bylaws. The following was proposed:

 For discussion and approval/ disapproval: Upon dissolution, the net assets of TSC shall not inure to the benefit of any private individual, unincorporated organization or corporation, including any member, officer or director of TSC, but shall be distributed to USA Swimming,

to be used exclusively for educational or charitable purposes. If USA Swimming is not then in existence, or is not then a corporation which is exempt under section 501(c)(3) of the IRS Code and to which contributions, bequests and gifts are deductible under sections 170(c)(2), 2055(a)(2) and 2522(a)(2) of the IRS Code, the net assets of TSC shall be distributed to a corporation or other organization meeting those criteria and designated by the TSC Board of Directors at the time of dissolution, to be used exclusively for educational or charitable purposes.- M/S/A

V. New Business

- A. USA Swimming Convention Recap- Sectional changes starting in 2015:
 - o Discussion on changes for Summer Sectionals
 - o Starts in 2015

- The summer Sectional meet shall be no more than four days long and must conclude between 8 and 22 days before either the US Open or Junior Nationals, depending on which one comes first
- o Summer Sectional must have at least one 18 & under heat
- o Discussion on changes for Spring Sectionals
 - o Meet cannot be longer than 3.5 days
 - o Meet must have at least on 18 & under heat
- The USA Swimming Senior Committee will publish a set of ceiling times for the Sectional meet. Sectionals will still set their own time standards, but they cannot be faster than the Sr Committee set of times.
- Sectionals may not be more than 800 athletes for one course or 1100 athletes for two courses. If this happens, there must be a change for the following year (two sites, faster time standards, etc).
- D. New TSC Board- five automatic board positions- Longhorns, Lakeside, NTN, Dallas Mustangs, Nitro placed Top 5 at Senior Circuit Champs. FCST and CFSC were added from the floor.
