1. (insert in all meet information) **The Meet Management may adapt the starting procedures and timelines to accommodate unusually large, or small, meets.**

2. (insert in all Sectionals meet information) **Fax Entry Deadline: Only swims achieving the qualifying time standards for the first time from (Sectional meet entry deadline), through (Sunday prior to Sectionals), may be sent by FAX transmission. These faxed entries must be received no later than 11:59 p.m., Central time, (Monday prior to Sectionals).** Fax entry can not be used to improve any the seed time of a prior entry.
3. Seed **all** of SC Sectionals prelims fastest to slowest
4. SC Sectionals: Drop awards and add one (1) heat of finals
