Dear Friends.

USA Diving is pleased to invite your Federation to participate in the 2013 UANA Junior Pan American Games, from September 26-29 at the Hillenbrand Aquatic Complex in Tucson, AZ.

Number of Divers: There will be individual and synchronized diving competition in the 3-meter springboard event. Two (2) divers per individual event and one (1) team per synchronized event per Age Group are welcome to participate from your country.

Entries, Housing and Payment: The meet headquarters hotel will be Aloft Tucson University -1900 East Speedway Boulevard Tucson, Arizona 85719. The hotel is located approximately 1 mile (about 10 minutes walking) from the Hillenbrand Aquatic Center. Hotel reservations may begin as early as Monday, September 23, 2013. Meals will begin on September 23rd with dinner and will conclude with breakfast on September 30. Please make your housing arrangements through National Travel Systems. A form is attached to make your reservations and payments. Accommodations and meals will be at a cost of \$150 (USD) per person per day for double or triple occupancy and \$219 (USD) per person per day for single occupancy. Incidentals and/or extra expenses will be the responsibility of the participant(s) or the Federation they represent. A minimum down payment of 50% of the full amount due should be sent to National Travel Systems by June 17th along with your Preliminary entry form. Your Final entry form and final housing final payment will are both due August 15th.

Entries: Preliminary entries with hotel requirements and partial payment are due June 15th, final entries are due August 15 and final payment by August 15. We are unable to guarantee availability of rooms after September 6, 2013.

Registration/Results: Scoring will be managed "Live" and online exclusively at www.divemeets.com. DiveMeets will provide athletes access for online entry, and provide an email confirmation that each individual dive sheet is processed. If errors are noted during the registration process, the rule checker prompts the individual to review the error and make the correction.

Results will be posted following each event by the meet control room at the pool. Live results will be available through www.usadiving.org and www.divemeets.com for families and fans.

Technical Meeting: The technical meeting will be held Wednesday, September 25 with a time and location to be announced.

Visa and Medical Insurance: Many countries are now required to interview for a USA visa. If your Federation or diver(s) are required to obtain a United States visa, please initiate the process as soon as possible to avoid any problems. We want to emphasize the importance of getting interviews as early as several months in advance to avoid delays in getting your visas. Federations are reminded they must have medical insurance for their team. The Organizing Committee will provide first aid if required. Individual Federations are responsible for all other necessary medical expenses.
