Page 1: OPENING CEREMONIES

Page 9: ATHLETE VILLAGE

- LSC's must have at least one chaperone in Athlete Village to supervise any time their athlete(s) are using it.
- Tents are provided. Sidewalls, tables and chairs need to be ordered if desired. (Although we are trying to get the facility to provide 1 table per team.) The order form is on the meet website in the TEAM SUPPORT area.
- Question: Can we use our own tents? Answer: No, the facility won't allow it for liability reasons.
- Question: How hot is it usually in August? Answer: 90-100 degrees
- Question: Will there be electricity available if we want to bring our own misters or fans? Answer: Yes, if you let us know in advance we will let the facility know to provide electricity to your area.
- Question: Will the athletes need to show a deck pass to get in and out of the pool area? Answer: No, 3 sides of the pool deck are within the credentialed area so the athletes won't need to show credentials to enter it from the Athlete Village, but they will need to show it to get to the facility from the parking lot, and they will need to show it to get back into the Athlete Village area after using the locker room and/or rest rooms as they are not contained within the athlete village. (We lamented this fact, but it is what it is.)

Page 9: TEAM BOX LUNCHES & DINNERS

- We are working to respond to the request that more substantial dinners be offered. If so, they would be more catered type--large pans--of food rather than individual box lunch type items. (Dinner only.) Right now Olive Garden, Noodles & Co. and a private catering business are being consulted. We will let you know the results as soon as we know.
- Question: Can you arrange it so the dinners can be delivered to the hotels? Answer: As meet management, we cannot take that on, but we can provide you with the names of businesses (if we are able to get them--see above) who may be willing to deliver to the hotel. The teams could then handle the details of that on their own.
- Question: Is it possible to get a list of where all the teams will be staying: Answer: Yes. It was suggested it be posted on the meet website and looked like we'd be going in that direction, however, I have since decided that athlete protection comes first and I don't want to publish online where each team will be staying. So instead, we plan to email the list of hotels where teams will be staying, along with the contact information for someone on each team to the team contacts and they can forward it as needed.
- One long-time coach shared why he liked to have dinner delivered to the pool. His ideas included: It was nice for those who didn't make finals not to have to wait so long to eat and also to be able to feed them there then get the athletes to bed quicker when they got to the hotel.
