Athletes compete on one of 17 "all-star" teams from their state or region. Athletes, coaches, officials, team support personnel, families of swimmers, spectators, meet volunteers, zone and national swimming leadership attend a variety of event activities.

5. What are the time standards and how many "q" times must my swimmer have to participate in Zones?

You can find the 2016 time standards at utahzones2016.com under the *Time Standards* Tab. Each LSC has its own guidelines regarding the number of "q" times a swimmer must have to be eligible to attend the meet.

6. I have heard that if a swimmer only qualifies for a few events that they may be eligible to have "bonus" swims. If so how many?

This again is determined by each individual LSC. Please refer to your specific LSC for guidelines on this matter.

7. If my swimmer ages up during the meet will they participate in their new age group? The swimmer's age on the first day of the meet determines the age group in which they will compete for the entire meet.

8. Are there opportunities to volunteer during the meet?

Western Zone policy encourages each LSC to provide 3 timers and at least 1 deck or admin official for all eight sessions. We would be delighted to have more. You may go to the utahzones2016.com and click on the *Volunteers* tab for more information or to sign up. Volunteers working at least two sessions will receive Rocky the Raptor T-Shirt. Other incentives are available for working more.

9. Is lodging available?

Yes, local hotels have partnered with the meet to offer close lodging at a great price through July 18th (or when full.) The meet website: <u>utahzones2016.com</u> has a link. Click on the *Plan Your Trip/Hotels* tab at the top of the page. (NOTE: A few additional rooms MAY be made available via the link after July 11th if meet officials do not use all rooms reserved.)

10. Can you buy coffee and be served alcohol in Utah?

4. I've heard officials need to apply to work the meet. Why?

The application process allows for advance planning, including mapping out deck positions and shirt orders. This level meet requires a large number of officials to run effectively.

5. Where do I go to find out more about the meet and how to apply to officiate?

Application forms and the meet announcement, which has extensive information for officials on pages 10-11, are available at: utahzones2016.com. Questions may be directed to Team Lead Chief Judge Kristin Fox bknfox@comcast.net

6. Is there an application deadline?

Yes. It is **June 15** for the assigned positions of Deck Referees, Starters & Chief Judges (FYI: Often 6 of each position are used at each session so please sign up for one (or more) of these positions if qualified) and **July 20** for stroke and turn positions and Requests for Evaluation. (NOTE: Applications greatly aide meet planners and are very much appreciated, but don't stay away just because you missed the deadline.)

7. How will I know if I've been accepted to officiate the meet?

Acceptances for assigned positions will be sent on or about July 1st; all others will be sent on or about July 23rd (we won't turn anyone away!). If not contacted by July 25, contact Kristin Fox bknfox@comcast.net

8. Can you explain what a "National Official Qualifying Meet" is?

This meet and other "national level" meets are called: Officials Qualifying Meets, or OQM's. This means the meet is approved by USA-Swimming as an event where national level certifications can be obtained. Officials may apply to be mentored. National level evaluators are available to observe, mentor and certify. The mission of the USA-

Swimming National Certification program is as follows: To develop officials who are competent, current and consistent from the LSC level meet to the highest level in our sport through a progressive training program based on an accumulation of experience acquired by specific meet attendance, mentoring and constructive evaluation. More information is available on the USA Swimming website.

9. Do officials need to already be nationally certified to apply to work this meet?

No, but they must be current members of USA Swimming and an LSC certified official.

10. Do officials have to be observed by an evaluator?

No. Evaluations are done on a voluntary basis. The application form has a section that allows officials to indicate their interest in being evaluated. Please don't let the fact that evaluations occur discourage involvement.

However we strongly encourage all officials, especially locals, to take the opportunity to get additional training and mentoring. It is rare to have an OQM in Utah and the process is extremely helpful. In the end, it is the swimmers who benefit when officials are well-trained and experienced.

11. How many officials participated in Age Group Zones meet in Hawaii last year?

More than 85! This included over 10 Chief Judges (5 per session), 12 starters and 12 Deck Referees and a ton of stroke and turn officials. Your help is greatly needed!

12. Are there a minimum number of sessions officials need to work in order to participate?

No, however a minimum of 4 sessions is required in order to be evaluated for national certification. It takes many volunteers to run a successful meet. The application form includes an area to select the session(s) that will be worked. This greatly aides planning. However, walk-on officials will also be gladly received the day of the meet. Your help is needed.

- 13. **Is there financial assistance to help offset travel expenses of officials who work at least 80% of the meet?** Yes. The Western Zone has 2 programs to help officials with travel expenses. Contact your LSC Officials Chair for more information. (Links to each LSC website are available on the first page.)
 - **Officials Mentoring Program (OMP)**: Provides free lodging for up to 2 officials from each LSC. These officials (one to act as mentor and the other, one with strong potential) are designated by the LSC Officials Chair by June 30th to receive meet provided lodging.
 - **Officials Reimbursement Fund**: Provides some reimbursement assistance to those who are not receiving funding benefit from another source, like the OMP.
- 14. Are there discount hotel accommodations available for officials and if so, whom do I contact?

Yes! We are pleased to be able to offer a large number of discount hotel rooms to all officials **up to July 10**th. For a link to the discounted lodging and more information contact either Adam Caldwell adam@binghamsnow.com or Kristin Fox bknfox@comcast.net

15. **Is carpooling and/or coordinating transportation with other officials flying in for the meet an option?** Yes.
