| FACILITY: | Indoor 50-meter pool. 7' deep at the shallow end and 17'1" deep at the deep end; the pool has overflow gutters; non-turbulent lane markers; and Paddock starting blocks with backstroke handles and foot wedges. Colorado Timing System will be used. Sessions will be run in the 50M competition pool set up in the shallow end. The meet host will ensure that the competition course meets the required dimensions as specified in 103.3 USA Swimming Rules and Regulations. Lifeguards and AED devices are available at the facility. In order to provide parents/guardians who are outside of the facility the ability to view their athletes' events, this meet may be video streamed following all MAAPP guidelines. | ELIGIBILITY: | Open to all athletes who are registered with USA Swimming before the first day of the meet 2025-2028 NAG time standards are in effect. No on-deck USA Swimming athlete registration will be permitted. Age on May 2, 2025 will determine age for the entire meet. | | | | | |
| DISABILITY SWIMMERS: | Athletes with a disability are welcome and shall provide advance notice of desired accommodations to the Meet Director. The athlete (or the athlete's coach) is also responsible for notifying the session referee of any disability prior to the competition using the <u>Disability Accommodation Form.</u> | | | | | |
| ATHLETES WITH A SERIOUS | The swimmer (or the swimmer's coach) is responsible for notifying the Meet Referee, prior to the competition, of the medical condition that is potentially life-threatening while swimming and of any requested accommodations. | ENTRIES: | DEADLINE FOR THE RECEIPT OF ENTRIES IS Tuesday, April 22, 2025 Athletes may enter 2 events on Friday. 12 & under athletes may enter a maximum of 4 individual events on Saturday/Sunday. 13 & over athletes may enter a maximum of 3 individual events per session and 5 total events on Saturday and 4 individual events on Sunday. Entries will be processed in the order received and accepted to the greatest extent possible without exceeding the 4-hour/session timeline limit or the limits as mandated by current Commonwealth of Virginia guidelines. Deck entries will be accepted for athletes already entered in the meet to the extent that open lanes are available. | | | | | |
| FEES: | Individual events: \$12.00 Swimmer surcharge: \$2.50 per person (entered in the meet in any capacity) | | | | | |
| SEEDING: | All events will be pre-seeded except Friday Events and 13 & over 400 Free. Positive Check-in for Friday events and Saturday's 400 Free will close 30 minutes prior to the end of warmups. | | | | | |
| AWARDS: | No awards for 13&Over events 12&under Events: Single Age Group 1st-8th place. (12,11,10,9,8,7&under) | | | | | |
| PENALTIES: | A fine of up to \$100 per event may be assessed for any illegal participation in the meet. Illegal participation is defined as Entries using fraudulent or non-verifiable times. Athlete competed in the incorrect age group. Athlete is not registered with USA Swimming prior to the first day of the meet. | | | | | |

| | Any swimmer entered in the meet must be certified by a USA-S member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement. | | | | |
| | Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present without written USA Swimming approval. | | | | |

| | An athlete suspected of sustaining a concussion or exhibiting signs of a concussion will immediately be removed from competition and shall not return to competition that day. The athlete may return to competition on a subsequent day, but only with a release authorization signed by a licensed healthcare provider. | | | | |
| | In accordance with VSI Policy, only those coaches who have current, valid USA Swimming credentials will be permitted to act in a coaching capacity at this meet. Coaches with expired or non-current credentials will be required to leave the deck area. | | | | |

- Only Aquatic Staff are permitted in the Aquatic Offices, Equipment Room and First Aid Office unless approved by Aquatic Staff Management.
- Smoking is NOT permitted within the Town of Christiansburg Aquatic Center.
- The Town of Christiansburg Aquatic Center is not responsible for any lost or stolen items. Make sure someone you know is always present supervising individual/team belongings.
- No unauthorized persons are permitted to use the stereo system without the permission of the Aquatic Director.
- No glass containers of any kind are to be brought into the pool complex.
- Parking violators will be subject to fines and/or towing as posted.
- Overflow parking may be pre-arranged with Kroger or Christiansburg High School on weekends.
- The Aquatic Center strongly encourages showering prior to entering the pool.
- All emergency exits and walkways must remain clear.
- Each club is responsible for supervising the conduct of its swimmers/spectators. Swimmers are not permitted in any room not directly associated with the meet.
