### **Proposed Changes to Policies and Procedures**

#### **G. CLASSIFICATIONS, TIME STANDARDS and ENTRIES**

**Current Wording:** 

4. Entry times must have been achieved in USA Swimming sanctioned or approved competitions, or observed swims. "Coaches Times" (CT's) or "No Times" (NT's) are permitted when specified in the invitation in meets until the championship series of meets begin for both short and long course seasons. At no time may Coach's Times be faster than a BB time standard. NTs are restricted to entries requiring BB or below time standards.

#### Proposed Change:

4. Entry times must have been achieved in USA Swimming sanctioned or approved competitions, or observed swims. "Coaches Times" (CT's) or "No Times" (NT's) are permitted when specified in the invitation in meets *including District Champs, Summer Awards and 15-18 swimmers participating in Regional Champs. "Coaches Times" (CT's) or "No Times" (NT's) are not permitted at Age Group Champs, Senior Champs or 14 & under swimmers participating in Regional Champs.* At no time may Coach's Times be faster than a BB time standard. NTs are restricted to entries requiring BB or below time standards.

Eastern Zone Competition Information Pertaining Only to Long Course Zones Current Wording:

h. In the event that Senior Championships occurs after Age Group Championships, individual event results and relay lead off splits for 14 and younger swimmers may be used towards the number of events in which the swimmer qualifies. Time trials and intermediate splits from any race will not be included for consideration.

#### Proposed Change:

- h. In the event that Senior Championships occurs after Age Group Championships, individual event results and relay lead off splits for 14 and younger swimmers may be used towards the number of events in which the swimmer qualifies.
- i. Time trials and intermediate splits from any race will not be included for consideration.

#### A. RECORDS

1. In order to be considered for VSI Age Group and Open records, a swimmer or relay team must be registered with USA Swimming and representing VSI when the time is achieved.
