Call to Order John Stanley

• The meeting was called to order at 7:02 pm.

Consent Agenda

Approval of the Minutes from October 25, 2020 Emily Fagan

The minutes were approved.

Treasurer's Report

Bob Rustin

- Treasurer's Report is attached.
- Revenues are coming in strong. Expenses will pick up now that we are into championship season.
- In February, Bob moved \$20,000 (\$10,000 per fund) into the endowment fund. There has been a \$4000 return on the investment. BAC account totaled \$125 for the year.
- Rebates will be a shortfall through February. Revenue for SC was down for meet rebates because the meet sizes were small.
- For meets through January, we have received \$14,000 from PVS and Maryland Swimming. DC and MD are not holding meets so PVS is looking to VA to hold meets. Tim Husson has asked about considering a different fee structure for out of LSC athletes.
- The motion to approve the Treasurer's report passed.

General Chair's Report

Bryan Wallin

John presented the report for Bryan.

- USA Swimming Board of Directors and Committees Athlete Representation. In response to the passage of the Empowering Olympic, Paralympic and Amateur Athlete Act (EOPPA), USA Swimming will hold a special HOD meeting on June 30 to vote on proposed bylaws changes needed to comply with the new regulations. Delegates to the convention in 2020 should have received an email to attend the meeting. Key highlights:
 - o The number of athletes must be one third of the USA Swimming Board of Directors and committees.
 - The athletes must be 10+ year athletes and competed at an international level for USA Swimming.
 - o It is not clear how it will affect LSCs. No LSC bylaws changes are necessary for 2021.
- Steve said we need to be prepared for it to trickle down to the LSC Board and committees.

Senior Vice Chair's Report

Report Attached. There were many observations expressed by committee about Senior Champs.

- Differences in the starting apparatus at the two facilities.
- Rotation of warmups with three warm up periods.
- Clubs who experienced meets in Richmond this year were aware of the COVID restrictions. Teams who had not been to the facilities were less aware and communication could have been better to not the avoid confusion.

- Discussion of Order of Events on deck was done way in advance prior to Senior Champs was a frustration with the number of questions.
- The committee was unanimous in their appreciation of the efforts of Mary and Emily for their work to make the Age Group and Senior Championship meets.
- The Senior Committee also appreciated the officiating staff at Senior Champs and to Dan Demers for leading the team.

There was considerable discussion about coaches unaware of the details/changes to the meet.

- It was suggested that the Senior Committee with the Age Group Committee, partner with the Coaches Committee on educating coaches on the importance of engagement in the LSC and where to find things on the website.
- Mike suggested that the Coach, Senior and Age Group committee meet combine efforts to help get the word out. Senior and Age Group champs had a lot of changes. He also noted we are in unique times with the pandemic. He suggests starting the discussion at the Coaches Committee level.
- Most coaches do not read the meet announcement until it is time to do entries.
- Drew proposed that we examine larger boundary LSCs about keeping information flowing. With smaller meets, the coach interaction has been lost. Athletes were best served by being flexible and changing the meets once the numbers were realized.
- John suggested a Zoom presentation for the Senior and Age Group announcements are released. The board does not come up with the meets. The Age Group and Senior committee come up with the Championship meets.
- Mike asked if the district meets could have been better. There were facility limitations were a huge factor with the SE District meet. Weather was also a factor with the 9-12 District Champs. The Senior Committee focused most of their attention on Senior Champs leaving the 13 & O Districts to the hosts and Age Groups. For the summer meets, we need to determine what is wanted out to the meets.
- Much was a done for the betterment of the athlete but in some cases it fell short. The meets will not be perfect or make everyone happy.
- For LC season, there are three Summer Awards, Senior Champs and Age Group Champs meets that are hosted by great hosts. The board is happy to facilitate communication between committees and meet hosts.

Age Group Vice Chair's Report - Drew Hirth

- Drew felt like the meet at both sites was the best that could be offered. The athletes were inside and it felt like a real meet.
- Drew noted that we can be proud of what we have been able to provide for our athletes and the hard work of everyone involved.

Finance Vice Chair Report - Bill Geiszler

The budget will be put together in the next month. Budget items for consideration that not included in previous budgets or changes should be sent to Bob, Bill or Dave.

Bill has started to examine the finances to see if there is money to offer more grants this year. He will review with the committee to project where we are financially and determine if we can afford to give grants.

Safe Sport Vice Chair Report - Maureen Tolliver

• As of February, VSI is 8th nationwide in percentage of teams who have achieved Safe Sport recognition. There are 12 additional teams still to achieve Safe Sport recognition. Maureen anticipates that all 12 will complete their Safe Sport Certification.

- Trainings are posted on the website.
- VSI Logo has to be changed to remove the USA Swimming shield from our logo. New digital files are forthcoming. Anything already with the logo can still be used. **The motion to approve the updated logo passed.**

Governance Committee Report

There is an election coming up. The committee is charged with soliciting nominees for the next board. HOD will be virtual. The committee has to be announced 20 days prior to HOD. Nominations are done with a volunteer interest form.

Athlete Committee Report

Scholarships were awarded to Blake Johnson (ODAC) and Tim Higgins (SRVA) at Senior Champs.

Coach Committee Report - Mike Salpeter and Morgan Cordle (Submitted)

- Coaches are reflecting about how they could have done more with the committee to squelch some of the issues that arose with the two meets.
- Was there a consideration of an AG and Senior Champs East and West combined meet?
- Regular season LC meets need to consider granting access smaller teams.
- There was discussion about consideration for spectators at meets. The Virginia Forward guidelines must be followed.

Executive Director's Report

- Our current registration numbers are:
 - o 6500 athletes (flex, premium and outreach).
 - The outreach numbers are a little higher this year. There is a higher number of flex this year as well as flex upgrades.
 - o We are down 7.2% compared to where we were this time last year.
 - o Anyone who joined after June 1 will be valid through December 31, 2021.
 - o 907 non athletes (955 last year)
 - o 39 clubs (46 last year) some clubs joined together or became satellites.
- Overall, our numbers are good relative to USA Swimming being down 30% across the country. Many LSCs are half of what they were in previous years. VSI is fortunate to have been able to have meets and in person championship meets.
- A club has requested a waiver for a \$278 service fee because the check was mailed and not received. There is evidence of a stop payment on the check. **The motion to waive the service fee was approved.**
- A club had to have their athletes unattached. The club is more than 60 days in arrears for the registration of their athletes. The club is not a coach owned club. The issue will be turned over to the Admin Review Committee. The coach indicated that there are two athletes on the team who chose not to register for 2021, but their registrations were included in their registration file. The organization will not pay for all of their athletes while there are two outstanding registration payments at the club. Every month without paying, there is another service fee added one.

Old Business - none

New Business

- 1. Proposal to continue VSI's Procedure 45 Fees and Surcharges through LC
 - **a.** We currently have a suspension of fees for failure to get sanctions in 60 days prior to the start of the meet. The board is requested to approve an extension of the suspension of the policy

and the changing the re-sanctioning fee to the end of LC season (August 31, 2021). **The board** approved the extension of suspension of the policy and waive the change fee to August 31, 2021.

2. Discussion of fees received from PVS for Athlete Endowment

- There is a \$2.50 endowment charge per athlete participating in a meet held within the boundaries of the LSC. PVS does not like that the athletes are being treated differently than VSI athletes who are changed 20 cents per splash. PVS believes they are paying double than what they would be paying if the fee were the same as it is for VSI athletes. John will send the information received from PVS. This will be old business for the April meeting. Bob pointed out VSI would wait a full year to re-evaluate. There was a motion to extend the out of LSC fee of \$2.50 for another year. The motion was approved.
- 3. Governance Committee status no report
- **4. Request to re-evaluate our policy on meets during Championship weeks.** This item will be tabled with a proposal for the April meeting. Send John any thoughts about the policy change. Chad will assist with the evaluation of the policy. HOD will have to act on a change. The Senior committee also has a position on the issue. Mary will also be involved.

Virginia Swimming Senior Committee Report

1. Current working groups.

- Commonwealth Classic Update (no report).
- VSI Senior Circuit Update (no report). The next meeting will be 12:00 noon, Friday, April 23rd (tentatively scheduled)
- Senior Camps, Clinics Update (no report). WG Chair has sent information to the working group about a meeting next week.

2. Summer Senior Champs Working Group (initial report attached)

- **Working Group Meeting:** The working group met on April 14. There was discussion about the boys "getting the short end of the stick." The deadline for the decision about Senior Champs will be May 15. Next working group meeting will be 1:00 PM, Wednesday, April 28th
- Backup Site for LC Senior Champs: Mary suggested having a backup site lined up.
- **Relays**: Relays were at Liberty for a college championship meet using odd lanes.
 - ✓ We are still dealing with the same distancing limitations by the Governor. We have not changed the policy so far. Steve asked if the number of relays could change. Mary suggested that we limit the number of relays a team could compete.
 - ✓ CSAC is not allowing relays right now. Peter suggested the meet be four full days. Liberty cost is the same whether it is 3 ½ days or 4 days. Liberty is a per day fee.

Working group action items:

- ✓ Protocol for relays
 - A suggestion was offered to not swim all of the relays. Limit each team to one relay instead of two.
 - There are 30 relays at Age Groups versus 10 relays at Senior Champs
- ✓ Order of events
- ✓ Moving to a four-day meet.
- ✓ Athletes on Deck: Need to know about the number of athletes on deck. Need tol get information about spacing at Liberty for Age Group Champs.
 - Until VA allows less stringent spacing, we are handicapped in the number of athletes on deck.
 - Senior Champs will influence Age Group Champs considerations as well. The working group needs to keep this in mind.
- ✓ Flighting Finals. Consideration for boys and girls groups for flighting finals. Additional warmups would be needed. Sometimes it is a more efficient use of time to have both genders swim together.

3. Communication Alternatives for Senior Committee business, recommendations, and decisions

- The Working Group discussed ways to get information out to make sure all coaches are receiving information in a timely manner.
- Currently information is posted and relayed in a timely manner we may not be effective reaching our intended audience.
- The athlete committee has not been involved in communication which could precipitate information sharing.
- We will work with the business office to increase dissemination to club presidents, head coaches, and club contacts.
- More robust effort must be made to communication with coaches committee to increase education on how to stay informed and to not solely focus on our championship meets when entries are due.
- Social media should be used to direct people to the website.
- Concerns were expressed about when COVID protocols, updates, and changes are sent out. They can be sent earlier but they often change as circumstances change and/or restrictions are updated.

• OME available for late entries was a good enhancement this year. The challenge was the high school meets and times not in SWIMS.

4. EZ Updates (report attached)

- LC Sectional meet entries were opened two weeks ago. On April 12th, there were 400 athletes entered and the limit is 500 athletes. The meet is a trials qualifier.
- SC Sectional meet was very small. At the last minute it was changed to a prelims/finals meet. The northern states who came to meet were so thankful for the work done to pull off the meet.
- The AG Zone meet discussion is ongoing. The format is up in the air and there is a possibility of having the meet. It may not be the Zones meet we are used to. More information to come.

5. Tech Planning Request about Championship progression for 2022.

- A schedule needs to be presented at the April HOD meeting.
- High school state meets February 17-19
- Option 1: Keeps the progression the same with a break the weekend of February 18-20.

February 11-13: 9-12 Champs

February 18-20: Break

February 25-27: 13&O Champs

March 3-6: Senior Champs

March 10-13: Age Group Champs

Considerations:

- ✓ Concerns expressed over the early start for 8&U swimmers, effectively ending their season 60 days prior to the close of the SCY season.
- ✓ Break between the 9-12 Champs & 13&O Champs is driven by VHSL Champs and not as beneficial for teams/swimmers.
- Option 2: Start the progression a week later. Pro: 8 & U are in the water longer Con: five weeks in a row

February 11-13: 8&U Champs February 18-20: 9-12 Champs February 25-27: 13&O Champs March 3-6: Senior Champs

March 10-13: Age Group Champs

Considerations:

- ✓ There was concern that it is hard on the staffing for small teams.
- ✓ Several committee members agreed many small teams will likely staff each meet with coaches working with the age range of the meet and will not pose a problem even for small teams.
- ✓ There was also concern about not having enough officials.
- ✓ No break between meets
- ✓ Suggestion was provided to put the 8 & U meets on the same weekend as Senior Champs.
- Option 3: Hold 8&U Champs on same weekend on as senior champs. 13&O Champs on Feb 11-13. 12&U Champs on Feb 18-20. Feb 25-27 open

February 11-13: 13&O Champs February 18-20: 9-12 Champs

February 25-27: Open

March 3-6 - Senior Champs & 8&U Champs

Considerations:

- Regional high school meets are held during the week not on the weekends.
- ✓ Mary mentioned concerns over age up dates.
- ✓ Northern district would compete as a 12 & U meet on Feb 18-20.
- ✓ Four pools are needed (3 pools for the 8 & U meets, one pool for Senior Champs.)
- ✓ According to the VSI Policy and Procedures manual, Tech Planning sets the championship meets for the season in consultation with the Age Group and Senior Committees.
- ✓ There are no policy or procedural changes necessary to enact this suggestion.
- ✓ The Age Group Committee will also make their recommendation.
- ✓ Richard motioned that we approve Option 3. Peter seconded the motion. Further discussion and vote will occur electronically.
- Electronic feedback from the committee on each of the options lead us to recommend Option 2 at this time.
 - ✓ There is a strong feeling that Option 3 can work if we find an effective alternative for the age up swimmer.
 - ✓ There is the belief that considering the placement of the 8&U Champs meet either on the same weekend as Senior Champs or on the open weekend in option 2. Each topic requires more time and discussion.
 - ✓ Only half the committee responded to the request for feedback.

6. Hosting Meeting during the championship season.

- The current policy is to reserve all of the weekend's in the championship meet progression. No meets can be held during the championship period. The problem is that 13 & O who are not in the regional champs meets, they have a long break for those athletes for Senior Champs and Age Group Champs meets. Steve asked if we want to modify the championship progression.
- Committee recommended age group and senior champs remain protected. For the other weekends, non-championship meets may be held as long as not in direct competition with the meet of the weekend (i.e., no 12&U meets can be held the weekend of the 12&U district meet).
- The recommendation was reported to the VSI BoD and forwarded to the AG Committee and Tech Planning Committee for their endorsement/action.

VSI Long Course '21 Senior Champs Subcommittee Meeting (April 14th, 2021)

Attendees: Jonathan Kaplan (SRVA), Chad Onken (QSTS), Anthony Pederson (RAYS), John Poorman (CGBD), Steve Hennessy (CGBD), Richard Hunter (TIDE)

Items of Discussion

• Order of Events

- Group: Previously decided plan was to return to "old" order of events for LC '21 and SC
 '22 before returning to "new" order of events for LC '22
- <u>Chad</u>: SC '21 meet had events on right days, but we may need to look into the order of events within each day (in particular the 200 fly being first each time)
- Group: New order of events likely to be discussed in future Senior Committee meetings, but we may want to look at the order for this meet. Consensus from subcommittee was they would go with whatever others wanted as long as we gave ample time for coaches to know in advance

Qualifying Times

- Richard/Steve: Reminded the group that there was discussion of the 1000/1650 distance events having too many participants at SC '21.
- Group: Consensus was that we do not want to change qualifying times, in particular distance races, until we as Senior Committee has time to address the concerns of a lack of opportunities for athletes to compete in distance races throughout the season

Anticipated Participation

- Steve: From discussions with Mary, we can expect similar participation for LC '21 as we had in SC '21 plus some additional college swimmers. She feels we will be able to keep one location with the possibility of either a combined prelims session, or split gender sessions again
- <u>Anthony</u>: Expressed concern for boys getting the short end of the stick with quick turnarounds between sessions at SC '21 meet. <u>Steve</u> mentioned that decision was made with intent to keep the days consistent for the athletes since no matter how you did it, one gender would get the short end more than the other.
- <u>Richard</u>: Raised the question of whether or not we should have a location back-up option secured in advance in case something comes up the precludes Liberty from being able to host. The Group agreed.

Possibility of Relays

- o <u>Group</u>: Consensus that we all would like to have relays.
- Richard: We may need to consider format changes to relays in order to make it happen if necessary. (Possibility of limiting relay numbers per team further, etc)
- Steve: We should follow-up with Liberty to determine if they are comfortable with relays happening and how we would need to do them. That would assist us in further decision making. We should also follow-up with VSI to determine if there will be any relaxing of the current rule of no more than 2 relays per 8 lanes in a competition pool per heat.

• Additional Discussion

- Richard: Raised the point that we should probably have a date to have things set and determined like we did with Jan 15th for short course.
- Group: Agreed with Richard and decided on May 15th as our current date, knowing that we will have 2 Senior Committee meetings, a House of Delegates meet and another Senior Champs LC '21 Subcommittee meeting before then to get it all figured out.
- Steve: Mentioned we should consider a new approach to communicating information to coaches. Expressed concern that even with our attempts to communicate changes in a timely manner, there are coaches in the LSC who are still not getting the information or are not involved enough for whatever reason.
- Jonathan: Mentioned that we should reach out to Coaches' Committee (and maybe even Age Group Committee) to look into a multi-layered media approach to distributing information beyond email and website only.

EZ TECH PLANNING RECAP

EZ 2021 Winter Sectionals – Recap

The final meet format was prelim/final for 3 days and the format was well-received by the athletes and coaches in attendance.

EZ 2021 Summer Super Sectionals Richmond VA – Status Update

Four day prelim/final meet. 326/500 athletes were entered in the first 24 hours on OME. There are 30-40 waiting to be checked out with a 500 athlete max cap. Standards will remain unchanged from 2020.

EZ 2021 Open Water Champs Middlebury, CT

Jen Lyman was unable to attend today. She reported that CT are still not open fully and is hopeful to push the CT Open Water Meet to August 2021. She feels it is in the best interest of the Eastern Zone to offer two open water championships to best serve the needs of the athletes across the Eastern Zone for 2021. Tim Husson requested that Jen draft a proposal for consideration at the Eastern Zone spring meeting for funding for two meets vs. one meet, potentially reappropriating/utilizing funds from 2020/2021.

EZ 2021 AG Zones - Richmond VA

2021 will mark the first Eastern Zone Age Group Championship without 15 and overs. It is expected there will be 13/14 prelim, 11/12 prelim, 10 & under timed final, and finals. There will be a 250 athlete cap per session as with all meets at SwimRVA. Mary Turner, Marci Callan, JoAnn Faucett, Carol Healey, and Tristan Formon will work on developing a format for consideration by technical. The 2021 Age Group Zone Meet will likely look very different to prior years. If all 12 LSCs attend, we will be looking at an average of just over 20 athletes per session per LSC.

EZ 2021 SNR Zones - Buffalo NY

Tristan had a conference call with TJ Day on Tuesday. Star Swimming are likely to be able to host 150 athletes per session, with flighted prelims and then finals. ABC final, similar format to Super Sectionals.

EZ 2021 Winter AG Zone Champs Leaderboard – Status Update

Tim Husson reported that he pulled results this past weekend one more time in order to capture any outstanding meets. The 2021 Eastern Zone Leaderboard is now final. Marci reported that Webster are now permitting two team meets through July and it is unlikely that the Eastern Zone will be able to host an in-person spring short course yard Age Group Zone Championships.

LSC Updates: Competitive / Water Access Status

AD – Jenn reported that some teams are functioning. There have been a number of intrasquad and dual meets thus far.

CT – Ellen/Rick reported that CT have dropped their cohort regulations. There is no longer a limit on numbers in lanes provided 6 feet social distancing is maintained. There have been a few



more dual meets and in-house meets. They are hopeful to have a potential LCM Championship series including senior and age group with 200-225 athlete caps.

ME – Marcel said that a number of teams are running workouts and dual meets. Indoor capacity is up to 50% or 50 people, whichever is greater. In May, this will transition to 75% or 75 people.

NE – Patrick/Aaron reported they just wrapped up their LSC leaderboard for the past 6 weeks with good participation. All meets were SCY. Bids are starting to come in for the summer, all are SCY with one LCM meet bid. There are hopes for a LCM championship. As weather improves, there are hopes for access to outdoor water, specifically LCM.

NI – Marci reported that access to water is still regional. There are teams in the Buffalo area who have been able to have access to 17-18 competitive opportunities but very scattered opportunities throughout the balance of the LSC with many teams partnering to create opportunities.

NJ – TJ reported that the YMCA held their national festival (NJ location) this past weekend. There have been a number of dual meets and intrasquads, restrictions are easing. NJS recently wrapped up its 4 week leaderboard.

PVS – Tim reported that PVS has sanctioned 75 SCY meets since October. All of the meets have been in North Virginia. MD is still restricted to 4-5 per lane for practice and no competition. DC is restricted to 1 athlete per lane. There have been two LCM time trials in Northern Virginia. PVS recently wrapped up a robust championship series serving many athletes throughout the LSC.

2021 Registration Summary: At this point our total athlete registrations are down 5.7% when compared to this date last year. USA-S was down just under 30% at the end of March. Approximately 100 more athletes who registered as Flex have upgraded to Premium this year when compared to last year and those are included in the Premium total. The reduction in the number of clubs can be explained as follows: 2 clubs became satellites of another club, 1 club merged with another club, and 4 clubs did not renew due to COVID restrictions and pool availability. (Numbers don't match because 1 club renewed this year after not doing so last year.) Of the 4 that did not renew, I believe at least of two them will renew next year.

Coach Certifications: The Risk Management Committee for USA Swimming reviewed the list of courses that meet the requirements for certification/recertification and many courses were removed from the list. Before enrolling in any CPR/AED course or lifeguarding course, be certain to check the list (Coach Safety Requirements) to ensure that the course is on the approved list. Also, coaches whose CPR/AED certification expired on March 31st can receive an extension until September 1st (just extended from July 1st) if a certificate for completing the online component of the course is submitted to the office. In addition, the in-water component of Safety Training can also be extended to September 1st if an updated certificate for that online course is submitted or if the current expiration date of the online course is after September 1st. The hands-on or in-water component of each course must be completed and the certificate submitted to the office by September 1st for the certification to be valid after that date. Please check the certification dates for these courses in your Deck Pass account and let me know if you have any questions.

2022 Registrations: Premium athlete and non-athlete registrations fees will increase to \$83 and \$73, respectively, next year. This reflects a \$2 increase in the USA Swimming but no change in the Virginia Swimming fee. Flex registration fees will remain the same at \$20 but upgrade fee will increase to \$63. Flex membership will be handled the same for the 2022 registration year as it has in the past: athletes must upgrade if they want to compete in more than two sanctioned events or a championship meet. Additional registration information and documents will be sent to clubs in early July.

Covid Facility Fee: At the September Board meeting, #45 in the VSI Policies and Procedures was amended to allow host teams to charge a COVID-19 Facility Management Fee for meets with start

dates prior to May 1,2021, unless the Board extended the date. At this point, I recommend that we extend this provision through the end of August.

Officials Committee Report

- 1. Our website has been updated, courtesy of John Stanley and is much easier to search and find information.
- 2. We have hosted 17 Zoom Clinics for Officials training This has been a great medium for clinics for both new and tenured officials.
 - a. For new officials, 101 attended clinics for S&T, TEO and AO
 - b. For tenured officials, 20 attending clinics for advanced certifications.
 - c. The date and times of clinics are sent to the Team Chairs for distribution to their membership. Hopefully, all the clubs are seeing this information.
- 3. We are currently hovering around 400 Officials certified in VSI. This is a decrease from last year by approximately 70 officials. We suspect COVID-19 played a role in the drop off and whether some of those 70 or so officials return to officiating is unknown.
- 4. The LSC Officials Committee has completed the succession plan noted in previous years summary and it is posted on the webpage.
- 5. Officials Staffing at meets. There are a couple of items that clubs should review.
 - a. For an Officials to remain certified, our VSI Officials Handbook requires Officials to work, as a minimum, of 8 sessions per calendar year. In Non-COVID era, that equates to 32 hours per year. Suggest clubs look at their internal policy for yearly volunteer hours and hopefully be within the ballpark of our certification requirements to keep officials within the pipeline.
 - b. The Officials Team Chair is a key player when developing meet schedules. They should be administratively strong and a great voice for promoting Officiating and the need for officials. We have an Officials Team Chair Guide on our website that is available to anyone. Also, the LSC Officials Committee will be happy to host a Zoom Clinic on the same subject matter.

- (1) Chair The Chair of the DEI Committee shall be appointed and serve as specified in Policy section 5.3.A. The DEI Committee Chair shall actively participate in the Eastern Zone DEI Committee by attending meetings, expressing concerns, and sharing best practices.
- (2) Members The members of the DEI Committee shall be appointed and serve as specified in Policy section 5.3.B with the following additions. The committee shall include at least one (1) Coach Member and at least two (2) non-athlete members.
- (3) Duties The DEI Committee shall be responsible for the implementation, coordination, and execution of a diversity, equity, and inclusion program for VSI. The committee shall work with USA Swimming and the Eastern Zone to establish best practices within VSI. The committee shall:

 - (b) Communicate information about DEI programs and activities to VSI clubs; and

VSI Policies

18.3 The weekends on which District, Region, Age Group, and Senior Championships, as well as Summer Awards, are considered to be protected, and additional meets shall not be held on these weekends

1) It has been proposed that this policy be eliminated or altered to permit certain types of competition during the Championship weekends. Currently there are 4 or more protected weekends in a row during the SC Champs season (8&U Districts, 9-12 Districts, 13&O Districts, Seniors, & Age Groups). The Senior Committee has adopted a proposal that non-champs meets would be permitted on the weekends of Districts (8&U, 9-12 or 12&U, &13&O), but only if they did not compete with the age groups competing at the District Championships (eg. a 15&O meet the weekend of 8&U District Champs). SC Senior Champs and SC Age Group Champs would remain closed to all other competition. In the LC season, Summer Awards, as well as Age Groups and Seniors would remain protected. The suggested revised policy would read:

Proposed/Revised 18.3

The weekends which correspond to Age Group and Senior Championships, as well as Summer Awards, are considered protected, and additional meets shall not be held on these weekends. Additional meets in which the age groups competing do not correspond to those attending the District Championships, shall be permitted on District Championship weekends.

2) The current policy protects "weekends". As such, policy language suggests that weekdays between the weekends are not protected, and thus competition would be allowed. Depending on the person speaking, "weekends" may or may not include Thursdays and Fridays, which are typically competition days for several of our current championship meets. Do we also want to clearly define what constitutes "weekends"?

In addition to the above suggested policy change, Tech Planning has been considering several proposals re: next year's SC championship season, which should be considered at the upcoming board meeting. Some of the options are a departure from our "traditional" champs seasons, but really don't affect the above proposal.
