<b>LOCATION:</b>	<ul style="list-style-type: none"> <li>Jeff Rouse Swim and Sport Center, 1600 Mine Rd., Stafford VA 22554, Phone: 804-387-1279</li> </ul>		
<b>FACILITY:</b>	<ul style="list-style-type: none"> <li>The Jeff Rouse Swim and Sport Center provides 2 indoor pools and supporting amenities including hospitality and concession stand.</li> <li>Eight lanes, 50-meter competition pool, 12 feet deep at the start end and 6.7 feet at the turn end; overflow gutters with non-turbulent lane markers.</li> <li>All sessions will be run in a 25-yard course.</li> <li>Indoor 6 lane 25-yard pool for continuous warm-up, cool-down. Non-Turbulent Lane Markers in both pools.</li> <li>Spectator seating for 700 plus.</li> <li>The meet host will ensure that the competition course meets the required dimensions as specified in 103.3 USA Swimming Rules and Regulations. (USA-S Rule change.)</li> <li>There will be lifeguards and additional Aquatics staff along with 2 AED located on the opposite sides of the pool deck.</li> <li>In order to provide parents/guardians who are outside of the facility the ability to view their athletes' events, this meet may be video streamed following all MAAPP guidelines. By attending or participating in this competition, you acknowledge and grant permission to be included in the video-streaming.</li> </ul>

<b>ELIGIBILITY:</b>	<ul style="list-style-type: none"> <li>Open to all USA Swimming athletes registered before the first day of the meet.</li> <li>No on deck USA Swimming athlete registration will be permitted.</li> <li>2021-2024 NAG time standards are in effect.</li> <li>Age on October 12, 2024 will determine age for the entire meet.</li> </ul>		
<b>DISABILITY SWIMMERS:</b>	<ul style="list-style-type: none"> <li>Athletes with a disability are welcome and shall provide advance notice of desired accommodations to the Meet Director.</li> <li>The athlete (or the athlete's coach) is also responsible for notifying the session referee of any disability prior to the competition.</li> </ul>		
<b>ATHLETES WITH A SERIOUS MEDICAL CONDITION:</b>	<ul style="list-style-type: none"> <li>The swimmer (or the swimmer's coach) is responsible for notifying the Meet Referee, prior to the competition, of the medical condition that is potentially life-threatening while swimming and of any requested accommodations. Early notice (e.g. concurrent with the meet entry) is encouraged to allow for any needed planning or logistical support.</li> <li>This provision does not apply to medical conditions that are not life-threatening while swimming including injuries that limit range of motion.</li> <li>The swimmer/coach shall provide a Personal Assistant(s) as needed.</li> </ul>		
<b>FORMAT:</b>	<ul style="list-style-type: none"> <li>All 13 &amp; over swimmers will swim in the AM sessions.</li> <li>All 8 &amp; Under Swimmers will swim in a session immediately following the 9-12 Session on Saturday.</li> </ul>		

	<ul style="list-style-type: none"> <li>All 9-12 Year Old swimmers will swim in the PM session.</li> <li>All events will be timed finals.</li> <li>2 courses may be utilized for all or some sessions depending on the number of entries. Teams will be notified NLT Monday October 7<sup>th</sup>, 2024 if two courses will be used.</li> </ul>
<b>WARM-UP:</b>	<ul style="list-style-type: none"> <li>Saturday <ul style="list-style-type: none"> <li>13 &amp; O session: Warm-ups start at 7:00am; competition starts at 8:10am.</li> <li>9-12 session: Warm-ups start no earlier than 10:30am; competition starts no earlier than 11:30am.</li> <li>8 &amp; U session: Warm-ups start no earlier than 2:00pm; competition starts no earlier than 2:45pm.</li> </ul> </li> <li>Sunday <ul style="list-style-type: none"> <li>13 &amp; O session: Warm-ups start at 7:00am; competition starts at 8:00am.</li> <li>12 &amp; U session: Warm-ups start no earlier than 10:30am; competition starts no earlier than 11:30am.</li> </ul> </li> <li>Lane assignments and warm-up times will be posted on the RAYS website - <a href="http://www.swimrays.org">www.swimrays.org</a>, no later than Tuesday, October 8th, 2024.</li> <li>If any sessions run long, warm-ups for the following session will begin 5 minutes after the final event finishes from the prior session.</li> </ul>
<b>ENTRIES:</b>	<p><b>DEADLINE FOR THE RECEIPT OF ENTRIES IS WEDNESDAY, OCTOBER 2, 2024.</b></p> <ul style="list-style-type: none"> <li>Entries must be submitted in SCY times using Commlink-2 software. teams submit entries via email.</li> <li>Coach Time (CT) and "No Time" (NT) will be accepted for events in which a swimmer does not have a time of record. <b><u>CT must be slower than an "A" time.</u></b> All entry times other than CT must have been achieved in USA Swimming sanctioned, approved, or observed competition.</li> <li>Swimmers may enter a maximum of 4 <b><i>individual events per day.</i></b></li> <li>Entries will be processed in the order received and <b>accepted to</b> the greatest extent possible without exceeding the 4-hour/session timeline limit or the limits as mandated by current Commonwealth of Virginia guidelines.</li> <li>Email entries to: Anthony Pedersen, email: <a href="mailto:meetentries@swimrays.org">meetentries@swimrays.org</a>, phone: 703-919-5889</li> <li>Deck entries will be accepted in the order received for swimmers already entered in the meet, to the extent that open lanes are available. <b>SEEDING:</b>	<ul style="list-style-type: none"> <li>8 &amp; Under events only will have clerk course.</li> <li>All events will be pre-seeded.</li> </ul>
<b>AWARDS:</b>	<ul style="list-style-type: none"> <li>Individual events: Ribbons will be awarded for first through eighth place for 12 &amp; U swimmers.</li> <li>9-12 events will be given separate awards for 11-12 and 9-10 age groups.</li> <li>12 &amp; Under events will be given separate awards for 11-12, 9-10 and 8 &amp; Under age groups.</li> <li>8 &amp; Under awards for first through eighth place.</li> <li>Specialty awards will be awarded to heat winners for all 9-12, 12 &amp; U, 8 &amp; U individual events.</li> <li>No awards for 13 &amp; Overs</li> </ul>
<b>RULES:</b>	<ul style="list-style-type: none"> <li>The current USA Swimming Rules and Regulations including the Minor Athlete Abuse Prevention Policy will govern this meet.</li> <li>All adults participating in or associated with this meet, acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy (MAAPP) and that they</li> </ul>

	<p>understand that compliance with MAAPP is a condition of participation in the conduct of this competition.</p> <ul style="list-style-type: none"> <li>Any swimmer entered in the meet must be certified by a USAS member coach as being proficient in performing a racing start or must start each race from within the water without the use of a backstroke ledge. When unaccompanied by a member coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.</li> <li>Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present without written USA Swimming approval.</li> <li>Use of audio or visual recording devices, including cell phones, is not permitted in changing areas, rest rooms or locker rooms. In addition, photography behind the blocks is <u>not permitted</u>.</li> <li>Changing, in whole or in part, into or out of swimsuit when wearing just one suit in an area other than in a locker room, bathroom, or other space designated for changing is PROHIBITED.</li> <li>In accordance with VSI Best Practices, swimmers should shower before entering the pool.</li> <li>Any athlete suspected of sustaining a concussion or exhibiting signs of a concussion, will immediately be removed from competition and shall not return to competition that day. The athlete may return to competition on a subsequent day, but only with a release authorization signed by a licensed healthcare provider.</li> <li>In accordance with VSI Policy, only those coaches who have current, valid USA Swimming credentials will be permitted to act in a coaching capacity at this meet. Coaches with expired or non-current credentials will be required to leave the deck area.</li> </ul>
<b>PENALTIES:</b>	<ul style="list-style-type: none"> <li>A fine of up to \$100 per event may be assessed for any illegal participation in the meet. Illegal participation is defined as <ul style="list-style-type: none"> <li>Entries using fraudulent or non-verifiable times.</li> <li>Athlete competed in the incorrect age group.</li> <li>Athlete is not registered with USA Swimming prior to the first day of the meet.</li> </ul> </li> <li>If the swimmer is representing a club in competition, the fine will be levied on the Club. If the swimmer is unattached, the fine will be levied on the swimmer.</li> <li>Any event in which an athlete participated illegally will be rescored and re-awarded.</li> </ul>

<b>TIMERS:</b>	<ul style="list-style-type: none"> <li>Clubs will be required to provide timers in proportion to the number of swimmers they have entered in each session.</li> <li>Athletes must supply their own timers and counters for the 500 Free.</li> <li>The number of timers required per club and their lane assignments will be posted on the <a href="http://www.swimrays.org">www.swimrays.org</a> website, no later than Monday, October 7, 2024 and will also be emailed to the contact person of each of the individual clubs.</li> <li>Timers' meeting will be held approximately 30 minutes prior to the start of each session.</li> </ul>
