VSI Rules and Legislation Coordinator Report

October 31, 2025 (amended November 7, 2025)

As a follow up to the legislation passed at the September 27, 2025, USA Swimming HOD meeting, the Virginia Swimming Bylaws were updated to incorporate required changes that affected the duties of the Governance Committee. The changes were approved by USA Swimming on September 30, 2025.

The following is a compendium of proposals that range from Meet Announcement language changes to suggested procedure and policy changes. Some of this requires further discussion and some of this is ready for action.

UPDATE THE LANGUAGE USED IN THE "DISABILITY SWIMMERS" SECTION OF VSI MEET ANNOUNCEMENTS

Background: Rule 105.1.2A states the following: "The swimmer (or the swimmer's coach) is responsible for notifying the Referee, prior to the competition, of any swimmer with a disability and of the requested accommodations and/or modifications. The swimmer/coach shall provide a Personal Assistant(s) or any equipment (tappers, deck mats, etc.) if required."

The language in VSI meet announcements currently mentions only accommodations and not modifications, and the language has notice going to the Meet Director and not to the Meet Referee.

Proposal: First, update the section header to "Athletes with Disabilities." Second, adopt the language developed by the National DEI Disability Subcommittee. Two versions are suggested with the second version calling out the use of the parallel time standards when in use. Note that the linked "Athlete Accommodation/Modification Form" is currently linked in our Meet Announcements.

Language for meets with no time standards

- Coaches entering swimmers with disabilities that require any accommodations or modifications, including the need for personal assistants and/or registered service animals, must provide advance notice in writing, accompanying their meet entry file, to the meet referee by the entry deadline. Failure to provide advance notice may limit the host's ability to accommodate all requests.
- Athlete Accommodation/Modification Form.

Language for meets with qualifying time standards

- All swimmers with a disability must meet the Parallel Time Standards according to their performance group (P1, P2, P3) in every event they wish to participate in the meet. Coaches entering swimmers with disabilities that require any accommodations or modifications, including the need for personal assistants and/or registered service animals, must provide advance notice in writing, accompanying their meet entry file, to the meet referee by the entry deadline. Failure to provide advance notice may limit the host's ability to accommodate all requests.
- Athlete Accommodation/Modification Form.

POLICY AMENDMENT PROPOSAL (OFFICIALS: GENERAL GUIDELINES FOR DISCIPLINE AND DE-CERTIFICATION)

Purpose: In approximately 2002, the USA Swimming National Officials Committee developed a document covering "Officials: General Guidelines for Discipline and De-Certification." LSCs were encouraged/mandated to incorporate the guidelines into their operating policy. Virginia Swimming did so by incorporating the guidelines as a policy in the Virginia Swimming Policy and Procedures manual.

Based on comments made in the context of a recent LSC Officials Chairs meeting, Kevin Hogan followed up with Dana Covington (chair, National Officials Committee) and Derek Paul (associate general counsel, USA Swimming) as to the current applicability of the guidelines. Per Derek, there are sections of the guidelines that are no longer effective (eg, an LSC can no longer de-certify an official) and indicated that the language should be removed.

This proposal removes the guidelines in their entirety from the Virginia Swimming policies so that we are compliant with current practice.

The section would be intentionally left blank to avoid renumbering procedure sections 34-57.

POLICY AMENDMENT PROPOSAL (USE OF PARALLEL TIME STANDARDS FOR SWIMMERS WITH DISABILITIES)

Purpose: To encourage the participation of swimmers with disabilities in Virginia Swimming meets, any meet that uses minimal or maximal time standards, must also use the USA Swimming Parallel Time Standards for swimmers with disabilities.

Proposal:

17.3 When time standards are used to determine eligibility of a swimmer to enter an event in a meet, the ability of swimmers with a disability must be determined by using the USA Swimming Parallel Time Standards according to the swimmer's performance group (P1, P2, P3) in every event in which they wish to participate in the meet.

POLICY AMENDMENT PROPOSAL (OFFICIALS' TRAVEL REIMBURSEMENT POLICY)

Purpose: (1) Eliminate "lower" level meets from reimbursement consideration as there are now a sufficient number of Officials Qualifying Meets within Virginia Swimming that N2 and N3 certification evaluations can be met within the LSC. (2) Clarify that international meets, when held within the US, are reimbursable meets; (3) Allow for the reimbursement of a third meet if the third meet is a "by invitation only" meet. These meets would include Olympic Trials (for which policy already allows a third reimbursement for swimmers and coaches and for which current practice is to reimburse officials), the World Cup, and PanPacs. It should be noted that those officials receiving an invitation to officiate at "by invitation only" meets are officiating at a minimum of two, and often three or four, national level meets per year and are incurring substantial out-of-pocket expenses even when reimbursed for some of them. (4) Clarify that attendance at a National Championship Disability meet is required for reimbursement in that category.

Proposal:

- 29.2 The following meets qualify for reimbursement: Eastern Zone Championships, Speede Champions Series (Sectional Championships), Futures, TYR Pro Series, US Open, World Cup, and USA Swimming National and Junior National Championships; trials class meets including Olympic Trials and World Championship Trials; and international competition held domestically including, but not limited to, the World Cup and PanPacschampionship level meets identified in USA Swimming Rules and Regulations. Meets held within the VSI boundaries do not qualify for reimbursement.
- 29.4 VSI will reimburse an official for travel expenses no more than two times (three times if the third meet is Olympic Trials or another "by invitation only" meet) per fiscal year (1 September 31 August) for any of the meets listed in paragraph 2section 29.2 above. In addition, officials will can be reimbursed for attending one National Championship Disability Meet per fiscal year.

PROCEDURE CHANGE CONCEPT

Background: Championship meet entry deadlines are specified in VSI Policies and Procedures. VSI procedures currently state the following in procedures section 46.6.A "Other Fees."

Championship meet entries received after the entry deadline will be accepted at a cost of \$10.00/event up until the first day before the start of the meet. Beginning the first day of the meet, the charge will be \$25.00/event. These fees will be in addition to regular meet entry fees. Swimmers added prior to the printing of the heat sheet will be seeded as stated in the invitation. Swimmers added after the printing of the heat sheet will be seeded in the slowest heat in the appropriate empty lane. A new heat(s) will be added if necessary to accommodate these entries. The host team will retain fees received for these late entries.

I recommend changing this procedure for two reasons.

First, I think the standard set for late entries in this section is unreasonable. While adding a swimmer to an empty lane in an already seeded event is not a big deal, creating a new heat and reseeding two swimmers after the heat sheets have been printed and distributed is a big deal. While it may have never happened, section 46.6.A essentially allows for entries up until the start of an event. The section allows a coach to enter a swimmer into an event part way through a session and in doing so create a need to add a heat and reseed two swimmers into that heat.

Second, the procedure sets expectations that are not consistent with late entry practice at higher level meets. National and sectional meets all appear to set a deadline of noon two days prior to the start day of the meet.

Recommendations: First, I think it would be helpful to clarify that "other fees" applies to VSI Age Championship meets and VSI Senior Championship meets, but not to other championship meets.

My second recommendation is that we make the late entry deadline for AGC and SC be at noon two days prior to the start of the meet. If that recommendation does not have support, I then recommend the following:

- For Age Group Champs, for pre-seeded events on the first day of the meet, the entry
 deadline shall be 6:00 pm the day before the meet starts. For all other pre-seeded
 events, the entry deadline shall be 30 minutes after the start of finals the day preceding
 the event. For all positive check-in events, the entry deadline shall be at the close of
 positive check-in.
- For Senior Champs, the entry deadline shall be by the close of the scratch box or the close of positive check-in for the event being entered.

Discussion and consensus by the BOD is needed to determine if and how this proposal should go forward.

Updates: The finance committee approved grants in the amount of \$1,500/team(Teams noted above) for the Learn to Swim programs. All teams should have received their money from VSI by 08/31. The VSI budget this year for Learn to Swim was \$9K. This amount dispersed was over budget by \$1,500.00. This year was the largest number of applicants and also the largest amount of monies were granted by VSI.

The finance members requested that if an applicant did not provide the required documentation to the VSI(as outlined), then the applicant would be ineligible for future grants from VSI. Historically applicants

Registration Update:

• 2026 Registrations:

- Bulk Renewal Our teams continue to utilize the option to bulk renew athletes and non-athletes this season. Several teams used the TU integration that allowed them to register all athletes, new and returning, through its platform. Teams using Captyn also have that option, but I don't know if any teams elected to utilize it. Using the integration allows teams to handle registrations much like they did prior to SWIMS 3.0 except that the team is submitting the payment to USA-S instead of the LSC. Non-athletes must still be renewed through the club portal in SWIMS.
- Self-Renewal If clubs elect self-renewal, parents and non-athletes will receive automatic reminders from USA-S in the fall and will be able to renew directly from their member dashboard.
- ACH Registration Payments One thing that has surfaced is the delay in registration if a team pays by ACH instead of credit card. Athletes are not considered to be registered until the ACH payment clears which I have seen take as long as 10 days. As such, I have recommended that clubs only use ACH to when paying for renewals of currently registered athletes prior to December 1st. I have discussed this with USA-S staff and Board members explaining the challenges this
- Outreach: As has been our practice in the past, clubs identify athletes that qualify for Outreach membership. We provide eligibility guidelines for the clubs to use which include:
 - Free/reduced lunch
 - Medicaid
 - SNAP
 - Clubs can also provide an explanation of the method that they utilize to verify qualification such as YMCA scholarship guidelines.

Clubs are reimbursed for meet entry fees for their Outreach athletes. Because registration is now handled either by the parents or clubs, we do not participate in the actual registration confirmation process as we did prior to SWIMS 3.0. However, in order for the club to receive reimbursement of meet fees, we do still require documentation for each athlete from the clubs as to the eligibility guideline utilized. The date we receive the form is the first date for which

- meet fee reimbursements are provided. Last year we created an online form to make it easier for teams to submit the document
- <u>Club Fees</u>: USA-S increased the club fee to \$225 this year so our teams will pay \$255 when clubs renew for 2026 because it will include our \$30 fee. The registration fee for a new club registration is \$750 plus our \$30 LSC fee. If I recall last year's legislation correctly, the \$750 fee is only required for the first year of membership and will then revert to the \$225 USA-S fee for future years.
- <u>Satellite Clubs</u>: We currently have three clubs that have satellite branches: BASS (two satellites), GATR (1 satellite) and NOVA (1 satellite). Basically, each of the clubs and its respective satellites join together as one team at meets but they have separate governing bodies and keep their finances separate. Because of that, it was our practice to charge the satellites the same fee that each club was charged in the past \$100.

<u>Action Item</u>: With the \$225 USA-S increase in the club fee, do we maintain the current practice of charging each satellite the \$100 fee and provide a separate listing for each on the Club page of our website?

2027 Eastern Zone Meets: Bids for these meets must be submitted to the EZ Championship Meet Coordinator for consideration at the meeting which will be held in Denver next month. The following teams have expressed interest in hosting meets:

- SC Region 2 Sectionals, March 18-21, 2027:
 - o HOKI at CAC
 - NOVA at NOVA-Regency
- LC Super Sectionals, May 20-23, 2027: SRVA at CSAC
- LC Age Group Championships, either August 4-7 or August 11-14, 2027
 - o SRVA at CSAC
 - NOVA at NOVA-Regency

Action Item: Select the host team & location for EZ LC Age Group Champs bid

Coach Credentials at Meets: We feel that we need to make a change to the way we handle verifying coach credentials for meets. On the Monday prior to a meet, we send a list of all Virginia Swimming registered coaches to the meet director and meet referee. The name of any coach with a certification expiring prior to the meet is highlighted and we ask the meet director or meet referee to contact the teams attending the meet to alert them about the coaches who will not be allowed on deck if the certification issues are not resolved by the end of business that Wednesday. On Thursday an updated list is sent to the meet director and meet referee. Any coach whose name is highlighted should not be allowed on deck without his/her membership card. In general, this process works well but it's not an all-inclusive list: it will not include individuals who are not registered as coaches or coaches from another LSC. This could put insurance coverage in jeopardy. To address this issue, we propose requiring meet hosts to have a check-in procedure for meets.

Action Item: Approve requiring meet hosts to check credentials of coaches attending the meet.

Migration to Office 365 Business: Emily and I are happy to report that the migration is almost complete! This includes moving all of our shared files to SharePoint which will provide additional accessibility and ensure preservation of our historical documents. We are still finalizing the board members who will have VSI emails forwarded to their personal email accounts. More information to follow.

LC Zones: Again, this year Zone team registrations, team selection, and submitting entries were handled through Team Unify. The entire process from athlete registration to identifying the team to selecting events to collecting fees and refunding those who registered but didn't make the team went very smoothly.

Meet Director & Meet Marshal Workshops: Emily and I will be scheduling these workshops for multiple dates in September. Quite a few of our teams will need to renew these requirements this year so we are reviewing the material presented in previous years to update and streamline the workshops. Our first Meet Director Workshops are scheduled for Monday, September 8th at 10am and Tuesday, September 9th at 7:30pm.

Scholastic All-American: The application period will remain open until September 30th. Information about the requirements and application process can be found at https://www.usaswimming.org/times/popular-resources/scholastic-all-america. This year all ablebodied athletes who achieved a qualifying time and their head coach received an email inviting them to apply. Athletes with a disability should check the link above to find the Para Scholastic All American time standards to see if they qualify and follow instructions on that page to submit an application. USA Swimming does not have a way to identify those athletes and contact them directly. Emily serves as one of the SAA evaluators so please contact her with any questions or if assistance is needed.

Swimmers of the Year: The Senior and Age Group Committees are currently identifying the recipients of the awards. Single age awards are provided for males and females in the 9-14-year-old athletes while 15-16 and 17-18 are awarded by age group. This year the awards will be presented at each athlete's individual club practice. Details will be provided to the clubs once the recipients have been selected. The athletes will also be invited to Lunch with the Olympians between the sessions of the athlete clinic that is scheduled for September 14th.

Fall Education Weekend: This year's Swimposium will only feature a session for Officials. Information and registration links are posted on the website homepage and were emailed to all officials. The Swimposium will be held at SwimRVA – CSAC.

Additionally, there will be an Athlete Clinic will be held on Sunday, September 14th at the SwimRVA - CSAC. Kelsy Dahlia Worrell and our own Thomas Heilman will be the clinicians for the event. As mentioned above our 2025 Swimmer of the Year recipients will be invited to attend lunch with the Olympians in recognition of their achievement. Currently sessions for both age groups are almost full.
