

757swim Financial Assistance Information

757swim awards financial assistance to members based on (1) need and (2) availability of funds.

Application Deadlines are as follows (must complete a tryout at least two weeks prior to application deadline):

Short Course Season: August 1 Long Course Season: January 1

Eligibility:

- New or returning families with an annual income at or below 300% of the federal poverty level are eligible to apply for a full or partial scholarship towards membership dues for one season (short course or long course). Families are welcome to re-apply for subsequent seasons.
- Current member families in good standing who do not otherwise meet income eligibility requirements may apply for full or partial scholarships if the family has experienced an unexpected severe financial hardship such as an illness, house fire, etc.

Financial assistance is never guaranteed. The scholarship committee—comprised of at least three board members—will allocate funding based on need and fund availability on a first-come, first served basis. Financial assistance covers dues (full or partial). Families must expect to pay for other expenses such as team suits and practice equipment, meet fees, USA Swimming membership (either full or as an Outreach membership (see below for more details)) etc.

757swim will also assist eligible families with accessing benefits through Virginia Swimming's Outreach Membership program. Eligible families pay a reduced rate for USA Swimming registration and qualify for reimbursement of meet fees. Eligibility is determined by Virginia Swimming. Currently, Outreach families must be eligible for free/reduced meals through the National School Lunch Program.

Member families who receive financial assistance from 757swim must comply with team policies and other expectations. 757swim reserves the right to revoke financial assistance. In order to continue receiving assistance,

- Families must meet the expectations of the team Fundraising and Volunteer policies.
- Swimmers and families must comply with the team Code of Conduct. Inappropriate behavior may result in financial assistance being terminated.
- Swimmers must maintain a 70% practice attendance record (90% for Platinum Team

members).
