

2025-26 FUNDRAISING EXPECTATION

Welcome to another exciting year with H2okie Aquatics! As we continue our goal in offering a positive competitive environment and enhancing our swimmer's team spirit and sportsmanship, your support in fundraising is much needed. The NRVA Board of Directors voted to continue a minimum fundraising obligation for each family in order to establish sufficient operating funds for the 2025-26 year.

STROKE SCHOOL & MIDDLE/SENIOR PREP FAMILIES:

Stroke School & Middle/Senior Prep families have a reduced fundraising obligation compared to our Competitive Swim Team families. Stroke School & Middle/Senior Prep families are those defined as **only** having swimmers in the Stroke School or Middle/Senior Prep groups. Your fundraising requirement for 2025-26 are:

- **\$50 - September - May ***

Parents will be required to have their fundraising obligations paid in full at the end of May.

Your account will be automatically billed **June 1st** for any outstanding balance from each session.

*** If you elect to withdraw from the team prior to June 1st, you will be automatically billed for any outstanding balance of your fundraising obligation on your final invoice.**

SWIM TEAM FAMILIES:

'Swim Team Families' are defined as any family who has at least one swimmer in **any** Age Group or Senior Level Group (excluding Senior Prep). Families will have two options with regards to the fundraising requirement. Families may choose to either participate in the fundraising activities or choose to have your fundraising requirement added to your monthly bill. Your fundraising requirement for 2025-26 are:

- **\$175 - AG 1 Families (no other swimmers in AG2 or higher group)**
- **\$350 – AG2, AG3, SR1 & SR2 Families ****

Parents will be required to have their fundraising obligations paid in full by **June 30th, 2026**. Your account will be automatically billed on **July 1st** for any outstanding balance from each session. If you elect to withdraw from the team at any time prior to July 1st, you will have the choice to be billed for any outstanding balance of your fundraising obligation on your final invoice or be billed on July 1st so you can continue participating in fundraising activities.

If you choose to add your fundraising requirement to your monthly dues, the total amount due will be split into equal payments and added to your swimmers monthly dues. *(If you have multiple swimmers in the program, it will be added to your first swimmers monthly dues)*

****** If you join the swim team after January 1st or if you have 'extenuating circumstances', your fundraising requirement can be prorated.
