Additional Information

- The registration fee will be collected at time of registration for \$200 per swimmer. Registration fees will include a team suit, 3 t-shirts, 3 caps (2 latex, 1 silicone), and administrative fees.
- All swimmers are required to have a USA Swimming membership. Families will be responsible for registering and paying directly with USA Swimming for a Premium Athlete Membership.
- Monthly payment method options include cash, check, FTE or credit card and will be set up at the time of registration.
- All swimmers are REQUIRED to maintain a current membership at the Brooks Family YMCA.
- There is a 10% sibling discount on monthly program dues. Discounts are applied to the least expensive registration(s).
- Meet entry fees, lodging, transportation, and other meet costs are not included in program fees and are collected separately. Meet fees will be billed the Friday following the swim meet.

- Delinquent accounts more than 30 days past due could result in a suspension.
