FOR ALL PARENTS

The agreements you acknowledged during registration are now all housed in your TeamUnify/SportsEngine Account for reference and as a reminder of your obligations. If they are not marked as “Signed” you will need to click on each one in turn, (re)read it, and electronically sign it. To do this, please follow these instructions:


First, log into your TeamUnify/SportsEngine account. Here is the URL:

https://user.sportngin.com/users/sign_in

Then in the menu on the left, hover over “My Account” and click on “Account Info” in the menu that pops out to the right. That will take you to your account information page. If there is a red circle with an exclamation mark on the Agreements tab that means you need to electronically sign them. If you do not have the red circle, please click on that tab and view what is housed there. Our Swimmer Contract is the longest agreement we have and I suspect most of you simply skimmed it when you registered your swimmer. Now you have time to read it more carefully.

FOR NEW PARENTS

USA Swimming Registration is required of all TIDE athletes. We offer two different categories of membership:

FLEX

- only for Novice swimmers
- \$40 annual fee
- Membership only allows swimmer to participate in TWO non-championship level swim meets
- If swimmer will be swimming more than 2 meets it is best to select the PREMIUM membership

PREMIUM

- For all swimmers
- \$88 annual fee
- Membership allows swimmer so participate in UNLIMITED swim meets, including championship level competitions
