The above is the most up-to-date information about revenues. It is predicting forward for June and July with respect to monthly swimmers. It is also estimating with respect to summer travel fees and WSU/alumni swimmers.

In terms of our projected costs, we have a number of summer expenses – Orchards Pool, Reaney Pool, Taxes, Salaries, Travel – plus existing costs (recent expenditures include those associated with Swim-a-thon). While there are some unknowns and of course unexpected costs (for example, the original budget did not account for summer pools, various tax obligations, late fees resulting from past errors with taxes; need to hire multiple accountants), right now our projected costs are about 121,000. This has a good number of contingencies and leaves room in certain areas. Our hope is to have at least 5000 in reserves at the end of the year, and hopefully more.
