**DATE:** Saturday, December 6<sup>th</sup> & Sunday, December 7<sup>th</sup>, 2025

**LOCATION:** Sauk Prairie High School 25-yard Indoor Pool, 105 9th St, Prairie Du Sac, WI 53578

**FACILITY:** 8-lane, 25-yard pool with a starting depth of 12.5 feet and a turn depth of 4 feet. It has

regulation-height starting blocks (30") and ample viewing area for athletes and spectators. The

meet host will ensure the required course dimensions.

**CLASSIFICATION:** Closed Invitational, Mixed Gender Events.

**RULES:** Held under the sanction of USA Swimming. This meet will be conducted under USA Swimming

2025 and Wisconsin Swimming Rules. Swimmers age as of 12/06/25 will be their age for competition. This is a sanctioned meet, so all participants must be USA Swimming registered.

Deck changes are prohibited.

(13-over & Open events) **Meet Start** 9:05am

Sunday 500 SESSION 5 **Warm-ups** Starting at completion of Sunday AM

(Open 500 Free) session, lasting appx 20 minutes

**Meet Start** 5 minutes after completion of warm-ups

**WARM-UPS:** BAC reserves the right to assign warm up times and lanes.

Circle swimming only, except in designated lanes and times. All entry to pools during open warm-

up cool down periods shall be feet first three-point entry. No snorkels, kickboards or other

training devices are allowed during warm-ups.

Teams should plan to do starts, sprint and pace work within their assigned warm-up

time. Swimmer(s) without a coach present are to report to the Meet Director prior to warm-ups

for lane assignment

**ENTRIES:** Swimmers may compete in **3 (THREE)** individual events per day, not counting the 500 Free. So

swimmers can do a maximum of **7 (SEVEN)** individual events total. This meet will be run using



Hy-Tek Meet Manager. All teams are encouraged to submit entries on disk or by e-mail in the Hy-Tek commlink format. Swimmers competing without a Team representative should contact Jacob Johnson, either by phone 608-852-5727, or by e-mail to <a href="mailto:coachjacob@badgeraquatics.com">coachjacob@badgeraquatics.com</a> about entry into the meet. You can download a meet setup file (zipped) from the WI web site. For swimmers entering without a commlink file a \$5.00 per swimmer charge will be accessed for hand entering.

**ENTRY PERIOD:** 

The meet entry will open at noon on WEDNESDAY, NOVEMBER 19<sup>TH</sup> and will close at noon on **TUESDAY, NOVEMBER 25<sup>TH</sup>**. Teams will receive an e-mail confirmation of your entry within 24 hours of the close deadline. Please look over and confirm it matches your entry. If you have not received that confirmation, please text or call Jacob Johnson at 608-852-5727.

Efforts will be made to accommodate every interested team, especially 'returning' teams, but if the interest level exceeds the meet capacity, we will also utilize 'first come, first served'.

**ENTRY FEES:**

\$6.00 per individual event, no relay events \$11.00 per swimmer athlete surcharge

**TIMING SYSTEM:** 

All events will be timed using Daktronics with horn start, touch pads, two buttons, and a minimum of one watch as backup. 25-yard races may be timed with two buttons and minimum of one watch as backup.

DISABILITY SWIMMERS:

Please indicate on the entries form any special needs for those athletes requiring assistance. Athletes that are requesting an accommodation and/or modification, shall present the <u>WSI Para Accommodation Form</u> to the meet referee and/or meet director prior to the meet start.

RACING START CERTIFICATION:

Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water without the use of the backstroke ledge. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

**AWARDS:** Awards for  $1^{st} - 8^{th}$  place for all Individual Events

8-under and 10-under awards can be claimed at the meet OR will be 'bagged' for coaches

11-12, 13-over, and Open awards MUST be claimed at the meet

**SEEDING:** All events will be pre-seeded and swimmers are responsible for being at the blocks and ready to

swim.



**DECK SEEDING**: Coaches may deck-seed swimmers to the limit of filling heats each session and at the discretion

of meet management. There will be a surcharge of \$4.00 plus entry fees = (\$10.00) for anyone wishing to be deck seeded. All swimmers must currently be registered with USA Swimming. Entries will not be allowed to exceed meet entry limits and all deck entries must be completed 30 minutes prior to the start of the session. Decision to grant entry is up to the meet director. NO

DECK ENTRIES WILL BE DONE AFTER THE DEADLINE.

**MEET CONDUCT:** ATHLETE & PARENT CONDUCT, please follow the athlete and parent conduct guidelines below. Anyone not following these rules may be subject to removal from the meet and facility. Each

team is responsible for the conduct of its swimmers and parents.

• Teams are asked to pick up any garbage in their immediate team area after each session.

Only counters and officials are allowed at the pool edge during competition.

• No coolers, chairs, blankets or large bags will be allowed in the main pool spectator area.

• Swimmers (and their bags) should sit either in their team's area on the pool deck or in the off-deck team area, not in the spectator stands

Deck changes are prohibited

• Use of audio or visual recording devices, including cell phones, is not permitted in changing areas, restrooms or locker rooms. Changing into or out of swimsuits other than in locker rooms or other designated areas is prohibited.

 Flash photography and photography from behind the starting blocks are prohibited at the start of each race. Only designated photographers will be allowed on deck during the warmups and meet.

• Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present. Exceptions may be granted with prior written approval by the Vice President of Program Operations

**MAAPP POLICY:** 

All adults participating in or associated with this meet acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with MAAPP is a condition of participation in the conduct of this competition. Times achieved by an athlete member at a sanctioned/approved meet who is over 18 years of age who had not completed the Athlete Protection Training (or whose APT training had expired) by the date of the swim, will not be able to be uploaded to SWIMS. This includes participation as a member of a relay. These athletes will also be considered "not in good standing" and can be subject to fines under Wisconsin Swimming Policy 11.2.1.

**ADMISSIONS:** FREE ADMISSION for all spectators.

Programs will be available for FREE on Meet Mobile, and the Meet Landing page for viewing

electronically, or pre-printing

**LIVE STREAM:** There will NOT be a Livestream for this meet.

**FINAL RESULTS:** Teams that submitted entries via e-mail will receive a MM back up and TM file sent to the

provided e-mail contact/address that they have provided on the waiver form. Complete meet



results in pdf format plus MM back up will be sent to be posted on the WI web after the

conclusion of the weekend.
