FACILITY: 8-lane, 25-yard pool with a starting depth of 4½-5 feet and a turn depth of 4 feet. It has regulation-height starting blocks (30") and ample viewing area for athletes and spectators. The Meet host will ensure the required course dimensions.

Saturday Open: Warm-ups 10:40am, meet start 11:45am
Sunday AM: Warm-ups 7:45am, meet start 8:45 am
Sunday Mid: Warm-ups starting at conclusion of AM session and lasting min of 45 minutes.
Sunday PM: Warm-ups starting at conclusion of Mid session and lasting min of 45 minutes
Updated timelines will be posted at www.badgeraquatics.com once all entries are in.

WARM-UPS: BAC reserves the right to assign warm up times and lanes.
Swimmer(s) without a coach present are to report to the Meet Director prior to warm-ups for lane assignments. Teams should plan to do starts, sprint and pace work within their assigned warm-up time, if assigned.
Feet first three-point entries from the starting end of the pool during general warm-ups will be enforced for all sanctioned/approved competition in accordance with the recent change to Wisconsin Policy 4.5.2(a).

No equipment, pull buoys, kick boards, or paddles used during warm-ups.

ENTRIES: Swimmers may compete in a maximum of 3 individual events on Saturday, and 3 individual events on Sunday, as well as one relay event on Sunday. Entries for Saturday may be limited to a maximum of 600 swims, and entries for Sunday may be limited to a maximum of 1600 swims. This meet will be run using Hy-Tek Meet Manager. All teams are encouraged to submit entries via e-mail. Swimmers competing without a Team representative should contact Jacob Johnson by e-mail at coachjacob@badgeraquatics.com about entry into the meet. You can download a meet event file (zipped) from the WI LSC or BAC web site.

DECK ENTRIES: Deck entries may be accepted if there are any open lanes for the event at a fee of \$10.00 per race. All deck entries MUST be requested no later than 30 minutes before the start of the session. Switching out of one event to another will not be allowed. No on-site USA registrations will be accepted.

ENTRY PERIOD: Entries are due by 10am on Monday, October 6th. Please include a pdf of your entry with your e-mail. You will receive an e-mail confirmation of your entry within 24 hours. Please look over and confirm it matches your entry. If you have not received that confirmation by Tuesday 10/07 at 10am, please call Jacob Johnson at 608-852-5727. Waiver and fees must be received by the start of the meet.

E-mail entries to: coachjacob@badgeraquatics.com. Coaches can bring the waiver and check to the meet, no need to mail beforehand.

ENTRY FEES: \$4.00 LSC splash fee per swimmer, \$6.00 per individual event. \$12.00 per relays. \$11.00 Athlete Surcharge in lieu of cost for admissions or heat sheets.
For swimmers entering without a commlink file a \$5.00 per swimmer charge will be accessed for hand entering.

TIMING SYSTEM: All events will be timed using Daktronics with horn start, touch pads, one or two buttons, and a minimum of one watch as backup. 25-yard races may be timed with buttons or with watches as a back-up.

RACING STARTS: **(USAS 202.4.11 D)** Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water without the use of the backstroke ledge. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement

AWARDS: All age groups will receive 1st through 8th place ribbons for both individual and relay events. Special Heat winner awards will be awarded for all events. No awards will be mailed or kept after the meet.

Swimmers will be responsible for picking up their awards at the awards table.

DISABILITY SWIMMERS: Please indicate on the entries form any special needs for those athletes requiring assistance. Para athletes that are requesting an accommodation and/or modification, shall present the [WSI Para Accommodation Form](#) to the meet referee and/or meet director prior to the meet start.

RULES: Held under the sanction of USA Swimming. This meet will be conducted under USA Swimming 2025 and Wisconsin Swimming Rules. Swimmers age as of 10/11/25 will be their age for competition. This is a sanctioned meet, so all participants must be USA Swimming registered.

MEET CONDUCT: ATHLETE & PARENT CONDUCT, please follow the athlete and parent conduct guidelines below. Anyone not following these rules may be subject to removal from the meet and the facility. Each team is responsible for the conduct of its swimmers and parents.

- Teams are asked to pick up any garbage in their immediate team area after each session.
- Only counters and officials are allowed at the pool edge during competition.
- No coolers, chairs, blankets or large bags will be allowed in the main pool spectator area.
- Swimmers (and their bags) should sit either in their team's area on the pool deck or in the off-deck team area, not in the spectator stands

- No deck changing allowed.
- Use of audio or visual recording devices, including cell phones, is not permitted in changing areas, restrooms or locker rooms. Changing into or out of swimsuits other than in locker rooms or other designated areas is prohibited.
- Flash photography and photography from behind the starting blocks are prohibited at the start of each race. Only designated photographers will be allowed on deck during the warmups and meet.
- Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present. Exceptions may be granted with prior written approval by the Vice President of Program Operations

MAAPP POLICY:

All adults participating in or associated with this meet acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with MAAPP is a condition of participation in the conduct of this competition. Times achieved by an athlete member at a sanctioned/approved meet who is over 18 years of age who had not completed the Athlete Protection Training (or whose APT training had expired) by the date of the swim, will not be able to be uploaded to SWIMS. This includes participation as a member of a relay. These athletes will also be considered "not in good standing" and can be subject to fines under Wisconsin Swimming Policy 11.2.1.

ADMISSIONS:

No admission charge for spectators. Programs will be available for free on Meet Mobile and on the Meet Landing Page

LIVE STREAM:

There will be no Livestream available for this meet.

FINAL RESULTS:

Teams that submitted entries via e-mail will receive a MM back up and TM file sent to the e-mail contact/address that submitted the entry, or what was provided on the waiver form. Complete meet results in pdf format plus MM back up and TM files will be sent to be posted on the WI web after the conclusion of the weekend.

CONCESSIONS:
