Meet Date:	Saturday, June 28, 2025
Location:	DeForest Area High School, 815 Jefferson St., DeForest, WI 53532
Facility:	Indoor 25 yard pool with eight 7' lanes, non-turbulent lane markers, backstroke flags, 29 ½" Keifer starting blocks, gutter pool. Pool depth is 12'6" at the starting block end and 3 ½" at the opposite end. The meet host will ensure the required course dimensions.
Timing:	All events will be timed using Colorado 6 Timing System with strobe/horn start, touch pads, one button, and 2 watches as backup, with the exception of all 25-yard races, which will be timed with 2 electronic watches and minimum of one button. All events will be timed finals.
Official Rules:	This meet is sanctioned by USA Swimming and Wisconsin Swimming, Inc. All USA Swimming and WSI rules apply including safety rules, which will be strictly enforced.
Eligibility	Coaches and Club officials desiring to be on deck will be required to display proof of current USA Swimming membership at all times. All swimmers must hold current 2025 USA Swimming registration.
Racing Start Certification	Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water without the use of the backstroke ledge. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.
Medical Supervision:	Certified lifeguards will be present to provide medical supervision to athletes during the meet.
Entries:	Completed entry forms, signed waiver, and fees must be received by Saturday, June 14, 2025. Preferred method of entry is by email in HY-TEK COMMLINK format. You can download meet setup file (zipped) from the WI website. Current USA Swimming ID number MUST be included on the entry form. All deck entries must be able to prove USA Swimming membership. Out of state swimmers must show their current USA Swimming card prior to swimming.

Entry Limit:	Only the first 300 swimmers, or until the timeline is full, will be accepted. Meet management does reserve the right to limit heats if for some reason there are time issues. Entries not accepted will be notified by email as soon as possible. Swimmers are limited to four (4) individual events plus one (1) relay for the meet.
Entry Fee:	Individual events: \$6.00 Relays: \$16.00 Splash Fee: \$4.00 Admission Fee: \$10.00
Schedule:	Session 1: Warm-ups at 8:00 am. First event at 9:05am Session 2: Warm-ups not before 11:00 am, 1 hour warmup session.
Warm ups:	Warm ups will be assigned. Feet first three point entries from the starting end of the pool during general warmups will be enforced for all sanctioned/approved competition. No equipment or other training devices are allowed during warm-ups. Swimmer(s) without a coach present are to report to the Meet Director prior to warm-ups for lane. Warm up procedures are at the discretion of the teams warming up in each specific lane. Meet Marshals will be on deck during the entire warmup with the authority to recommend disqualification from individual events. Warm up schedule and lane assignments will be shared during the week prior to the meet.
Age Groups:	8&U, 9-10, 11-12, 13-14, 15&O (age as of 6/28/25)
Seeding:	This is a pre-seeded meet. It is the swimmer's responsibility to be at the blocks at the start of their event(s). Staging assistance will be provided for 8&U individual events. 500 Freestyle and 1000 Freestyle events will be seeded fast-to-slow. All other events will be seeded slow-to-fast
Deck Seeding:	Deck seeding will be allowed only to the limit of filling partially filled heats. Deck seeding will close at 8:30 for the AM session and 30 minutes before the other session starts. All competitors must be registered athlete members of USA Swimming and Wisconsin Swimming, Inc.
Awards:	Awards for relay events will consist of ribbons for 1st- 8th place. Awards for individual events will consist of medals for 1st-3th place and ribbons for 4th-16th place for the following age groups: 8&U, 9-10, 11-12, 13-14 for both female and males. 15&O will not receive awards Heat winners for all ages will receive a reward. Group distribution of awards to coaches will be permitted and/or mailed.
Final Results:	One copy of the meet's final results will be sent to each team's designated recipient. Results will also be posted on both the DFAC and Wisconsin Swimming websites.

MAAPP Policy:	All applicable adults participating in or associated with this meet acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with MAAPP is a condition of participation in the conduct of this competition. Times achieved by an athlete member at a sanctioned meet who is over 18 years of age who had not completed the Athlete Protection Training (or whose APT training had expired) by the date of the swim, will not be able to be uploaded to SWIMS. These athletes will also be considered "not in good standing" and can be subject to fines under Wisconsin Swimming Policy 11.2.1
Admission:	Admission fee of \$10 per athlete, included in entry fees. Heat sheets will be available online before the meet.
Concessions:	A selection of food will be available at reasonable prices throughout the meet.
Meet Conduct:	• Use of audio or visual recording devices, including cell phones, is not permitted in the changing areas, restrooms, or locker rooms. • Changing into or out of swimsuits other than in locker rooms or other designated areas is not appropriate and is prohibited. Deck changes are prohibited. • Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open-ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present • All coaches are responsible for the conduct of their swimmers and will see that their club has proper supervision at all times. Meet Marshals have the authority to remove any swimmer and/or spectator from the meet for any violation such as improper behavior, damage to property, etc. No smoking on the premises. Please encourage your swimmers to clean up after themselves.
Image Authorization	All participants agree to be filmed and photographed by the official photographer(s) and network(s) of Wisconsin Swimming and the meet host under the conditions authored by Wisconsin and USA Swimming, and allow event organizers the right to use names, pictures, likenesses, and biographical information before, during or after the period of participation in this Wisconsin Swimming competition to promote such competition
