MEET FORMAT, WARM UP PROCEDURES, AND SCHEDULE	AM Session: 10 & Under Warmups: 8:00-9:00 AM Circle swimming only, except in designated lanes and times. All entry to pools during open warm-up cool down periods shall be feet first entry from the start end. No snorkels, kickboards or other training devices are allowed during warm-ups. Teams should plan to do starts, sprint and pace work within their assigned warm-up time. Meet start: 9:05 AM PM Session: 11 -14 & Open Warmups: The afternoon warm-ups will start as soon as the morning session has been completed with the afternoon session starting no earlier than 11:00 AM. Warm-up procedure will be repeated for the afternoon session. Start time: The afternoon session will start 65 minutes after the conclusion of the AM session. Swimmer(s) without a coach present are to report to the Meet Director prior to warm-ups for lane assignment.
POOL INFORMATION	Eight lane, 25 yard pool. Pool depth is 9 feet at the start end and 4 feet at the turn end. Blocks are 30 inches high. Pool features non-turbulent lane markers and backstroke flags. The pool utilizes Colorado blocks

	with individual start horns. The meet host will ensure the required course dimensions.

Entering the Meet

ELIGIBILITY	All athletes must be current registered members of USA swimming. First date of the meet will determine the age of competition
ENTRIES	Completed entry file must be received by the entry chair no later than the deadline date. Please submit electronic entries via email. This meet is being run by HyTeck swim software.
ENTRY DEADLINE	June 5, 2025
ENTRY LIMITS	Swimmers may compete in four (4) individual events plus two (2) relays.
ENTRY FEES	Individual events: \$5.00 per event Relay team: \$12 per relay Splash Fee: \$4.00 per swimmer entered in at least one individual event. Admission Fee: \$10 per swimmer; no admission charged at the door Please make checks payable to FAST. Entry fees must accompany the official waiver on the day of the meet, and are not refundable.
On Deck Registration	No on deck registrations will be accepted.
Deck Entries	No deck entries will be accepted.

COACHES	All coaches must pick up their coach's packet in person, must show their coach's card, <u>and must sign in for each session</u> . If a coach does not present a USA Swimming registration card, they will not be allowed on deck and the swimmers for the team will be assigned to a USA Swimming certified coach for warm-ups. The official mobile application of USA Swimming is acceptable proof of USA Swimming membership.
FINAL RESULTS	Results will be posted on www.wisconsinswimming.org and e-mailed to participating team coaches.
MEDICAL SUPERVISION	Please indicate any special needs your swimmers may have on the entry form. We will do everything possible to accommodate them. This should include any existing conditions that may require meet management to activate the emergency response plan. Building personnel and Lifeguards are trained in procedures required by Blood Borne Pathogens laws and will be responsible for any cleanup required. Lifeguards & high school trainer's room available to athletes participating in the meet.

ADMISSIONS	Admissions included in meet entry fees
HEAT SHEETS	Heat sheets will be sent to coaches electronically and posted on the meet landing page the night before the meet.
AWARDS	Ribbons for individual events places 1-12, open events 1-12, and relay events places 1-3; Plaques will be awarded to the top three teams based on points. Top 12 finishers will be awarded points as follows - 12-11-10-9-8-7-6-5-4-3-2-1. Ribbons will be mailed out after the meet.
CONCESSIONS	Concessions will be available
RAFFLE	Chuck-A-Duck will take place once in the morning session and once in the afternoon session with a cash prize for the winner.

Rules, Regulations, & WI Swimming Information

STATEMENT OF RULES:	This meet is sanctioned by USA Swimming and Wisconsin Swimming, Inc. All USA Swimming and WSI rules apply including safety rules, which will be strictly enforced.
MAAPP	All adults participating in or associated with this meet acknowledge that they are subject to the provisions of the

	USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with MAAPP is a condition of participation in the conduct of this competition. Times achieved by an athlete member at a sanctioned/approved meet who is over 18 years of age who had not completed the Athlete Protection Training (or whose APT training had expired) by the date of the swim, will not be able to be uploaded to SWIMS. This includes participation as a member of a relay. These athletes will also be considered "not in good standing" and can be subject to fines under Wisconsin Swimming Policy 11.2.1
RACING START CERTIFICATION:	Any swimmer entered in the meet, must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.
REQUIRED CONDUCT LANGUAGE:	All coaches are responsible for the conduct of their swimmers and will see that their club has proper supervision at all times. Meet Marshals have the authority to remove any swimmer and/or spectator from the meet for any violation such as improper behavior, damage to property, etc. No smoking on the premises. Please encourage your parents and swimmers to clean up after themselves. Use of audio or visual recording devices, including cell phones, is not permitted in the changing areas, restrooms, or locker rooms. No photography allowed behind the starting blocks. Changing into or out of swimsuits other than in locker rooms or other designated areas is not appropriate and is prohibited. Deck changes are prohibited. Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.
IMAGE AUTHORIZATION:	All participants agree to be filmed and photographed by the official photographer(s) and network(s) of Wisconsin Swimming and the meet host under the conditions authored by Wisconsin and USA Swimming, and allow event organizers the right to use names, pictures, likenesses, and biographical information before, during or after the period of participation in this Wisconsin Swimming competition to promote such competitions.
