GENERAL MEET INFORMATION

General Meeting	The General Meeting will be held virtually on Thursday, February 27th at 8pm via Zoom. It will be recorded and posted on the host's website and/or emailed to all teams. Additional coaches' meetings may be held as determined by the Meet Referee. It is the responsibility and obligation of each team or unattached swimmer to be represented at all coaches' meetings. Coaches or other team representatives are responsible for all information presented at these meetings including changes to the meet format or conduct. Coaches should check their team mailboxes prior to each session where they pick up heat sheets (admin table).
Officials Meeting	An Officials Meeting will be held one hour before the starting time for each session in the hospitality room. Anyone wishing to officiate at this meet should sign up on the Meet Landing Page or contact the Team Lead CJ. Officials must have valid USA Swimming registration and must be working that session to be on deck. The official mobile application of USA Swimming is acceptable proof of USA Swimming Membership. Timers Briefings will be held 30 minutes before the start of each session.
Facility	Indoor facility with two 25-yard pools. The 'competition pool' is an 8 lane, 25-yard pool with 30" blocks, a starting end depth of 7' and a turn-end depth of 3.5'. The 'warm-up' pool is also 8 lanes and 25 yards. Host will ensure the required course dimensions.

Timing System	A fully automatic Colorado 6 timing system with touchpads will be the primary timing for all races other than 25y races. There will be 1-2 manual backup buttons and two backup stopwatches for each lane will be used. 25s will be run through the Colorado Timing System with no touchpads, but with 2 buttons serving as the primary timing, and two stopwatches serving as the backup.				
First Aid/Medical	All injuries should be reported to the lifeguard on duty. Lifeguard staff has basic first aid supplies available if needed. An AED is available on the pool deck and lifeguards can activate EMS if needed.				
Deck Access	Deck access is restricted to participating athletes, coaches, working officials and meet personnel. Credentials will be issued and must be displayed at all times while on deck. This will be strictly enforced by Meet Marshals and other Meet staff. Coaches and Officials must produce proof of USA Swimming membership immediately upon request by the Meet Referee or his/her delegate or leave the pool deck. The official mobile application of USA Swimming is acceptable proof of membership. Coaches may pick up meet packets at the admin table and must sign in at the start of each session.				
Spectators & Spectator Admission	Admission for the meet is included in the entry fee for each athlete. All spectator seating is upstairs on the mezzanine level. There will be designated seating for disabled and elderly spectators. In addition to the mezzanine, there will be room for spectators and athletes in the 'commons' just down the hall from the pool The meet will be live-streamed over the BAC YouTube channel. Links will be posted on the meet landing page. The meet will also be streamed on TVs in the commons area.				
Lost and Found	The lost and found area is located at the entrance to the 'athlete only' hallway by the locker rooms, between the pool deck and the commons area				
Concessions	Concessions will be available upstairs on the mezzanine level.				
Parking	Parking is available for FREE in the Verona Area High School Parking lot. A map will be posted to the Meet Landing Page. Please do NOT park in the lot labeled as 'pool parking' - this is reserved for pool staff and meet personnel.

	Scheduled breaks are indicated on event order below. Additional breaks may be scheduled as needed and will be determined by meet management before the start of the meet. Meet management would determine the duration of each break. Depending on duration, the competition pool may or may not be open for warm-ups during these breaks. All added breaks will be posted to the session report and communicated to lead coaches.

RULES and PROCEDURES

Meet Rules	Official current USA Swimming and Wisconsin LSC rules shall prevail for this meet except as otherwise specified in this meet information. Participating athletes must be registered USA Swimming athletes and in good standing. The athlete's age on the first day of the meet determines the age group for the entire competition. No deck registrations will be accepted at this meet. All coaches and officials are required to sign in and prove that their USA Swimming membership is in good standing and all certifications are current. The official mobile application of USA Swimming should be used for proof of USA Swimming membership. All USA Swimming athletes must be under the supervision of a USA Swimming member coach during warm-up, competition, and warm-down. The Meet Director or Meet Referee may assist an unaccompanied swimmer make arrangements for such supervision, but it is the swimmer's responsibility to make such arrangements prior to the start of the meet.
Para/Disability Swimming	Please note any special requirements and/or requests for a swimmer with disability with your meet entry. All requests for swimmers with disabilities must be received before the start of the meet and presented to the meet referee. Para athletes or their representative coach will be expected to provide a written document of the desired accommodations (physical needs maneuvering throughout the venue) and modifications (technical rule changes while swimming) to the meet referee upon arrival. Failure to provide documentation will grant the meet referee complete discretion towards disqualifications, with no protest. Use of the WSI Para Accommodation Form is encouraged for all accommodation and/or modification requests
Start Certification	Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water without the use of the backstroke ledge. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.
Meet Format	This meet will be conducted in short course yards using eight lanes; it is a 2-day competition. All events are pre-seeded timed finals, swam slow to fast, except as noted elsewhere in the Meet Information. All swimmers must report to the blocks for the start of their heat. Fly-over starts will be used. Deck entries for individual events will not be accepted. Relay-only swimmers may be deck-entered no later than 30 minutes before the start of each session. The coach must give the information to the Meet Director and pay the appropriate fee(s).
Warm Up Procedures	Warm-up times and lanes will be assigned. Assignments will be posted on the meet landing page and communicated to all teams using the email address that submitted the entry. Assigned time blocks will be a minimum of 20 minutes of warm-ups with a 15-minute controlled warm-up for starts/pace for all athletes at the end of the warm-up session.

	USA Swimming and Wisconsin Swimming warm-up procedures will be enforced throughout the meet. Circle swimming only, feet first three-point entry from the starting end of the pool. No equipment or other training devices are allowed during warm-ups. Swimmer(s) without a coach present are to report to the Meet Director prior to the warm-up session start time for lane assignment. Additional in-water breaks may be determined once all entries have been received and timeline has been set. Violators of the warm up procedures are subject to disqualification. There will be warm-up/warm-down lanes available in the warm-up pool - as well as additional seating and awards staging - throughout the meet.
MAAPP	All adults participating in or associated with this meet acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with MAAPP is a condition of participation in the conduct of this competition. Times achieved by an athlete member at a sanctioned/approved meet who is over 18 years of age who had not completed the Athlete Protection Training (or whose APT training had expired) by the date of the swim, will not be able to be uploaded to SWIMS. This includes participation as a member of a relay. These athletes will also be considered "not in good standing" and can be subject to fines under Wisconsin Swimming Policy 11.2.1.
Conduct	Coaches are responsible for the conduct of their swimmers and will see that their club has proper supervision at all times. Meet Marshals have the authority to remove any swimmer and/or spectator from the meet for any violation such as improper behavior, damage to property, etc. No smoking on the premises. • Each team is responsible for the conduct of its swimmers and parents. • Teams are asked to pick up any garbage in their immediate team area after each session. • No coolers, chairs, blankets, or large bags will be allowed in the mezzanine spectator area - there is room for all of that in the commons area. • Use of audio or visual recording devices, including cell phones, is not permitted in changing areas, restrooms, locker rooms or behind the blocks. • Changing into or out of swimsuits other than in locker rooms or other designated areas is not appropriate and is prohibited. Deck Changing is prohibited. • Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas, and open ceiling locker rooms) any time athletes, coaches, officials, and/or spectators are present. • No underwater video recording equipment is allowed at any time during the meet. • Flash photography will not be allowed during the start of any heat. Individuals using flash photography near the start of a heat may be ejected from the meet facility. • Per USAS SafeSport, swimmers should not be filmed or photographed from behind the blocks while in a starting position. • Parents/guardians are NOT allowed on deck at any time, except when serving as counters for distance events, or as timers. • No glass containers of any kind are allowed on deck or in locker room areas. • Locker Rooms on the pool deck will be designated ATHLETE only. Use by coaches, officials, and volunteers is strictly forbidden. All participants agree to be filmed and photographed by the official photographer(s) and network(s) of Wisconsin Swimming and the meet host under the conditions authored by Wisconsin and USA Swimming and allow event organizers the right to use names, pictures, likenesses, and biographical information before, during or after the period of participation in

	this Wisconsin Swimming competition to promote such competitions. To withhold consent, please contact the host team or Meet Director for the proper forms.
Protests	For consideration of administrative protests lodged at the meet, the Meet Referee may appoint a meet committee consisting of not fewer than three (3) and not more than five (5) persons, at least one of whom shall be a coach and one an athlete, prior to the start of competition. Protests against judgment decisions can only be considered by the Referee and the Referee's decision is final.

ENTRY INTO THE MEET

Eligibility	All swimmers must be registered athlete members of USA Swimming and Wisconsin Swimming, and be in good standing. The athlete's age will be determined as of the first day of the meet. All individual swimmers entered in the meet shall be eligible to swim in the meet, having at least one verifiable qualifying time. Swimmers who cannot verify qualification for the meet with a proof of time will be withdrawn from the meet. Any swimmer who swims in the meet and is found ineligible will be disqualified from the meet, forfeit all awards and points achieved and their club fined \$200. There will be no deck entries or registration. The representative submitting entries shall be responsible for verifying that all swimmers satisfy these requirements. Swimmers must meet the 2025 Wisconsin 10-Under State Championships Time Standards.
Qualifying and Seed Times	QUALIFYING TIMES MUST BE ACHIEVED AFTER SEPTEMBER 1, 2023. Qualifying time standards are listed on the meet landing page as well as the Wisconsin Swimming website. Qualifying times will be accepted in Short Course Yards, Long Course Meters, or Short Course Meters. Non-conforming times will be seeded after SCY times. The order used for seeding will be SCY-SCM-LCM Bonus entries will be seeded after qualified swims in the same order. QUALIFYING TIME STANDARDS CAN BE FOUND ON THE WI LSC WEBSITE
Para/Disability Athletes	Para swimmer athletes can enter any event (up to the limit of the meet information) but they must have achieved a Wisconsin Swimming State Time Standard OR the Disability Para Motivational Championship Time Standards (P1, P2, P3). Both sets of time standards can be found on Wisconsin Swimming's website. Although swimmers with disabilities can enter any event(s), the only events that will be scored and awarded in Para categories are noted on the event page. All 25s of stroke will be offered for 8&Under athletes (please note that 8&Under athletes must qualify at the 50 of stroke time standard (P1, P2, P3) but still enter at their 25 time). When entering an athlete with a disability to the designated Disability events or any other events, email the Entry Chair so they can be verified and seeded properly. If coaches have any questions regarding Disability inclusion at the State Championship, please email Wisconsin Swimming's Disability Chair (Tom Miazga - tommiazga8@gmail.com) Meet Management may combine entries based on gender and/or age groups.
Age Groups	The meet shall consist of two age groups: 8&U and 10&U NOTE: 8&U athletes swimming in 10&U individual events - points earned do not count toward 8&U totals for highpoint awards.
Entry Limit	A swimmer may compete in not more than 6 individual events total for the meet.

	A swimmer may compete in no more than 5 individual events per day, plus 1 relay per day. Athletes 8 & Under are allowed to compete in 10 & Under relays but can only swim one (1) relay per day								
Bonus Events	Any swimmer who has entered with one qualifying time may enter three bonus events for which they do not have a qualifying time. Any swimmer entered with two qualifying times may enter two bonus events and any swimmer entered with three qualifying times may enter one bonus event. Any swimmer with four or more entered qualifying times is not eligible for bonus events. A swimmer must be qualified, by time and age restrictions, in an age group to earn a bonus swim in that age group. There are no bonus entries for swimmers that are “relay only” entrants in the meet. ENTRIES MUST INCLUDE A PDF COPY OF ENTRIES INDICATING ALL BONUS EVENTS.								
Relay Events	A Relays must consist of at least one (1) individual qualifier in that age group & gender. B Relays – eight (8) Qualifiers in that age group and gender. C Relays – twelve (12) Qualifiers in that age group and gender. The other members of a team’s only relay entry in each age group/gender may be relay-only swimmers. Relays that are not a team’s only relay for an age group & gender must be composed entirely of swimmers who are individually qualified for the meet. Relay-only swimmers must be included in your entry. To add a relay-only swimmer after the entry deadline, the swimmer must be entered in the meet 30 minutes prior to the start of the session in which they will swim. If a swimmer who is entered as an eligible swimmer is found to be ineligible for the meet, that swimmer may not be part of a relay as a relay-only swimmer and does not count as a qualified swimmer for a relay.

Entry Procedure	ENTRY DEADLINE: Entries must be e-mailed to coachjacob@badgeraquatics.com by 6:00 PM CST on Monday, February 24th, 2025 • When emailing entries, please include contact information including the name of the person submitting the entries, the name of the club and phone number in case of questions or problems with the entries. • You will receive a confirmation e-mail. If you have not received your confirmation by noon on Tuesday, February 25th, 2025, contact the entry chair immediately. • Any entries received after the entry deadline are potentially subject to a \$150 late fee. Entries submitted after Tuesday, February 25th at 6:00 PM will not be accepted. Teams are allowed to send in an updated entry by noon on Wednesday, February 26th, 2025 • Any non-electronic entry (Team Manager or Team Unify) is subject to a \$20 per athlete fee. • When entering a para-athlete into the meet, please be sure to include any needed documentation used to determine P1, P2, or P3 designated disability placement. • When entering an athlete who has qualified with a first-place finish in a qualifying event at the Regional Meet, use an override time to enter the athlete at the standard. Email the Entry Chair the correct times, so they can be verified and seeded properly. A psych sheet will be posted by 12:00 PM on Wednesday, February 26th, 2025. Only changes for errors by the Entry Chair or Assigned Admin Team are allowed after the Psych sheet is posted.								

Payment	A non-refundable check for entry fees and surcharges must be received before the start of the meet. All payments will be made via check, no credit cards will be accepted. Proof of Time	All entry times will be verified against the SWIMS database, if you use override (custom) times, you must provide all proof of times by Wednesday, February 26th, 2025, at 3:00 PM. After that point, all “unproven” times may be scratched from the meet. Entry times requiring proof will be posted on Tuesday, February 25th Submit printed proof of time on PDF with time highlighted or otherwise designated. Refer to Wisconsin Swimming Proof of Time Policy (2.7.4), page 13 for details and any applicable fines for failure to provide documentation of Proof of Time.
