- Volunteer update
 - 51 parents
 - 6 family members/others
 - 5 swimmers
 - 3 parent officials
 - 8 swimmers did not have parents volunteer = 7 families
 - 65 TOTAL EXCEEDS NUMBER OF SWIMMERS!
- Can't continue to not have teams come to our meets, overlaps of schedules. Likely to get more swimmers if a USA approved event - 25% cut but would charge a splash fee to help cover this. Need to get Titletown on the USA Swim calendar for next year.
 - MUST APPLY BY MARCH FOR NEXT JANUARY.
 KAYLA NEEDS TO WORK ON THIS ASAP. SHE WILL
 REVIEW THE PROCESS THIS WEEK AND WILL
 CONTACT STEVE OR BRIAN IF HELP IS NEEDED.
 - Kayla isn't getting much feedback from coaches about a shared meet calendar.
 - Need to nurture our current relationships and remedy the issue with the few other teams that don't consistently attend our meets. Kayla isn't sure how much more she can do to change this. She will be meeting with Dave for some guidance soon. The approach so far hasn't been effective in making change. The solution may be to change the whole approach and decide how to do that after the Last Chance. Discussed having Dave step into the role to communicate with the coaches he knows to resolve this.
- Last Chance: March 8, 2025 (2nd Saturday in March)
 - Same weekend as DCY meet now. Our events were sent out in September so not sure why DCY scheduled the same weekend as us. Kayla emailed Mike regarding this conflict but hasn't received a response yet. MTRY also contacted him about it. Our date has always been the second Saturday in March.
 - Nicole reviewed information and estimates GBY, MTRY, M&M, NLY, SCY, OSHY (?) - about 155 swimmers. Some teams have DCY on their calendar
 - All official positions filled. Will waive swim fees up to \$50. Can do a gift card for Elizabeth since she won't have a swimmer.
 - Same as 11-12 and 13-14 USA State
 - Coach Stephanie will take qualifiers this weekend if needed.
 - Nicole ready to post all the jobs, food needs, etc
 - Nicole will schedule for Friday night setup.
 - Chelsea talked about sharing info to draw more people. Ex. Titletown, hotel suggestions, restaurant suggestions.

	Jenn is finalizing this (for away meets) for new parent folders and just general info. She can maybe work on putting something together and then Kayla can put this out. A lot of other teams post their menus in meet info. Jenn suggested we do this to show what we really have to offer. Tressa proposes adding an Officials Sub-Committee Dan Hatch is willing to lead this. Marc Schinker and Josh Gouin can be members of this sub-committee along with any other team officials.
