Class of Meet: Prelims/Finals for 9-10, 11-12, 14&U and OPEN Saturday. Timed finals Friday and Sunday, and timed finals for all 8&Under events.

Facility: Indoor, 25-yard pool with up to 10 lanes on one course. Two courses may be used if dictated by timelines or at the discretion of meet management. Pool depth – 7' throughout 25 yards on the western course and ranging from 12' at the start to 4' at the turn end on the eastern course. Lanes are 7'4" wide with 6-inch Kiefer Wave Eater lane lines and 29.5" Kiefer Elite Starting Platforms. Backstroke wedges may be used. The meet host will ensure the required course dimensions.

MAAPP 2.0 Policy: All adults participating in or associated with this meet acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with MAAPP is a condition of participation in the conduct of this competition. Times achieved by an athlete member at a sanctioned meet who is over 18 years of age who had not completed the Athlete Protection Training (or whose APT training had expired) by the date of the swim, will not be able to be uploaded to SWIMS. These athletes will also be considered "not in good standing" and can be subject to fines under Wisconsin Swimming Policy 11.2.1.

Schedule/Warm-ups: **Friday PM:** 5:00pm-6:00 pm warm-ups. Meet Start: 6:05 pm

Saturday AM: 7:30am-8:30a warmups. Meet Start: 8:35am

Saturday PM: Warm-ups will begin 65 minutes prior to the scheduled session start time including a 5 minute clear water period.

Saturday Finals: 4:30-5:30p warmup. Meet Start 5:35p

Sunday AM: 7:00am-8:30am warm-ups. Meet Start: 8:35am

Sunday Distance: Warm-ups will begin 30 minutes prior to the scheduled session start time. Warm-ups will begin no less than 15 minutes after the completion of the AM session.

Doors will open at 4:30 pm on Friday and at 7:00 am on Saturday and 6:30 am on Sunday

Wisconsin Swimming warm-up procedures will be in effect. Warm-up session will begin with 30 minutes of circle swimming in all lanes. Swimmers must enter the pool from the starting end using a three-point entry for warm-up. Sprint and Pace lanes will be opened at the discretion of the Meet Management as needed during the remaining warmup. Violators of the Wisconsin Swimming warm-up procedures are subject to disqualifications. Warmup procedures will be finalized after the close of entries. The use of equipment (paddles, kickboards, fins, etc.) is prohibited.

Lane assignments for warm ups may be used. Assignments, if needed, will be sent out to teams by February 6th and will also be posted at the facility. During the competition, if the East (waterpark) course is being used, 2 lanes will be available for warm-ups / cool downs in the waterpark or in the center section between the bulkheads – otherwise the East pool will be used for warm-ups / cool downs and the waterpark pool will be closed to Athletes.

Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water, without the use of the backstroke ledge. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

Timing System: A fully automatic Colorado timing system with manual back-up buttons and back-up watches for each lane.

Timers: Volunteer timers will be provided by Pleasant Prairie Patriots. Visiting teams may be asked to provide volunteer times (this will be communicated well in advance of the meet; lanes, sessions, etc.)
Athletes must provide timers and counters for the 1650

General Rules: Official current USA Swimming and WI LSC rules shall prevail at this meet. Age as of **February 6, 2026 will dictate swimmer age for the meet.**

Entry Fees: \$6.00 per individual event for timed final events, \$8.00 per individual event for prelim final events, \$4.00 WI LSC Splash Fee, \$5.00 for admissions plus \$15.00 facility fee for each swimmer entered in the meet. All fees must accompany entries. Checks should be made payable to “Village of Pleasant Prairie”.

Entry Limit: Individual event participation is limited to a maximum of three (3) individual events per session and eight (8) individual events for the meet.

Disabilities:

Athletes shall present an [accommodation/modification form](#) to the Meet Director or Meet Referee to assist with any athlete requests.

Deck Entries: Deck entries may be accepted at the discretion of the Meet Referee and Meet Director where space allows in existing heats. Deck entries are \$15.00 per individual event. Swimmers not already in the meet must pay the \$15.00 facility fee, and \$4.00 WI LSC Splash Fee at time of entry. Fees must be paid when deck entering in the Shark Room by cash or check payable to “Village of Pleasant Prairie”.

Format: Prelims/Finals for 9-10, 11-12, 14&U and OPEN Saturday. A&B finals for 9-10 & 11-12, 14&U and OPEN. Timed finals Friday and Sunday, and timed finals for all 8&Under events. The distance events: 500 Free, 400 Individual Medley, and the 1650 Free will be swum fastest to slowest. All events are pre-seeded with the exception of the 500 Free, 400 Individual Medley, and 1650 Free, which will be positive check-in. Swimmers in the 1650 free must provide their own counter and timer. Coaches will receive positive check in sheets in their coaches' packet and must be returned to the Administrative Official in the Shark Room. Positive check-in for the 500 free, 400 Individual Medley, and 1650 free will close 45 minutes before the start of the session. Athletes swimming in 25 yard events will start on the bulkhead end of the pool. **Please note:** Distance heats/events may be limited to conclude the session within a required time

standard. Breaks may be added or events may be combined (age/gender) at the discretion of meet management.

Awards: Ribbons will be given out for places 1 through 10 to 12 & under swimmers.

Heat Sheets: Heat sheets and estimated timelines will be posted on the Patriots Swimming website on the meet landing page as soon as the meet is seeded. Please be advised, heat sheets/seeding of the meet may change after web posting. Wi-Fi is complementary in the Aquatic Center and RecPlex facility.

Food: The RecPlex may have food and beverages available at concession areas during the meet. Coaches and Officials working the meet will be provided complimentary food and drink in the hospitality room.

Conduct: All coaches are responsible for the conduct of their swimmers and will see that their club has proper supervision at all times. Meet marshals have the authority to remove any swimmer and/or spectator from the meet for any violation such as improper behavior, damage to property, etc. No smoking on the premises. Please encourage your parents and swimmers to clean up after themselves. In accordance with the Federal Video Voyeurism Prevention Act of 2004 – the use of audio or visual recording devices, including cell phones, is not permitted in the changing areas, restrooms, or locker rooms. Changing into or out of swimsuits other than in locker rooms or other designated areas is not appropriate and is prohibited. Deck changes are prohibited.

Drone Use: Operation of a drone or any other flying apparatus is prohibited over the venue (pool, athlete's/coach areas, spectator area and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.

Underwater Video Use: Operation of a video recording device in the water is prohibited in any pool in the complex at all times during the meet (including warm-ups) unless approved and sanctioned by USA Swimming.

First Aid: Report injuries to the Lifeguard staff and Meet Directors. Only authorized RecPlex staff may administer care for liability reasons.

Lost & Found: Lost and found items will be placed in a drum at the Aqua Arena entrance marked "Lost and Found". Items of value will remain locked in the Aquatics Manager's office for identification. After the meet, lost and found items will be donated to charity after one weeks' time.

Meet Results: A copy will be emailed to participating teams and posted on the Patriots Swimming website. Results will also be posted at www.wisconsinswimming.org.

Swim Supplies: A vendor may be on site.

Facility Guidelines: No coolers or portable chairs may be brought into the facility, including on deck.
NO GLASS CONTAINERS ALLOWED ON THE POOL DECK.
