## Rules:

Official 2023 USA Swimming and WI LSC rules shall prevail at this meet.
All applicable adults participating in or associated with this meet, acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with the MAAPP 2.0 policy is a condition of participation in the conduct of this competition. A registered athlete member at a sanctioned/approved meet who is 18 years of age or older, who had not completed the Athlete Protection Training (APT) by the date of the swim, will not be able to upload into SWIMS. These athletes will also be considered "not in good standing" and can be subject to fines under Wisconsin Swimming Policy 11.2.1.

Eligibility: All swimmers must be currently registered with USA Swimming. Swimmer's age as of November 3, 2023 shall determine their age group for the meet.

Entry will be accepted on a first come, first filled basis beginning at 10am, Tuesday, October $17^{\text {th }}$ through midnight, Thursday, October 26th. You will receive confirmation that your entries were received and accepted. Once accepted, changes (as space permits) and times updates will be allowed through Monday, October 30th. Senior Prelim/Final Session participation is limited to a maximum of either 3 individual events and 1 relay, OR 2 individual events and two 2 relay events. Sunday's Senior Session is limited to a maximum of 3 individual events. 12\&Under Timed Final Sessions participants are limited to 4 individual events and 1 relay. Friday session limited to two events subject to the timeline.

Disabled Swimmers: Teams are encouraged to inform Meet Director and Officials of any special needs swimmers prior to the start of warmups.

The meet will be a combination of prelim/final events and timed final events as listed in the Schedule and Order of Events. Prelims events will be combined ages. Final individual events will be divided into 13-14 and Senior. Senior events are ages 15 and over.

Friday events are all positive check in. Positive check in will close at 4:30pm. All Friday events will be swum fastest to slowest

Finals Format - The top 20 of each gender and age group as listed will advance to finals in individual preliminary events with the fastest 10 swimmers in the Championship A finals and the next 10 swimmers in the Consolation B. The top seeded 10 swimmers of in the 500 freestyle by age and gender and the top 10 seeded relays of each gender will swim in finals.

Check in - All A finalists must check in prior to the start of the B final in the event they are competing.

Sunday PM Session - Will include 50's of each stroke in the survive and advance skins format. Each round (except freestyle) will be swum between heats of the 200 events in the timeline following each 50 skins event. Final heats of all events in this session will be announced. Skins format -

Round 1 will include all athletes
Round 2 will be the Top 3 fastest from Round 1
Round 3 will be the Top 2 fastest from Round 2
Pre-seeded events (prelims and timed finals) will have no penalty for failing to compete in prelims or timed finals.

## Finals events:

a. A swimmer qualifying for a consolation or championship final will have 30 minutes after the announcement of the preliminary results for that race in which to scratch or declare intent to scratch pending another race.
b. A swimmer who declares intent to scratch must declare their final intentions within 30 minutes following the announcement of the preliminary results for their last individual preliminary event of the session.
c. After the scratch deadline, finals qualifiers will be posted with results.
d. Failure to compete - This meet shall follow the WI Swimming scratch 4.1.3 Scratch Rule. If a swimmer qualifies for a final and does not scratch and fails to compete in the final, the swimmer shall be barred from further competition for the remainder of the meet. Disqualification under this section shall apply only to swimmers qualifying based on the original preliminary results.

Warm-up procedures will be in effect. Feet first three-point entry from the starting end during general warm-ups will be enforced unless performing one way starts.

Breaks may be added/adjusted, heats may be combined, and additional events may be positive check-in at the discretion of meet management.

Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. Further, those participants not proficient with a backstroke ledge must start each race from within the water, and without the use of the backstroke ledge. When unaccompanied by a member-coach, it is the responsibility of the swimmer of the swimmer's legal guardian to ensure compliance with this requirement.

The entry fee for deck entries will be $\$ 10.00$ per individual event. Deck entries will be allowed at the discretion of the Meet Director and only to fill open lanes if the timeline permits. Additional heats will not be added. Deck entries close 30 minutes prior to the start of the session. On-deck USAS registrations will not be accepted.

Coaches' Packets will be available in the office. Please be prepared to show your USA Swimming Coach's Card at the time of picking up your packet. Coach's must check in for each session and coach cards must be visible at all times on deck.

Each team with swimmers in the meet will be asked to provide timers. A list of lane assignments for each team will be posted at least 48 hours prior to the meet.

Food and beverages will be available on the premises. No food or beverages are allowed in the pool area.

All coaches are responsible for the conduct of their swimmers and will see that their club as proper supervision at all times. Meet Marshals shall have the authority to remove any swimmer/s from the meet for any violation such as improper behavior, damage to property, etc. Such teams are responsible financially for damage of property. Please make sure your team's area on deck and rest area is picked up at the end of each session.

Use of audio or visual recording devices, including cell phones, is not permitted in the changing areas, restrooms, or locker rooms. Changing into or out of swimsuits other than in the locker rooms.

Limited seating for spectators with disabilities is available on the second floor via the elevators. Notify the Meet Director prior to the meet if further assistance is needed.

Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials, and/or spectators are present. Exceptions may be granted with prior written approval by the Program Operations Vice Chair.

Injuries must be reported to the Lifeguard and to the Meet Director. A first aid kit will be located at the Lifeguard station.

An area for lost and found will be located by the desk near the facility entrance. Items not picked up by meet end will be donated.

Results will be posted on the Wisconsin Swimming website and emailed to participating teams.
