General Meeting	The General Meeting will be held virtually on Wed., December 10th @ 8:00pm via Zoom . It will be recorded and posted on the host's website and/or emailed to all teams. Additional coaches' meetings may be held as determined by the Meet Referee. It is the responsibility and obligation of each team or unattached swimmer to be represented at all coaches' meetings. Coaches or other team representatives are responsible for all information presented at these meetings, including changes to the meet format or conduct. Coaches should check their team mailboxes prior to each session where they pick up heat sheets (admin table).
Officials Meeting	An Officials Meeting will be held one hour before the starting time for each session in the hospitality room. Anyone wishing to officiate at this meet should sign up on the Meet Landing Page or contact the Team Lead CJ.

	Officials must have valid USA Swimming registration and must be working that session to be on deck. The official mobile application of USA Swimming is acceptable proof of USA Swimming Membership. Timers' briefings will be held 30 minutes before the start of each session.
Deck Access	Deck access is restricted to participating athletes, coaches, working officials, and meet personnel. Credentials will be issued and must be displayed at all times while on deck. This will be strictly enforced by Meet Marshals and other meet staff. Parents/guardians are NOT allowed on deck or in the locker rooms at any time. Parents and other non-swimmers not involved in the running of the meet are requested to remain in designated spectator areas. The Meet Director and Meet Referee reserve the right to limit deck access in the event of overcrowding, inappropriate behavior or for any reason concerning the safety or the efficient operation of the meet. USAS Rules of Conduct will be strictly enforced. Coaches may pick up meet packets in the admin office and must sign-in at the start of each session
Facility	One ten-lane, 25-yard pool with non-turbulent lane markers and backstroke flags will be used. The Pool depth at both the starting and turn ends is 7 feet. The block height is 29.5 inches. Starting blocks on the bulkhead will be used to start the 8&U 25-yard events. Backstroke wedges will be available at the starting end of the pool. Backstroke wedges will not be available for the 8&U 25-yard backstroke, starting on the turn end of the pool. The Meet Host will ensure the required course dimensions.
Timing System	A fully automatic Colorado timing system with two manual back-up buttons and two back-up stop watches for each lane will be used. 25's will be run through the Colorado Timing System.
Spectator Admission	Admission for the meet is included in the entry fee for each athlete. There is seating for disabled spectators in the balcony area of the pool The meet will be live-streamed, if technology allows. Links are available on the meet landing site.
Parking	Parking is available on the Racine Aquatic Center property, on the street near the premises, or in the adjacent lots at Racine Case High School.
Lost and Found	The lost and found area is located near the concession stand. A specified table for all lost and found items will be provided. All items left at the end of the meet will be donated as seen appropriate.
Concessions	Concessions will be available at the concession stand provided at the main entrance at the Racine Aquatic Center.
First Aid/Medical	All injuries should be reported to the lifeguard on duty. Lifeguard staff has basic first aid supplies available if needed. There are two AEDs on the pool deck. The first is located directly outside of the first aid room, behind the starting blocks. The other is located in the lifeguard office next to the diving well. Lifeguards can activate EMS if needed.

Depending on the size of the meet and timeline, warm-up times may be adjusted by meet management, and teams will be notified once all entries are received.

Breaks will be scheduled after the conclusion of the individual events and as noted on event order below, for a minimum of 5 minutes. Additional breaks may be scheduled as needed and will be determined by meet management before the start of the meet. Meet management would determine the duration of each break. Depending on duration, the competition pool may or may not be open for warm-ups during these breaks. All added breaks will be posted to the session report and communicated to lead coaches.

Warm-up times and lanes will be assigned. Assignments will be posted on the meet landing page and communicated to the "lead" coach for each team. Each team will be assigned a time block of no less than 20 minutes of warm-ups. A final, unassigned, 15 minute controlled warm up time block will be provided to all teams for starts/pace at the end of the warm up session. Controlled starts may be done during a team's assigned time block provided coaches are present and monitoring.

Swimmer(s) without a coach present or prior arrangements are to report to the Meet Director prior to warm-up sessions start time for lane assignment.

CONDUCT OF THE MEET

Meet Format	This meet will be conducted in short-course yards using ten lanes; it is a 2-day competition. All events are pre-seeded, timed finals, swam slow to fast, except as noted elsewhere in the Meet Information. All swimmers must report to the blocks for the start of their heat. Fly-over starts will be used.
Deck Entries	Deck entries for individual events will not be accepted. Relay-only swimmers may be deck-entered no later than 30 minutes before the start of each session. The coach must give the information to the Meet Director and pay the appropriate fee(s).
MAAPP	All adults participating in or associated with this meet acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with MAAPP is a condition of participation in the conduct of this competition. Times achieved by an athlete member at a sanctioned/approved meet who is over 18 years of age who had not completed the Athlete Protection Training (or whose APT training had expired) by the date of the swim, will not be able to be uploaded to SWIMS. This includes participation as a member of a relay. These athletes will also be considered "not in good standing" and can be subject to fines under Wisconsin Swimming Policy 11.2.1.

RULES and PROCEDURES

Official Rules	Official current USA Swimming and Wisconsin LSC rules shall prevail for this meet except as otherwise specified in this meet information. Participating athletes must be registered USA Swimming athletes and in good standing. The athlete's age on the first day of the meet determines the age group for the entire competition. All coaches and officials are required to sign in and prove that their USA Swimming membership is in good standing and all certifications are current. The official mobile application of USA Swimming should be used for proof of USA Swimming membership. All USA Swimming athletes must be under the supervision of a USA Swimming member coach during warm-up, competition, and warm-down. The Meet Director or Meet Referee may assist an unaccompanied swimmer in making arrangements for such supervision, but it is the swimmer's responsibility to make such arrangements prior to the start of the meet.
Deck Registration	On deck USAS registrations will not be accepted at this meet.
Para/Disability Swimming	Para athletes or their representative coach will be expected to provide a written document of the desired accommodations (physical needs maneuvering throughout the venue) and modifications (technical rule changes while swimming) to the meet referee upon arrival. Failure to provide documentation will grant the meet referee complete discretion towards disqualifications, with no protest. Athletes that are requesting an accommodation and/or modification, shall present the WSI Para Accommodation Form to the meet referee and/or meet director prior to the meet start.
Start Certification	Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water without the use of the backstroke ledge. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.
Protests	For consideration of administrative protests lodged at the meet, the Meet Referee may appoint a meet committee consisting of not fewer than three (3) and not more than five (5) persons, at least one of whom shall be a coach and one an athlete, prior to the start of competition. Protests against judgment decisions can only be considered by the Referee and the Referee's decision is final.
Warm-Up Procedures	USA Swimming and Wisconsin Swimming warm-up procedures will be enforced throughout the meet. Circle swimming only, feet first entry from the starting end of the pool. No equipment or other training devices are allowed in the competition pool during warm-ups. Violators of the warm up procedures are subject to disqualification. Additional in-water breaks may be determined once all entries have been received and timeline has been set. During the competition, there will be warm-up/warm-down lanes available in the diving well portion of the competition pool. 5 Lanes (with backstroke flags) will be made available and monitored throughout the meet. Swimmers are NOT permitted to use the adjacent lesson pool. During Awards Breaks, the competition pool will remain closed. Athletes will have

	continual availability to the warm-up/warm-down pool during the sessions. More information will be presented at the general meeting.
Conduct	Coaches are responsible for the conduct of their swimmers and will see that their club has proper supervision at all times. Meet Marshals have the authority to remove any swimmer and/or spectator from the meet for any violation such as improper behavior, damage to property, etc. No smoking on the premises. • Each team is responsible for the conduct of its swimmers and parents. • Teams are asked to pick up any garbage in their immediate team area after each session. • No coolers, chairs, blankets, or large bags will be allowed in the spectator area. • Swimmers (and their bags) should sit in their team's area on the pool deck, not in the spectator stands. • Use of audio or visual recording devices, including cell phones, is not permitted in changing areas, restrooms, locker rooms or behind the blocks. • Changing into or out of swimsuits other than in locker rooms or other designated areas is not appropriate and is prohibited. Deck Changing is prohibited. • Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present. • No underwater video recording equipment is allowed at any time during the meet. • Flash photography will not be allowed during the start of any heat. Individuals using flash photography near the start of a heat may be ejected from the meet facility. • Parents are NOT allowed on deck at any time, except when serving as counters for distance events, or as timers. • Spectators should avoid camping in the long hallways adjacent the pool deck. These areas need to be cleared for easy access for athletes to the Awards Staging, and 8&U Staging, respectively. • No glass containers of any kind are allowed on deck or in locker room areas. • Locker Rooms on the pool deck will be designated ATHLETE only. Use by coaches, officials and volunteers is strictly forbidden. All participants agree to be filmed and photographed by the official photographer(s) and network(s) of Wisconsin Swimming and the meet host under the conditions authored by Wisconsin and USA Swimming, and allow event organizers the right to use names, pictures, likenesses, and biographical information before, during or after the period of participation in this Wisconsin Swimming competition to promote such competitions. To withhold consent, please contact the host team or Meet Director for the proper forms.

ENTRY INTO THE MEET

Swimmer Eligibility	All swimmers must be registered athlete members of USA Swimming and Wisconsin Swimming, and be in good standing. The athlete's age will be determined as of the first day of the meet. All individual swimmers entered in the meet shall be eligible to swim in the meet, having at least one verifiable qualifying time. Swimmers who cannot verify qualification for the meet with a proof of time will be withdrawn from the meet. Any

	swimmer who swims in the meet and is found ineligible will be disqualified from the meet, forfeit all awards and points achieved and their club fined \$200. The representative submitting entries shall be responsible for verifying that all swimmers satisfy these requirements. Swimmers must meet the 2025 Wisconsin LSC Single Age Championships Time Standards.
Qualifying and Seed Times	QUALIFYING TIMES MUST BE ACHIEVED AFTER September 1st, 2024 . Qualifying time standards are listed on the meet landing page and on the Wisconsin Swimming website. Qualifying times will be accepted in Short Course Yards, Long Course Meters, or Short Course Meters. Non-conforming times will be seeded after SCY times. The order used for seeding will be SCY-SCM-LCM Bonus entries will be seeded after qualified swims in the same order. 2025 Qualifying Time Standards
Para/Disability Athletes	Para swimmer athletes can enter any event (up to the limit of the meet information) but they must have achieved a Wisconsin Swimming State Time Standard OR the Disability Para Motivational Championship Time Standards (P1, P2, P3). Both sets of time standards can be found on Wisconsin Swimming's website. Although swimmers with disabilities can enter any event(s), the only events that will be scored and awarded in Para categories are noted on the event page. All 25s of stroke will be offered for 8 & Under athletes (please note that 8 & Under athletes must qualify at the 50 of stroke time standard (P1, P2, P3) but still enter at their 25 time). When entering an athlete with a disability to the designated Disability events or any other events, email the Entry Chair so they can be verified and seeded properly. If coaches have any questions regarding the Disability inclusion at the State Championship, please email Wisconsin Swimming's Disability Chair (Tom Miazga - tommiazga8@gmail.com) Meet Management may combine entries based on gender and/or age groups.
Age Groups	The meet is broken into age groups as single age divisions for individual races (8 & U, 9YO, 10YO, 11YO, 12YO) Relays will be in three competitive age groups (11-12, 10 & U, 8 & U). Athletes must swim their conforming age during the duration of the meet.
Entry Limit	A swimmer may compete in 6 events total for the meet. A swimmer may compete in 4 events per day. A swimmer may compete in 1 Relay max per day
Bonus Events	Any swimmer who has entered with one qualifying time may enter three bonus events for which they do not have a qualifying time. Any swimmer entered with two qualifying times may enter two bonus events. Any swimmer entered with three qualifying times may enter one bonus event. Any swimmer with four or more entered qualifying times is not eligible for bonus events. There are no bonus entries for swimmers that are "relay only" entrants in the meet. ENTRIES MUST INCLUDE A PDF COPY OF RESULTS INDICATING ALL BONUS EVENTS.
Relay Events	A Relays must consist of at least one (1) individual qualifier in that age group and gender. B Relays must consist of eight (8) Qualifiers in that age group and gender. C Relays must consist of twelve (12) Qualifiers in that age group and gender, etc. The other members of a team's only relay entry in each age group/gender may be relay only swimmers. Relays that are not a team's only relay for an age group & gender must be composed entirely of swimmers who are individually qualified for the meet. Relay-only

	swimmers must be included in your entry. To add a relay-only swimmer after the entry deadline, the swimmer must be entered in the meet 30-minutes prior to the start of the session in which they will swim. If a swimmer who is entered as an eligible swimmer is found to be ineligible for the meet, that swimmer may not be part of a relay as a relay only swimmer and does not count as a qualified swimmer for a relay.
