- DATE:** Friday-Sunday, May 31 – June 2, 2024
- LOCATION:** NICHOLAS RECREATION CENTER 797 W Dayton Street Madison, WI 53715
- FACILITY:** 8 lanes, 50-meter pool. Pool depth is 8'3" at the start end and 8'3" at the turn end. Block height: 32 inches. Backstroke wedges for all lanes
25-yard Diving well will be available throughout the meet.
The Meet Host will ensure the required course dimensions.
- CLASSIFICATION & FORMAT:** Open Invitational.
Friday PM is distance events.
13-over swimmers have prelim/final events on Saturday, timed finals on Sunday
Both the Saturday and Sunday sessions are timed finals for the 12-under athletes.
Wisconsin State Qualifying standards are required for each initial entry.
Initially, swimmers will be allowed 'bonus events' (see below). Based on the size of the initial entry we may allow additional bonus, though the number of bonus swims allowed may vary from one age group and/or gender to another.

- TIME TRIALS:** Time trial sign-up schedule and deadlines will be communicated prior to the meet. All events potentially offered each day. Swimmers should already have seed times equal to or faster than Summer Speedo Sectional Time Standards.
Time Trial swimmers should be prepared to provide their own times and/or counters.
The Time Trial portion of this meet is technically run under a separate sanction (see attached information at the end of this meet info) but USAS rules on max events per day still apply.
- WARM-UPS:** BAC reserves the right to assign warm up times and lanes.
Feet first three-point entries from the starting end of the pool during general warm-ups will be enforced for all sanctioned/approved competition in accordance with the recent change to Wisconsin Policy 4.5.2(a).
No equipment, pull buoys, kick boards, or paddles used during warm-ups.
- ENTRIES:** Swimmers may compete in **3 (THREE)** individual events per day **a TOTAL of 7 (seven) races per the meet.** Total entries may be limited to a maximum of 1600 per day. The meet will be run using Hy-Tek Meet Manager. All teams are required to submit entries by e-mail in the Hy-Tek commlink format. Swimmers looking to compete in any Time Trial events (under a separate sanction) will still be held to USAS rules on maximum events per day.
- TIME STANDARDS:** **Are the 2024 Wisconsin LSC Championships Time Standards.** Those standards can be found on the WI LSC website under the "Athletes" tab

- BONUS ENTRIES:** Initially, bonus events will be allowed following an "up to 3" rule; swimmers entered with one qualified swim may enter 2 bonus events, swimmers entered with two qualified swims may enter 1 bonus event, and swimmers entered with 3 or more qualified swims may not enter any bonus events.
Meet host reserves the right to offer additional bonus opportunities based on the size of the meet after receipt of the initial entry. These additional bonus events may only be available for some ages or sessions.
Swimmers MAY NOT enter any bonus events on Friday evening.
- ENTRY:** Entry Chair is Jacob Johnson. Email at coachjacob@badgeraquatics.com or text (608) 852-5727. Bring waiver and check to the first day of the meet - no need to mail beforehand
- RACING STARTS:** Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water without the use of the backstroke ledge. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.
- DISABILITY, SWIMMERS:** Disability swimmers may be entered in the meet even if they have not achieved the time standard for the meet.
Please indicate on the entries form any special needs for those athletes requiring assistance. Also, please inform the head official of those needs prior to the start of the meet.
- ENTRY FEES:** \$4.00 LSC splash fee per swimmer, \$8.00 per individual event \$20.00 Facility fee.
Fees – as well as the waiver – can be brought to the meet instead of mailing ahead of time.
- DECK SEEDING & REGISTRATION:** Deck seeding may be allowed after the publication of the heat sheet to fill open lanes. There will be a surcharge of \$4.00 plus entry fees = (\$12.00) for anyone wishing to be deck seeded. All swimmers must currently be registered with USA Swimming.
On deck USA Swimming Registrations will not be accepted.
- ENTRY DEADLINE:** **INITIAL ENTRY PERIOD:**
Monday May 13TH, 2024 at Noon until Monday, May 20th at noon. Efforts will be made to accommodate every interested team, but we'll incorporate a 'first come, first served' element if the meet fills.
FINAL ENTRY DEADLINE:
Teams who submitted initial files will be allowed to send an updated file until Monday, May 27th at noon.
- TIMING SYSTEM:** All events will be timed using Colorado 7 timing system with Strobe/Horn Start, Touch pads, two buttons, and 1watch as backup.
- AWARDS:** 1st through 8th place medals
Swimmers will be responsible for picking up their awards at the awards table.

- MEET CONDUCT:** ATHLETE & PARENT CONDUCT, please follow the athlete and parent conduct guidelines below. Anyone not following these rules may be subject to removal from the meet and facility. Each team is responsible for the conduct of its swimmers and parents.
- Teams are asked to pick up any garbage in their immediate team area after each session.
 - Only counters and officials are allowed at the pool edge during competition.
 - No coolers, chairs, blankets or large bags will be allowed in the main pool spectator area.
 - Swimmers (and their bags) should sit either in their team's area on the pool deck or in the off-deck team area, not in the spectator stands
 - Deck Changes are prohibited
 - Use of audio or visual recording devices, including cell phones, is not permitted in changing areas, restrooms or locker rooms. Changing into or out of swimsuits other than in locker rooms or other designated areas is prohibited.
 - Flash photography and photography from behind the starting blocks are prohibited at the start of each race. Only designated photographers will be allowed on deck during the warmups and meet.
- MAAPP POLICY:** All adults participating in or associated with this meet acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with MAAPP is a condition of participation in the conduct of this competition. Times achieved by an athlete member at a sanctioned meet who is over 18 years of age who had not completed the Athlete Protection Training (or whose APT training had expired) by the date of the swim, will not be able to be uploaded to SWIMS. These athletes will also be considered "not in good standing" and can be subject to fines under Wisconsin Swimming Policy 11.2.1.
- ADMISSIONS:** The admission is built into the athlete surcharge, so spectator admission the day of is FREE. Programs are also part of that fee, and will be available for FREE on the BAC website ahead of the meet as well as on Meet Mobile.

- FINAL RESULTS:** Teams that submitted entries via e-mail will receive a MM back up and TM file sent to the provide e-mail contact/address used to submit entries. Contact the meet director if another email needs results.. Complete meet results in pdf format plus MM back up and TM files will be sent to be posted on the WI web after the conclusion of the weekend.

- FRIDAY NIGHT DISTANCE EVENTS:** Check-in may be required for Friday events. Deadlines will be communicated after final entry. All events are swum fast to slow. BAC reserves the right to request timers for Friday night.
- SATURDAY PRELIM FINAL EVENTS:** 16 swimmers - A final and B consol – advance for 13-14 girls and boys
24 swimmers – A final, B consol, C bonus – advance for Sr women and men
- SCRATCH RULES:** The USA Swimming scratch rule will be in effect for all prelim/final events

PROOF OF TIME: After the entries are completed, the meet database will be “reconned” by WI Swimming’s Registration Chair for times that are not in the USA Swimming times database.

MEET FINES: Swimmers who are disqualified or who fail to swim qualifying times in events may be asked to either prove the qualifying time or pay a \$100.00 fine before their next event if their entry time is not in the USA Swim Database. Athletes who fail to make the cut-off time, but still make Finals, may swim Finals only if they can prove the time. Official meet results, USA Swimming Times Database reports and Hy-Tek TM entry reports with proof of times are acceptable proofs of time. The host team will make exceptions for its swimmers.

- FACILITY:** 8 lanes, 50-meter pool. Pool depth is 8'3" at the start end and 8'3" at the turn end. Block height: 32 inches. Backstroke wedges for all lanes
25-yard Diving well will be available throughout the meet.
The Meet Host will ensure the required course dimensions.
- SCHEDULE:** There will be 3 separate Time Trial sessions during the weekend. A more exact schedule will be sent to participating teams once the JPI entries are finalized.
Session 1: upon the conclusion of Friday TF events – appx 7:30pm
Session 2: upon the conclusion of Saturday Finals events – appx 8:30pm
Session 3: upon the conclusion of Sunday TF events – appx 4:30pm
All events are potentially offered each Time Trial Session. All events will be Open and Mixed Gender. Events will be swum shortest to longest and some events may be combined.
- QUALIFICATION:** Swimmers should already have seed times equal to or faster than Summer Speedo Sectional Time Standards.
- ENTRIES:** Swimmers are limited to a single event in each session. Additionally, swimmers should be aware of the USAS maximum number of events in a day, particularly on Saturday with prelim/final events.
Entries may be limited at the discretion of the Meet Host.
- ENTRY FEE:** Each Time Trial race will be \$20. Swimmers not entered in the JPI may be subject to additional fees.
- ENTRY PROCEDURE:** Swimmers can sign up on deck at the admin table. Deadlines will be communicated once the final entries for the JPI meet are set.
- ELIGIBILITY:** Generally, the Time Trial portion is reserved for swimmers already registered for the JPI. Swimmers interested in competing in ONLY a Time Trial can contact the JPI Meet Director
- TIMERS & COUNTERS:** Participants will need to provide their own timers and counters.
