Facility & Timing Details	Indoor, eight lane, 25 yard pool. Depth is 12'0" at the start end and 4'0" at the turn end. The meet host will ensure the required course dimensions. Backstroke wedges will not be available. All events will be timed using a Colorado Timing System 7 with horn start, touch pads, buttons, and watches. 25 yard races will start from the blocks and will be timed using 2 plungers and 2 watches. Lifeguards and pool staff will be available and providing medical supervision during the meet, both on deck and in the pool office.

MAAPP	All adults participating in or associated with this meet acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy (MAAPP), and that they understand that compliance with MAAPP is a condition of participation in the conduct of this competition. Times achieved by an athlete member at a sanctioned meet who is over 18 years of age who had not completed the Athlete Protection Training (or whose APT training had expired) by the date of the swim, will not be able to be uploaded to SWIMS. These athletes will also be considered "not in good standing" and can be subject to fines under Wisconsin Swimming Policy 11.2.1.			
Rules	Official Current USA-Swimming Rules shall prevail for this meet. Swimmers must be registered USAS swimmers. Age is as of the first day of competition. Coaches must display their coach's credentials to be permitted on deck. The official mobile application of USA Swimming is acceptable proof of USA Swimming membership. Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.			
Meet Conduct	Each club is responsible for the conduct of its swimmers. Any person who, in the opinion of the Meet Director or Meet Marshall, is harmful to others or to other's property may be required to leave the competition. Deck changes are prohibited. Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms. Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present. Exceptions may be granted with prior written approval by the Vice President of Program Operations.

Warmup Details	Warmup assignments and procedures will be released the week of the meet by the entry chair. Three-Point entries from the starting end of the pool during general warm-ups will be enforced for all sanctioned/approved competition. No equipment, pull buoys, kick boards, or paddles used during assigned warmups.
Seeding	All events, with the exception of the 11&O 50 freestyle, will be seeded as timed finals events, fast to slow. The individual events are multi age: 10&U are multi-age 6&U/7&8/9&10; 11&O are multi-age 11&12/13&14/15&O
Shootout 50	The 11&O 50 freestyle is <i>not</i> multi age. All swimmers entered in the 50 will swim in the first event of the session. The top 8 from Round 1 will swim in Round 2; The top 4 from Round 2 will swim in Round 3. The top 2 from Round 3 will swim in the final round.
Disability Swimmers	Please inform the head official of those needs prior to the start of each session.
Scoring	1 st through 8 th place ribbons will be awarded for all individual & relay events No high point awards will be offered for this meet. A prize will be awarded to the winner of the Shootout for each gender.
