POOL INFORMATION	Eight lane, 25 yard pool. Pool depth is 9 feet at the start end and 4 feet at the turn end. Blocks are 30 inches high. Pool features non-turbulent lane markers and backstroke flags. The pool utilizes Colorado blocks with individual start horns. The meet host will ensure the required course dimensions.

## Entering the Meet

ELIGIBILITY	All athletes must be current registered members of USA swimming. First date of the meet will determine the age of competition
ENTRIES	Completed entry file must be received by the entry chair no later than the deadline date with payment and waivers. Submit current yard times. Please submit electronic entries via email. This meet is being run by HyTeck swim software.
ENTRY DEADLINE	May 11, 2024
ENTRY LIMITS	Swimmers may compete in four (4) individual events plus two (2) relay.
ENTRY FEES	Individual events: \$5.00 per event Relay team: \$12 per relay Splash Fee: \$4.00 per swimmer entered in at least one individual event. Admission Fee: \$10 per swimmer Deck entries: \$8.00 per individual event.  Please make checks payable too FAST. Entry fees must accompany the official entry forms and are not refundable.
ON DECK REGISTRATIONS	All individual events will be pre-seeded. All deck seeding will stop at 8:00 AM for morning session and 1 hour before the start of the afternoon session. Deck entries will be considered exhibition and will not count towards awards or high point.
COACHES	All coaches must pick up their coach's packet in person and must show their coach's card. If a coach does not present a USA Swimming registration card, they will not be allowed on deck and the swimmers for the team will be assigned to a USA Swimming certified coach for warm-ups. The official mobile application of USA Swimming is acceptable proof of USA Swimming membership.

MEDICAL SUPERVISION	Please indicate any special needs your swimmers may have on the entry form. We will do everything possible to accommodate them. This should include any existing conditions that may require meet management to activate the emergency response plan. Building personnel and Lifeguards are trained in procedures required by Blood Borne Pathogens laws and will be responsible for any cleanup

	required. Lifeguards & high school trainer's room available to athletes participating in the meet.

HEAT SHEETS	Heat sheets will be sent to coaches electronically and posted on the meet landing page the night before the meet. Concessions will have a limited number of printed copies for sale
AWARDS	Ribbons for individual events places 1-12 and relay events places 1-3; Ribbons must be picked up at the awards table as none will be mailed out after the meet; Plaques will be awarded to the top three teams

## Rules, Regulations, & WI Swimming Information

STATEMENT OF RULES:	This meet is sanctioned by USA Swimming and Wisconsin Swimming, Inc. All USA Swimming and WSI rules apply including safety rules, which will be strictly enforced.
MAAPP	All adults participating in or associated with this meet acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with MAAPP is a condition of participation in the conduct of this competition. Times achieved by an athlete member at a sanctioned meet who is over 18 years of age who had not completed the Athlete Protection Training (or whose APT training had expired) by the date of the swim, will not be able to be uploaded to SWIMS. This includes participation as a member of a relay. These athletes will also be considered "not in good standing" and can be subject to fines under Wisconsin Swimming Policy 11.2.1.
RACING START CERTIFICATION:	Any swimmer entered in the meet, must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

<p>REQUIRED CONDUCT LANGUAGE:</p>	<p>All coaches are responsible for the conduct of their swimmers and will see that their club has proper supervision at all times. Meet Marshals have the authority to remove any swimmer and/or spectator from the meet for any violation such as improper behavior, damage to property, etc. No smoking on the premises. Please encourage your parents and swimmers to clean up after themselves.</p> <p>Use of audio or visual recording devices, including cell phones, is not permitted in the changing areas, restrooms, or locker rooms.</p> <p>Changing into or out of swimsuits other than in locker rooms or other designated areas is not appropriate and is prohibited. Deck changes are prohibited.</p> <p>Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.</p>
<p>IMAGE AUTHORIZATION:</p>	<p>All participants agree to be filmed and photographed by the official photographer(s) and network(s) of Wisconsin Swimming and the meet host under the conditions authored by Wisconsin and USA Swimming, and allow event organizers the right to use names, pictures, likenesses, and biographical information before, during or after the period of participation in this Wisconsin Swimming competition to promote such competitions.</p>
<p>LIABILITY WAIVER:</p>	<p>In consideration of the acceptance of this entry, intending to be legally bound, I/we hereby waive, and release any and all rights and claims for damages which may accrue against USA Swimming, Inc., Wisconsin Swimming, Inc., FAST, Fort Atkinson High School, and their representatives, employees, or successors, for any and all injuries suffered by me or any contestant or representative in said meet as a representative of my club. In granting this sanction it is understood and agreed that USA Swimming and Wisconsin Swimming Inc shall be free from any liabilities or claims for damages arising by reason of injuries to anyone during the conduct of the event.</p>
