In granting this sanction it is understood and agreed that USA Swimming and Wisconsin Swimming, Inc. shall be free from any liabilities or claims for damages arising by reason of injuries to anyone during the conduct of the event.

DATE: Saturday, October 7th, 2023

PLACE: ARROWHEAD HIGH SCHOOL, 800 North Ave, Hartland, Wisconsin

WARMUP: AM session: 7:30-8:30 AM as follows: 7:30-8:00 circle swim, all lanes NO diving.
8:00-8:30 one-way sprints and push 50's as needed. Meet starts at 8:35 AM.

PM Session: Warm-ups 45 minutes. Meet starts 50 minutes after conclusion of AM session.
Feet-first entries from the starting end of the pool during general warm-ups will be enforced for all sanctioned/approved competition.

POOL: Six lane, 25-yard pool, 5'1" starting depth, 3'6" non-starting depth, 30" blocks, non-turbulent lane markers and backstroke flags. The competition course has not been certified in accordance with 104.2.2C(4).

TIMING: Superior Swim Timing and Colorado System with back-up watches and across the board judging in case of a malfunction. All events are timed finals.

OFFICIAL RULES: Official current USA Swimming Rules shall prevail for this meet. Swimmers must be USA-Swimming registered. Deck Registrations are not allowed. Non-LSC members should bring their USA Membership Card. Age as of first day of the meet. Please notify meet officials of any disabled swimmers upon arriving at the meet.

MAAPP ACKNOWLEDGEMENT: : All adults participating in or associated with this meet acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with MAAPP is a condition of participation in the conduct of this competition. Times achieved by an athlete member at a sanctioned meet who is over 18 years of age who had not completed the Athlete Protection Training (or whose APT training had expired) by the date of the swim, will not be able to be uploaded to SWIMS. These athletes will also be considered "not in good standing" and can be subject to fines under Wisconsin Swimming Policy 11.2.1.

RACING START CERTIFICATION: Any swimmer entered in the meet, unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

CONDUCT: Each team is responsible for the conduct of its swimmers. Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, restrooms or locker rooms. Changing into or out of swimsuits other than in locker rooms or other designated areas is not appropriate and is prohibited. Deck changes are prohibited. Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials, and/or spectators are present. Exceptions may be granted with prior written approval by the Program Operations Vice Chair

ENTRY LIMIT: Swimmers may compete in four (4) individual events plus relays.

ENTRY FEES: Individual events \$5.00 per event and \$12.00 per relay. \$4.00 LSC surcharge per swimmer entered in at least one individual event. Deck entries shall be \$10.00/individual event and \$24.00/relay entry. Please make checks payable to LAKE COUNTRY SWIM TEAM. Entry fees should be brought to the meet or mailed in advance.

ADMISSIONS: Spectators over 13 years old are \$4.00. Heat sheets are \$4.00.

PARKING: Parking is available in the north lots.
