

## **Senior State Meet Entry Instructions**

Meet entries are due Monday, February 19<sup>th</sup> at 10:00 PM.

Send entry email to [lakecountryswim@sbcglobal.net](mailto:lakecountryswim@sbcglobal.net). Entry email should include the following:

- ✓ Hy-Tek Meet Entry File. Please be sure your entry file includes the 100-yard IM. There were some posted versions of the entry file that did not include this event. Also, the surcharge for meet should be \$50, not \$54.
- ✓ PDF of Individual entries by athlete name. Bonus events must be marked – the designation does not come through on the entry file. Please also select the show proof of time option to help us determine which entries may require proof.
- ✓ PDF of Relay entries by event. You may include swimmer names or not.
- ✓ Proof of time for all entry times not in the USA Swimming SWIMS database. These should be sent as PDFs of meet results with proofs clearly marked or indexed.
- ✓ Any required para-athlete documentation.
- ✓ Entry times for 50-yard stroke events (fly, back and breast) must be the swimmer's 100-yard time of that stroke. Entry times for the 100-yard IM must be the swimmer's 200-yard IM time.

Late Entry: Entries received after the deadline may be accepted upon remittance of a \$100 late fee. No entry will be accepted after 6:00 PM on Tuesday, February 20<sup>th</sup>.

Proof of Times: All entry times will be verified against the SWIMS database. Entry times requiring proof will be posted on Tuesday, February 20<sup>th</sup>. All proof of time is due by Wednesday February 21<sup>st</sup>, 2024, at 3:00 PM. After that time, all "unproven" times may be scratched from the meet.

Para athlete Entry: When entering a para-athlete into the meet, please be sure to include any needed documentation used to determine P1, P2 or P3 designated disability placement. If coaches have any questions regarding the Disability inclusion at the State Championship, please email Wisconsin Swimming's Disability Chair (Tom Miazga - [tommiazga8@gmail.com](mailto:tommiazga8@gmail.com)).

Psych Sheet: Psych Sheet WILL NOT be posted until Wednesday, February 21<sup>st</sup>, 2024. Only changes for administrative errors are allowed after the Psych sheet is posted.
