- **WARMUP:** AM session: 8:00-9:00 AM Warm-up, Meet Start 9:05 AM. Three-point feet-first entries from the starting end of the pool during general warm-ups will be enforced for all sanctioned/approved competition.
- **POOL:** Eight lane, 50-meter pool, 12' starting depth (turn depth 3'6"), 29.5" blocks, non-turbulent lane markers and backstroke flags. Racing will occur in lanes 1-6 only. The competition course has not been certified in accordance with 104.2.2C(4).
- TIMING: Manual timing with three (3) watches and across the board judging.
- **RULES** Official current USA Swimming Rules shall prevail for this meet. Swimmers must be USA-Swimming registered. Age as of the first day of the meet. Please notify meet officials of any disabled swimmers upon arriving at the meet. Deck Pass is acceptable proof of USA Membership.
- MAAPP Acknowledgement: All applicable adults participating or associated with the respective meet to which this information applies, acknowledge that they are an applicable adult, subject to the provisions of USA Swimming's MAAPP, and that they understand that compliance with the MAAPP is a condition of participation in the conduct of this competition. An athlete member at a sanctioned meet who is over 18 years of age, who had not completed the Athlete Protection Training (APT) by the date of the swim, will not be able to upload into SWIMS. These athletes will also be considered "not in good standing" and can be subject to fines under Wisconsin Swimming Policy 11.2.1.
- **RACING START CERTIFICATION:** Any swimmer entered in the meet, unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

- **ENTRY LIMIT**: Swimmers may compete in four (4) individual events.
- FEES: Individual events \$5.00 per event. \$4.00 LSC surcharge per swimmer entered in at least one individual event. \$6.00 facility surcharge. Deck entries shall be \$10.00/individual event. Please make checks payable to LAKE COUNTRY SWIM TEAM. Entry fees must accompany the official entry forms and are not refundable.
- ADMISSIONS: Spectators over 12 years old are \$5.00. Heat sheets will be available on our meet webpage prior to the meet.
- PARKING: Parking is available in the lot north of the facility and on nearby city streets.
- **RESULTS:** Results will be posted on <u>www.wisconsinswimming.org</u> and e-mailed to participating teams.
- **CONDUCT**: Each team is responsible for the conduct of its swimmers. In accordance with the Federal Video Voyeurism Prevention Act of 2004 – the use of camera phones or video recording devices in the locker rooms is prohibited. Except where venue facilities require otherwise, changing into or out of swimsuits other than in locker rooms or other designated areas is prohibited. Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.
