Eligibility

ATHLETE

YMCA Membership: An athlete must be a YMCA member in good standing who holds an annual, full privilege membership at the YMCA he/she represents for a period of at least 90 days prior to the first day of the meet. An athlete may have only represented that YMCA team in competition for a period of 90 days prior to the first day of the meet, excluding scholastic competition.

Amateur Status: An athlete may not have represented a college, university or other post-high school institution in any competition and may not have accepted pay or compensation for competing as a swimmer.

Unattached Athletes: There is no "unattached" status in YMCA Swimming.

Age: Athlete's age as of December 1, 2025.

- ★ An athlete 18 and older must have completed Child/Athlete Protection Training within the past 12 months.
- ★ Athletes age 12 and under may not compete in Technical Suits, as defined in the USA Swimming Rulebook

Times: There are no qualifying times for this meet.

Athletes With A Disability: Swimmers with a disability are welcome to enter this meet. Teams are required to inform the Officials and Meet Director of any special needs prior to the start of warm ups. Athletes shall present an [accommodation/modification form](#) to the Meet Director or Meet Referee to assist with the athlete's request.

COACH

Required Certifications: Coaches must hold current certifications in the following courses in order to receive a deck credential: Safety Training for Swim Coaches, Basic Life Support (Professional Rescuer CPR), First Aid, Principles of YMCA Competitive Swimming and Diving, and Athlete Protection Training.

Coach Registration: Each coach must have completed the annual YMCA on-line coach registration process. Coaches who are not registered and approved will not be permitted on deck.

Teams Without A Coach At The Meet: All athletes and teams must have at least one certified and credentialed YMCA coach designated as being responsible for their supervision during competition. When a YMCA team will not have a coach present, that YMCA may authorize an eligible coach from another YMCA attending the meet to be responsible for their athletes at the meet. The Meet Director and Meet Referee must be notified of this situation.

TEAM

Team Registration: Each team must have completed the annual YMCA on-line team registration and paid the annual registration fee.

Insurance: Each team that participates in the meet must have a current and correct Certificate of Liability Insurance, in effect through the last day of the meet.

Check-In Procedure

EVENT CHECK-IN: Positive check-in is required for the 1650 Freestyle and the 1000 Freestyle. Check-in on pool deck by the pool office. **Swimmers must provide their own counter and one timer for these events.**

COACHES MEETING: Friday PM Session at 4:45pm.

OFFICIALS AND TIMERS MEETING: Officials meeting 60 minutes prior to the start of each session. Timers meeting in the hallway 30 minutes prior to the start of each session.

Championship Procedures and Operations

CHAMPIONSHIP COMMITTEE: The Committee will consist of the Meet Director, Meet Referee, and YMCA Regional Representative.

RULES: The meet will run under Rules That Govern YMCA Competitive Sports, Swimming Addendum to the Rules That Govern YMCA Competitive Sports, USA-S Technical Rules.

MEET FORMAT: The meet will be swum using a Timed Finals format. Swimmer's age will be determined as of December 1, 2025.

EVENT SEEDING: Events will be seeded Slowest to Fastest. The Meet Referee/Administrative Official reserve the right to combine heats.

WARM-UP SAFETY PROCEDURES: Circle swimming only, entry into the water shall be feet first three-point entry for all competition, except in designated lanes and times. All entry to pools during open warm-up cool down periods must be from the start end. No snorkels, kickboards or other training devices are allowed during warm-ups. Teams should plan to do starts, sprint and pace work within their assigned warm-up time.

Swimmers without a coach present are to report to the Meet Director prior to warm-ups for lane assignment.

Outside of the scheduled warm up periods the pool may be open during breaks for circle swim only. Swimmers are to enter the pool feet first at the start end and are not allowed to use the blocks.

Coaches are responsible for the safety of their athletes and are expected to monitor them at all times during warm up sessions.

Teams will be assigned lanes for warm-ups. Warm-up assignments will be emailed to coaches, posted online and at the pool.

STARTS: 'Fly-over' starts will be used at this meet. All swimmers (except for backstroke starts) should remain in the water at the completion of their race until the next heat has begun.

SWIMS (USA-S): This meet has been approved by USA Swimming. Therefore, all individual times will be automatically submitted for entry into SWIMS as long as USA-S ID numbers have been included with your entry and the member is in good standing.

RESULTS: Any results displayed on the scoreboard are unofficial until final results are published. Results will be posted and emailed to participating teams.

PROTEST PROCEDURE: Protests may only be initiated by a person with standing, that is, a coach or YMCA supervisor whose team is competing in the meet. The Championship committee will arbitrate protests, eligibility issues, safety rules and other issues.

Protests against the judgment decisions of starters, stroke, turn, place and relay take-off judges can only be considered by the Referee and the Referee's decisions will be final USA-S Rule 102.23).

CONDUCT AND RESTRICTIONS: All coaches are responsible for the conduct of their swimmers and will see that their club has proper supervision at all times. Meet Marshals have the authority to remove any swimmer and/or spectator from the meet for any violation such as improper behavior, damage to property, etc.

- Deck access is limited to only registered and approved coaches, swimmers, and working officials.
- Changing into or out of swimsuits other than in locker rooms or other designated areas is not appropriate and is prohibited.
- Deck changes are prohibited.
- Glass, food, and chairs are not permitted on deck.
- The use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms.
- Photographs are not allowed to be taken behind the block during competition.
- Massage tables are not permitted.
- Individuals are responsible for the security of their personal belongings and are encouraged not to bring valuables to the meet venue and not to leave items unattended.
- Swimmers are not permitted in the spectator stands.
- Shaving is not permitted in any areas of the facility.

ENTRY LIMITS: Swimmers are limited to 5 individual events and 2 relays

TIMES: No Times (NT) are not allowed. Please estimate time if NT. Submit entry times in SCY.

ENTRY FEES:

- \$6.00 per individual events
- \$20.00 per relay
- \$12.00 per swimmer facility fee
- \$4.00 per swimmer WI Splash fee

DECK ENTRIES: There will be no deck entries at this meet.

ENTRY DEADLINE: Entries will be accepted beginning February 1, 2026 and must be received by Monday, March 2, 2026. Changes and time updates will be allowed through Monday, March 9, 2026.

ENTRY PROCEDURE: Entries must be in Hy-Tek format and emailed with a hard copy Entry Report to Ceri Beatty at wynsmeets@gmail.com. You will receive confirmation that your entries were received and accepted.

Awards and Recognition

AWARDS: Individual Events: 1st-16th place for age groups 8 & under, 9-10, 11-12, 13-14, and open.

Relays: 1st-3rd place for age groups 8 & under, 9-10, 11-12, 13-14, and open.

Open events will not be awarded by age group.

Team: 1st, 2nd, and 3rd place teams will receive a trophy. 16th place scoring will be used.

Time Trials

WHEN: Sunday following the conclusion of the AM Session, limited to 10 and under swimmers.

Sunday following the conclusion of the PM 2 Session, open to all swimmers.

FORMAT AND FEE: Time Trials are open only to athletes entered in the Championship meet.

- ★ An athlete may only swim the stroke being contested in a Time Trials event, e.g. an athlete may not swim backstroke in a breaststroke event in Time Trials.
- ★ Time Trial Fee is \$10 per individual event and \$25 per relay - must be received at sign up.
- ★ **SWIMMERS MUST PROVIDE ONE TIMER**
- ★ Only events offered during the meet are eligible for time trials. The 500, 1000, and 1650 Freestyle events will not be offered.

TIME TRIAL ENTRIES: Sign up for time trials will be available at the pool office. Swimmers must sign up and pay before the conclusion of the last session.

Spectators

ADMISSION FEE: Free. There is no charge for admission.

HEAT SHEETS: Heat Sheets will be posted on our team website, www.swimwyns.com, for you to view and print. There will be no Heat Sheets for sale at the meet.

CONCESSIONS: Friday's session will have limited concessions for purchase. Full concessions will be available for purchase Saturday and Sunday in the gym.

CONDUCT AND RESTRICTIONS:

- No Flash Photography at the start of competition races.
- No personal chairs are allowed in the spectator area
- Parents are responsible for the conduct of their children. Children are not allowed to roam the facility unattended.
- The use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms.
- Spectators are not permitted on deck
- No smoking, drugs, or alcohol are permitted in the swimming complex.

Liability, Safety, and Emergency Procedures

INSURANCE: Each Association participating in this meet must have insurance coverage for representative(s) including leadership and participants who will be in attendance for the period of the meet. Appendix 2 must be signed by each association participating in the meet.

LIABILITY LIMITS: In granting this approval it is understood and agreed that USA Swimming shall be free and held harmless from any liabilities or claims for damages arising by reason of injuries to anyone during the conduct of the event.

In granting the YMCA Sanction, it is understood and agreed that YMCA of the USA shall be free and held harmless from any liabilities or claims for damages arising by reason of injuries to anyone during the conduct of the meet.

In granting this approval, it is understood and agreed that USA Swimming and WI Swimming, Inc. shall be free from any liabilities or claims for damages arising by reason of injuries to anyone during the conduct of the event.

EMERGENCIES: The facility personnel will handle all emergencies at the meet. These individuals will provide CPR and first aid as needed and will ensure that individuals with serious injuries are transported immediately to the nearest hospital for further treatment.

Any coach, athlete or official who recognizes an emergency situation should immediately inform the facility's personnel and then make sure the vicinity of the emergency is clear for the emergency personnel to do their job.

UNACCOMPANIED ATHLETE: Each athlete must have a certified coach responsible for him/her while on the pool deck. The coach of the athlete must authorize in writing a coach from another team to represent their team and be responsible for the swimmer(s).

CONCUSSION AWARENESS: This meet will follow the YMCA of USA Concussion procedure. Anyone who observes or has knowledge of a potential head injury should immediately notify lifeguards and/or hired medical personnel. Once the injury report is completed, the lifeguard and/or hired medical personnel will notify the Event Staff, the athlete's coaching staff, and the Meet Director.

If a head injury occurs, the action plan below will be followed:

1. Athlete is removed immediately from participation by the Meet Director
2. Athlete must be evaluated by a licensed healthcare professional experienced in identifying and treating concussions. In addition, the athlete must be in compliance with the laws that are in effect within the jurisdiction where the meet is held.
3. The coaching staff will inform the athlete's parents or guardians about the possible concussion and give or send them the fact sheet on concussion.
4. The athlete will not be allowed back to warm-up or compete until a healthcare professional, experienced in evaluating concussions, determines that the athlete is symptom-free and is OK to return to participation.

DRONES: Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.

MAAP: All applicable adults participating or associated with the respective meet to which this information applies, acknowledges that they are an applicable adult, subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with the MAAPP policy is a condition of participation in the conduct of this competition. All athletes 18 years of age and older must have completed Athlete Protection Training prior to the entry deadline. Times achieved by an athlete member at a sanctioned meet who is over 18 years of age who had not completed the Athlete Protection Training (or whose APT training had expired) by the date of the swim, will not be able to be uploaded to SWIMS. These athletes will also be considered "not in good standing" and can be subject to fines under Wisconsin Swimming Policy 11.2.1.

IMAGE AUTHORIZATION: All participants agree to be filmed and photographed by the official photographer(s) and network(s) of Wisconsin Swimming and the meet host under the conditions authored by Wisconsin and USA Swimming, and allow event organizers the right to use names, pictures, likenesses, and biographical information before, during or after the period of participation in this Wisconsin Swimming competition to promote such competitions.

LIGHTNING POLICY: The National Lightning Safety Institute, National Athletic Trainers Association, American College of Emergency Physicians, USA Swimming, and YMCA of the USA all recommend indoor pools closed during an electrical storm. This policy may be followed at the meet depending on the severity of the storm.
