Tuition Scholarship Criteria and Application

The Cody Kountry Aquatics Team (CKATs) strongly believes that members of our community should have the opportunity to participate in our competitive swimming program regardless of financial status. These guidelines are intended to regulate the granting of financial assistance in the form of tuition fee reduction for individuals or families unable to afford the established monthly tuition fee.

An application for tuition scholarship (see reverse) must be completed by an individual, parent, or legal guardian over the age 18. The application will be reviewed during the next scheduled CKATs Board meeting. Criteria for consideration and potential Board approval include:

- <u>Tuition Fee Relief</u> This scholarship opportunity only applies to monthly tuition fees. All other participation costs such as USA Swimming registration, swim clinics, meet entry fees, equipment, and fundraising efforts are not applicable.
- <u>Availability</u> The CKATs organization is able to provide tuition relief only in accordance with
 the constraints of our current budget assumptions and projected revenue. The amount of
 available relief shall be proportionally distributed, based on need and number of awarded
 scholarships. If the maximum allocated scholarship funds are dispersed, then any remaining
 applicants or new applicants will be placed on a waiting list and re-evaluated once additional
 funds become available.
- <u>Annual Application</u> All potential scholarship recipients must apply annually. New swimmers and applicants who have fulfilled volunteer and/or fundraising commitments from the previous season will be given preference.
- Good Standing All scholarship recipients shall remain in good standing with the CKATs Coaches, Board, and USA Swimming. Unsportsmanlike conduct and/or conduct detrimental to the program by the swimmer, parent or guardian shall be grounds for scholarship termination.
- <u>Participation</u> All scholarship recipients shall attend at least 2/3 of the scheduled swim
 practices each month. Without extenuating circumstances, continued absences exceeding this
 minimum level of participation will result in elimination of tuition relief the following month.
- <u>Termination</u> The CKATs Board reserves the right to terminate any and all scholarship assistance at any point during the fiscal year. At least 30 days prior notification will be given to the recipient.

These guidelines are not all-inclusive and the CKATs Board reserves the right to cancel or refuse financial assistance. Should you have any questions, please contact a CKATs Board Member.
