



# 2024 YMSC Block Party Meet #1

## Hosted by Yosemite Marlins Swim Club

Sunday, July 1st, 2024

**Time:** Warm-up 7:30 a.m. – 8:45 a.m. Meet Start 9:00 a.m.

**Location:** **BAKER SWIM COMPLEX**

**Yosemite High School**, 50200 High School Road (Road 427), Oakhurst CA 93644. Hwy 99 to North on HWY 41 towards Yosemite National Park. Right on Road 426, Left at School Road, Right at Yosemite High School marquee.

**Facility:** 25m x 25yd pool with an additional small shallow warm-up area. The main competition pool has a minimum depth of 7 feet. The competition course has not been certified according to articles 104.2.2 C (4) USAS rules and regulations. There is a large deck area with some provided shade. Propane Heaters are prohibited.

**Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, restrooms or locker rooms. For Athlete Protection, Central California Swimming prohibits the use of photography and audio or visual recording devices, including a cell phone, behind the starting blocks throughout the meet. Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present. Deck changes are prohibited.**

**Format:** This is a timed-finals, short course yards, developmental age group meet. The competition may be modified to fit the “4-hour rule”. In order to achieve this, swimmers entered in 4 events may need to scratch one of their entered events. If this is necessary, teams will be notified within 72 hours of the meet start time to make those changes to their entry file.

**Warm-Up:** All warm-ups must be supervised by a USAS registered coach. If a swimmer does not have a USAS registered coach at the meet, he/she must report to the Meet Referee for lane and coach assignment. **Swimmers must use “3-point” entries when entering the water for warm-up and warm-down.**

**Rules:** Current USAS and CCS rules will apply. All swimmers must be 2024 USAS registered. This meet will be **PRE-SEEDED** with events seeded in heats running **FASTEST TO SLOWEST** according to submitted times. This is a **timed finals** swim meet. All swimmers must compete in their age group as determined by their age on the first day of the meet. **Swimmers may compete in up to 4 individual events per day.**

**TECHNICAL SUITS:** No technical suits shall be worn by any 12 & Under athlete member in competition at any sanctioned, approved, or observed CCS Meet. This includes any suit with bonded or taped seams regardless of its fabric or silhouette or any suit with woven fabric extending past the hips. (Note: Woven Fabric – A suit with woven fabric and sewn seams that does not extend below the hips is permitted. Knit fabric – A suit with knit fabric and sewn seams not extending below the knees is permitted).

**\*\*\*Events may be combined regardless of age or gender at the discretion of the Meet Referee\*\*\***

This meet will comply with “Block Party” sanctioning rules. This means that any current USA Swimming registered non-athlete member, such as a coach or parent, may fill the role of an official in running the meet. The times achieved by athletes will be entered into the SWIMS database and will be valid for any meet that is below a sectional level USA Swimming sanctioned meet.



**Unaccompanied  
Athlete:**

All USAS athlete members must be under the supervision of a USAS member coach during warm-up, competition, and warm-down. Swimmers who do not have a USAS registered coach at the swim meet should report to the Deck Referee for lane and coach assignment. It is the swimmers responsibility to make such arrangements prior to the start of the meet. Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

**Entries:**

All entries must be submitted electronically. To submit TeamUnify or Hy-Tek Team Manager entries, send the entry file and meet entry report as attachments to [tmkudela@gmail.com](mailto:tmkudela@gmail.com).

**Entry Fees:**

The fee to enter the meet is \$25 per swimmer. Full payment (single team check) for a team entry must be turned into the Clerk of Course before the start of the meet. If payment for any athlete is not accounted for before the start of the meet, that athlete will not be allowed to compete in the meet. **Entry fees are nonrefundable. Full payment must accompany all entries. There will be a bank fee for all returned checks.**

**Entry Deadline:**

**All Entries must be received by Friday, July 12<sup>th</sup> @ 11:59p.m.** No late entries will be accepted unless special circumstances are granted by the Meet Director.

**Eligibility:**

**All swimmers registered with USA Swimming for at least 24 hours before the beginning of this competition are eligible. Any athlete not registered by 12:00 p.m. on July 11<sup>th</sup> will be removed by the Admin Official.** All entrants' membership will be verified through the USA Swimming database. All registered swimmers are welcome regardless of team and/or LSC affiliation.

There will be heat winner awards.
