Two 50 M x 25 Y outdoor pools. The main competition pool has a uniform depth of 7 ft. One 8 to 10 lane will be available. The adjacent multi-purpose pool has an 18-lane 25 Y course for continuous warm up and warm down. The competition course has been certified in accordance with 104.2.2C(4). The copy of such certification is on file with USA Swimming.

Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present. Use of audio or visual recordings devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms. ***Deck changes are prohibited.*** For Athlete Protection, Central California Swimming prohibits the use of photography and audio or visual recording devices, including a cell phone, behind the starting blocks.

Format: This is a timed-finals, short course yards senior meet.

Warm-up: All USAS athlete members must be under the supervision of a USAS registered coach during warm-up. Dive and pace lanes will be assigned at the discretion of the Meet Referee. Warm-up procedures will be announced on a continuous basis by the Deck and Starter Referee. **Swimmers must use "3-point" entries when entering the water for warm-up and warm-down.**

Rules: Current USAS and CCS rules will apply. All swimmers must be 2025 or 2026 USAS registered. Verification of entered times should be available upon request of the Meet Referee.

This meet will be **PRE-SEEDED**. Events will be seeded in heats running **FASTEST TO SLOWEST** according to submitted times. This is a timed finals swim meet. **Swimmers may compete in up to 3 individual events and 2 relays.** Swimmers in events 4 & 4 (women's and men's 1000 yard free) and 25 & 26 (women's and men's 500 yard free) will supply their own person to count laps. Lap counting devices will be provided. Timing chairs will be assigned to each team.

Proof that all coach and official membership requirements are met, as of the date of competition, shall be presented upon request by the Meet Referee. Proof may be presented by membership card on the USAS App. All USAS athlete members must be under the supervision of a USAS member coach during warm up, competition and warm-down. Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water.

Entry Deadline: All Entries must be received by Friday, October 10, 2025, by 11:59 p.m.

Eligibility: All swimmers must be registered with USA Swimming by noon on Oct. 17 and members (attached or unattached) of CLOV, PASA, SCSC, or SMST. All entrants' membership will be verified through the USA Swimming database. **On-deck USAS membership registration is not allowed.**
