Location: Sierra Pacific High School: 1259 N 13th Ave Hanford, CA 93230

Facility: 22-lane, 25-yard heated outdoor pool with minimum depth of 7 FT and warm up/warm down area. The competition course has not been certified according to article 104.2.2C (4) USAS rules and regulations. The meet will run 8 (8) lanes for competition which will allow twelve (12) lanes for continuous warm-up and cool-down throughout the duration of the meet. No Propane heaters allowed. The Colorado timing system and scoreboard will be used. No RV overnight parking is permitted at the property of the Sierra Pacific High School. **Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms.** For Athlete Protection, Central California Swimming prohibits the use of photography and audio or visual recording devices, including a cell phone, behind the starting blocks throughout the meet. Changing into or out of swimsuits other than in locker rooms or other designated areas is prohibited; no deck changes.

Format: This is a timed-finals, short course yards meet.

Warm Up Rules: All warm-ups must be supervised by a USAS registered coach. Swimmers who do not have a USAS registered coach at the meet must report to the Meet or Deck Referee for lane and coach assignment. Dive and pace lanes will be assigned at the discretion of the Deck Referee and follow the CDC guidelines regarding social distancing. NO DIVING will be permitted. **All Swimmers must use a 3-point entry during warm-up and warm-down.**

Rules: Current USA Swimming and CCS Rules will apply. All swimmers must be registered with USA Swimming for 2025. Verification of entered times should be available upon request by the Meet Referee. Swimmers must compete in their age group. Age on the first day of the meet determines age throughout the competition. Events will be seeded according to submitted times.

Swimmers may compete in up to four (4) individual events. Swimmers **MUST** swim in one age group for the meet. Events may be combined regardless of age, gender, distance, or stroke at the discretion of the Meet Referee. This meet will be **PRE-SEEDED** by the admin official. There will be **NO CHECK-IN** required for any event. Heats will be run from fastest to slowest.

Per Central California Swimming policy, swimmers 12 years old and younger are not permitted to wear "Technical" suits at any CCS sanctioned or approved meets. For a detailed definition of the suits included

Unaccompanied Athlete: All USAS athlete members must be under the supervision of a USAS member coach during warm up, competition and warm-down. Swimmers who do not have a USAS registered coach at the swim meet should report to the Deck Referee for lane and coach assignment. It is the swimmer's responsibility to make such arrangements prior to the start of the meet. Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

Officials: All USAS Officials are welcome and encouraged to work this meet. As the number of certified officials allows, interested parents/trainees are also welcome to shadow working officials for education and/or mentoring. If an insufficient number of officials are present to allow for breaks, a ten-minute break will be taken every two hours. **ANY DISPUTED CALLS SHOULD FIRST CHANNEL THROUGH COACHES, THEN THE MEET REFEREE.**

Eligibility: All swimmers currently registered with USA Swimming for 2025 are eligible. On-deck USAS membership registration will not be allowed. Athletes not registered by noon on February 27, 2025, will be scratched from the meet.

Awards: There will be no awards given during the meet.

Entries: All entries must be submitted electronically. Team entries should be sent in a Hy-Tek CL2 entry file to the following email address: jcanales8@me.com **On-line entries are due by 11:59 PM on Sunday, Feb 23rd, 2025.** Deck entries will not be permitted. Receipt of entry will not be verified by phone.

Unattached swimmers affiliated with CCS may enter this meet on the CCS website, as long as the swimmer had registered on the CCS site for their USA Swimming membership. **CCS Outreach swimmers who are entered in this meet will have their fees deducted by the Host Club. The Home Club or responsible individual of the Outreach swimmer is responsible for communicating with the Host Team about their roster and fees that need to be deducted. Names of the athletes who are receiving the Outreach incentive may be kept confidential at the discretion of the athletes' Home Club.**

Entry fees: \$5.00 for each individual event plus \$15.00 per CCS swimmer surcharge or \$20 non-CCS Surcharge for athletes. **NO REFUNDS. RETURNED CHECKS WILL INCUR A SERVICE FEE.** Receipt of entry will not be verified by phone. **Please make all checks payable to Hanford Swim Club**
