Location: **Kingsburg High School Pool:** 1900 18th Ave, Kingsburg CA 93631

Directions from North or the South, take Highway 99 to Kingsburg, take exit 112 Sierra Street. Turn East and proceed approximately 0.3 miles to 18th Ave. High School is located at the corner of Sierra and 18th Avenue. Turn Left onto 18th Ave and proceed 0.1 miles then turn right onto the school entry. Pool is located on the North center side of the High School campus, parking lots are located either on the North or East side of campus.

Facility: A 10-lane, 25-yard heated outdoor pool with minimum depth of 7 FT in the warm up/warm down area. The competition course has not been certified according to article 104.2.2C (4) USAS rules and regulations. No Propane heaters. This meet will run eight (8) lanes for competition and 2 lanes for continuous warm-up and cool-down throughout the duration of the meet. The Colorado timing system and scoreboard will be used. No RV overnight parking is permitted on the property of the Kingsburg High School.

Use of audio or visual recording devices, including cell phones, is not permitted in changing areas, restrooms or locker rooms. For athlete protection, CCS prohibits the use of photography, and audio or visual recording devices, including a cell phone, behind the blocks throughout the meet. Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) at any time athletes, coaches, officials and/or spectators are present. No propane heaters are allowed in the facility. Deck changes are prohibited.

Format: This is a timed-finals, short course yards meet.

Warm Up Rules: All swimmers must enter the pool with a three-point entry during warm up and warm down. GENERAL WARM-UP PERIOD - The first 30 minutes of warm-up will be for general warm-up in all lanes. There will be no diving allowed during general warm-up. SPECIFIC WARM-UP PERIOD - The last 45 minutes of warm-up in the competition course will be allocated for specific warm-up in designated lanes. During the specific warm-up period, lanes 1 and 8 will be used for push pace work, lanes 2 and 7 for one-way dive sprints, and lanes 3, 4, 5 and 6 for general warm-up. Eight lanes in the warm-up course will be for general warm-up and swim down. No starting practice in that course. All USAS athlete members must be under the supervision of a USAS member coach during warm up, competition and warm-down.

Rules: Current USA Swimming and CCS Rules will apply. All swimmers must be currently registered with USA Swimming. USAS digital card is an acceptable form of proof. Verification of entered times should be available upon request of the Meet Referee. Swimmers must compete in their age group. Age on the first day of the meet determines age throughout the competition. Events will be seeded according to submitted times. This is a **timed finals** swim meet. **Swimmers may compete in up to four (4) individual events per day.** Events may be combined regardless of age, gender, distance, or stroke at the discretion of the Meet Referee. This meet will be **PRE-SEEDED** by the admin official. There will be **NO CHECK-IN** required for any event. Heats will be run fastest to slowest. Swimmers in the distance freestyles (500) must provide a timer, a lap counter and a lap counting device. The 500 freestyle events will be swum fastest to slowest.

ADDITIONAL RULE:

Per Central California Swimming policy, swimmers 12 years old and younger are not permitted to wear Technical suits at any CCS sanctioned or approved meets. Unaccompanied Athlete: All USAS athlete members must be under the supervision of a USAS member coach during warm up, competition and warm-down. Swimmers who do not have a USAS registered coach at the swim meet should report to the Deck Referee for lane and coach assignment. It is the swimmer's responsibility to make such arrangements prior to the start of the meet. Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

Officials: All USAS Officials are welcomed and encourage to work this meet. As the number of certified officials allows, interested parents/trainees are also welcome to shadow working officials for education and/or mentoring. If an insufficient number of officials are present to allow for rest breaks, a ten-minute break will be taken every two hours. Events may be combined regardless of age and gender at the discretion of the meet referee.

Eligibility: All swimmers must be USAS registered on November 6th by noon, per the 36-hour rule. Athletes not registered by the deadline will be scratched.

Awards: No awards will be given during the meet.

Entries: Team entries should be sent in a Hy-Tek CL2 electronic entry file to the following email address: tritonswim.treasurer@gmail.com. Unattached swimmers affiliated with CCS may enter this meet on the CCS website, as long as the swimmer had registered on the CCS site for their USA Swimming membership. **On-line entries are due by 11:59 PM Monday, November 3, 2025. Late entries will be accepted until 11:59 PM Wednesday, November 5, 2025 with \$10 late fee per swimmer. Team entries have the same deadlines as individual events. Deck entries will not be permitted.**

CCS Outreach swimmers who are entered into this meet will have their fees deducted by the Host Club. The Home Club or responsible individual of the Outreach Swimmer is responsible for communicating with the Host Team of their roster and fees that need to be deducted. Names of the athletes who are receiving the Outreach

incentive may be kept confidential at the discretion of the athletes' Home Club.

\$4.00 per individual event; \$15.00 surcharge per CCS swimmer or \$20 per non-CCS swimmer. Full payment (single team check) for an email entry must be postmarked within 48 hours of the email entry (see address below).
