- Don Hougardy: financial reports are on file. Job split into two with Don as financial vice chair and Todd Stafek as treasurer is working well. Todd writes the checks and Don reconciles the bank account each month. IES is being audited by two different groups (1) Whitworth college audit group looks over our records (2) as does a firm through USA Swimming. Finally, financial growth has been great. We were able to give officials a small stipend to help out at Short Course Zones. Investments are nothing to brag about, but first quarter of 2023, have gained 4% since the end of the year. Invest in the future with the purchase of Omega starting system. Familiarity for officials and swimmers who attend bigger meets. We got a greatly discounted price for them. IES financials are strong and we have been able to do a lot of things. We haven't' had to tap into savings in Don's time as Treasurer or Finance Vice Chair.
- Russ Whitaker: Junior Champs allowing 15-19 age group to compete. Short course champs swam in the morning and it was good for them. IES records getting them posted to the IES website. USA Swimming is hosting a regional coaches clinic August 18-20th in Pullman, geared towards age group coaches and mental health. It would be great to have IES coaches well represented at this clinic
