Staff Report: Jody Broyles

- IES Club Registration status for 2024 All Clubs registered for 2024
- IES Communications Specialist Club updates have had communication with 6 teams, spoken with 4 via phone/Zoom, have a meeting with La Grande tomorrow morning, one team responded, but chose not to give feedback.
 - Ellensburg: Large team for a small community with over 100 registered athletes. Have a great relationship with CWU, recruiting has been mostly by word of mouth. Struggles: Assistant coach turnover, finding coaches who can work enough hours, pool shutdowns due to construction and maintenance. Where IES can help: Sponsor coach/swimmer education clinics, create more opportunities for IES coaches to meet and discuss a variety of topics. Finally, they would love any input on ways to get the school district to allow boys swimming. High school boys have no options other than club at the moment. School district sites Title IX as the reason.
 - O YYST: Small team limited by staffing, funding, and strong AAU summer swim league. Would love suggestions for helping grow the team. Don't currently use the long course pool in Toppenish.
 - Sandpoint: No longer a YMCA team, became a board ran team at the beginning of the year. There are over 50 registered athletes, which is great for the community size. YMCA swim lessons is a great feeder program for the team. The board has plans to run swim meets in the future. Struggles: Funding to support more than one coach. Emily is thankful for all the mentorship she is getting from IES staff and coaches.
 - O Velocity: Lots of team growth this year, especially in the 10 and under group. Great pre-team feeder program and added a Master's program this year. Struggles: coach turnover the last few years, inability to utilize Wenatchee High School pool post-COVID (lifeguarding shortages). Coach Westley would love to see an IES sponsored weekend swim clinic in the fall, similar to what Oregon Swimming does.
- Athlete Council: only 6 athlete council representatives so far. The deadline was extended to today. Coaches please work on this. First athlete council meeting next Monday night

- Per Todd: 5 Senior Zone Athletes who have not paid their entry fees from 2023 LC Zones. What recourse do we have? One more reminder will be sent out.
