#### **Old Business:**

## **General Chair Report:** Jeff Sutton

- Jr Champs LCN request to sell heat sheets/meet mobile
  - Russell motions that we table this until entries close and see if there are fewer swimmers than last year and can consider adding a heat sheet fee if necessary to help support the viability of the hosting team.
    - Motion made, seconded, and passed
- Approved Grievance recommendations from grievance committee
  - We will address this after the holidays.
- Approve P&P section for Admin Review
  - We do not currently have an administrative review policy. Jeff would like to adopt the policy as sent out. The administrative board of review is appointed by the general chair. The board cannot include any IES HOD members. It would be 3 to 5 people. An administrative review board is written into the bylaws, but nothing has been put into policy/practice. This is tabled until the January meeting.
- Verify any college swimmer exceptions for Champ meets (Jr, SC & LC)
  - Should collegiate athletes be allowed to swim at our championship meets. No collegiate athletes allowed in Junior Champs for any reason. For the other two meets, collegiate athletes may participate in prelims, but not finals. Jody will work with Tia on the language for the 2024 meets.
- Explore purchase of backstroke wedges (Finis @ \$200 each) was the suggestion as they
  are cheaper and more versatile
  - o Tabled for January
- Approve Job Description of Championship Coordinator
  - Still a work in progress

- Seasonal Team request
  - o In the past two months, Yakima and Spokane have had two requests for year round clubs.
  - Tri Cities has had a seasonal request and Pendleton has asked about being a seasonal club. We cannot deny access to full-blown clubs, but we have some leeway on how we handle seasonal clubs. Russell would like to see any incoming club have to go through the whole process. Seasonal clubs can stay AAU. They can operate seasonally, but must be fully registered and go through all of the steps.

- Review and approve updated language to include in Meet Announcements regarding cell phones behind the blocks
  - No cameras (including cell phone cameras) or other recording devices are allowed behind
    - the blocks at any time. If you see a phone/camera you should:
      o Inform the camera/phone user of the policy and request that it be put
    - o Inform the Meet Director or Facility Manager of the camera use. Do this even if the camera user puts the camera/phone away when asked.
    - o Exception: a credentialed, official Meet Photographer identified by the Meet Director, stated in the Meet Announcement and available to all athletes is allowed behind the blocks after the start of the race.
