Athlete Rep Report: Ava Swigart, Lindsay Sutton, Elle Krug

- Ava presented what she learned at the Annual Business Meeting including what she learned at the DEI meeting. DEI/CAP Connect, Accept, Provide. How to make swimming more affordable for everyone offer scholarships at the club and LSC level. Club level/Coach owned teams not always able to provide scholarships, but it could be accomplished at the LSC level and something our LSC could look into.
- Athlete Rep portion of the ABM: Connecting with athlete leadership from different LSCs. IES reps will be meeting with reps from New England and San Diego in December to check-in with each other and see how how things are going and what they have been able to implement what they learned at the ABM in their own LSCs
- At the IES Athlete Council level, the council has voted on the three sub-committees that they would like formed; Mentorship, College Recruiting, and Technique

New Business:

• Alex Herr: Open water swimming – Open water zones and open water nationals meets. We had 4 swimmers at open water zones in 2024 and two swimmers at nationals. Currently there is no information on the IES website about open water swimming. Our open water zones athletes do not receive equitable treatment as our pool-side zones athletes (all-star teams, swim bags, caps, t-shirts, etc). We celebrate our pool-side zones swimmers, but tend to forget about our open water swimmers. How do we fix that? How do we grow enthusiasm and excitement for open water swimming?

Per Todd (as Treasurer): Open Water Nationals falls into Senior budget and money to support this comes out of our Nationals budget and it is supported by the LSC

Per Jody: If we are strictly speaking about merch (caps, bags, etc) that is something that parents pay for at all Zones meets anyway. It just takes planning.

Per Jody: To grow enthusiasm and excitement for open-water swimming, it really starts with our coaches and the suggestion is to add the topic to the coaches meeting ahead of the HOD meeting in a couple of weeks.
