# NATHAN ADRIAN



**Nathan Adrian** is one of the premier sprint swimmers in the world. The owner of eight Olympic medals (5g, 1s, 2b), Nathan was Co-Captain of the 2016 Olympic Swimming Team and was one of the top academic sportsman during his collegiate tenure. Nathan continues to be successful both as an athlete and a leader to this day.

#### Olympic Experience:

Three-time Olympian (2008, 2012, 2016); Eight-time Olympic medalist (5 golds, 1 silver, 2 bronze) Rio 2016, gold (4x100 medley relay, 4x100 free); bronze (100 free, 50 free) London 2012, gold (100 free, 4x100 medley); silver (4x100 free) Beijing 2008, gold (4x100 free)

# **JOSH DAVIS**



**Josh Davis**, despite a late start in 1996, made history by becoming the only man in any sport from any nation at the Atlanta Olympic Games to win 3 gold medals. With a passion for representing our country, Josh returned to the Olympics in Sydney in 2000 where he was elected Captain of the USA Men's swim team. He speaks to groups all over the country on how perseverance, pursuing excellence, and attitude can turn the ordinary into extraordinary. Josh also hosts a popular podcast called Ultimate Swimmer that has interviewed hundreds of the top swimmers in the world.

Two-time Olympian (1996, 2000): Five-time Olympic medalist (3 golds, 2 silver) Atlanta 1996, gold (4x100 Freestyle relay, 4x100 medley relay, 4x200 Freestyle relay) Sydney 2000, silver (4x100 Freestyle relay, 4x200 Freestyle relay)

# **KEVIN ZACHER**



**Kevin Zacher** is the current head coach/CEO of the Santa Clara Swim Club. Coach Kevin was born and grew up in Southern Oregon. He swam competitively growing up and continued swimming at lowa State University, setting the school record in the 400 IM and being voted team captain his senior year. After graduating from ISU with a degree in Finance, he started coaching at King Aquatic Club in Washington. He also served as the Head Coach of Thomas Jefferson High School for several years. After coaching at King Aquatic Club for five years, Kevin moved to Scottsdale, AZ, and began coaching with Scottsdale Aquatic Club, becoming the Head Coach in 2007. In 2021, Kevin accepted the position of Head Coach at the Santa Clara Swim Club. Coach Kevin is married to Tere, a renowned Sports Psychologist, and Life Coach. They have a daughter, Kori, who currently attends Archbishop Mitty High School and works with the SCSC Learn-To-Swim program.

# KRISTIN HILL



**Kristin Hill** began coaching the Boise State Swimming and Diving program in 2006. Over her nine years, the program won 2 WAC and 2 Mountain West Championships and sent swimmers to the NCAA Championship 5 years in a row. She resigned from the program in 2015 to spend more time with her family. She is currently the Director of Academic, College, and Career Advising for Cole Valley Christian School, in addition to Senior Coach for Boise Swim Club and Meridian High School.

Coach Kristin grew up swimming for the Mission Viejo Nadadores in California and the Bellevue Club and Chinook Aquatic Club in Washington. She swam at the University of Puget Sound where she was an Academic All American and an NAIA All American, specializing in the 50, 100, and 200 freestyle

# **RON VAN POOL**



**Ron Van Pool** has been involved with USA Swimming for over 30 years, serving as an official at all levels from age group meets to being the Meet Referee for Sections, Grand Prix, Arena Pro, Winter Nationals, Masters Nationals, Open Water Nationals, Pac 12 Championships, NCAA Championships, and World Championship Trials Meets. He has officiated at every Olympic Team Trial since 1992 and continues to be active at both the LSC and the national level.

Van Pool has also served USA Swimming in many leadership roles including International Relations (Chair), Rules and Regulations Committee (Member, Program Operations (Vice-President), and Governance Review Task Force (Chair), and most recently, the USA Swimming CEO Search (Chair). He has also served on several FINA committees. He has also served as the USA Swimming representative to the USOC and the National Governing Body Council for over ten years. He reached the pinnacle of offices in 2002 when he was elected President of USA Swimming, a role he held through 2006.

# **ROBERT BROYLES**



**Robert Broyles** is on the FINA international officials list and has served as a national meet referee for Nationals, Jr Nationals, and the Arena Pro Swim Series. He served as a meet referee in 2019 for the ISL and has worked every USA Swimming Trial meet since 2008. He was the Western Zone Official's Chair from 2005 to 2009 and has been a zone and sectional meet referee.

Robert has served as USA Swimming's Administration Vice-Chair on the Board of Directors since 2014 and oversees the Awards, Convention Education, Credentials/Elections, Operational Risk, Registration/Membership, and Rules committees. Broyles previously served on the Board as the Western Zone non-coach Director from 2009–2014 and was a member of the Governance committee in 2014.

Broyles is a lifetime member of the Inland Empire LSC, where he served three terms as General Chair and was presented with the Conoco Phillips Outstanding Service Award in 2011. He was also chair of the Western Region Section from 2012 through 2016.
