## **SECTION A**

## WESTERN ZONE SWIMMING ADMINISTRATIVE PROCEDURES

#### ARTICLE 1 – RESPONSIBILITIES, ZONE ALIGNMENT and SECTIONS

- 1.1 RESPONSIBILITIES The responsibilities of the Western Zone shall be:
  - .1 To aid and assist in the distribution of information from USA Swimming to the LSCs within the Western Zone.
  - .2 To promote, develop, and assist in the conduct of swimming in the United States within the Western Zone.
  - .3 Per <u>USA Swimming Rules and Regulations</u>, at least one annual Age Group Zone Swimming Championship shall be offered and awarded by the Zone, recommended to be long course if only one is offered. The Zone has the responsibility to prescribe the format and conduct of that competition.
  - .4 Per <u>USA Swimming Rules and Regulations</u>, at least one annual Senior Zone Swimming Championship may be offered and awarded by the Zone at the end of every summer. The Zone has the responsibility to prescribe the format and conduct of that competition.
  - .5 Per <u>USA Swimming Rules and Regulations</u>, an Open Water Swimming Championship may be offered and awarded by the Zone. The Zone has the responsibility to prescribe the format and conduct of that competition.
- 2ONE ALIGNMENT The LSCs of the Western Zone are Alaska, Arizona, Central California, Colorado, Hawaii, Inland Empire, Montana, New Mexico, Oregon, Pacific, Pacific Northwest, San Diego Imperial, Sierra Nevada, Snake River, Southern California, Utah, and Wyoming.
- 1.3 SECTIONS Section alignment shall be:
  - .1 BLUE Alaska, Arizona, Colorado, Hawaii, Inland Empire, Montana, New Mexico, Oregon, Pacific Northwest, Snake River, Utah, Wyoming. For administrative purposes, the BLUE Section may also use the designation of Western Region Section (WRS) and may be divided into two sub-regions, with the following designations:
    - A. Northwest (NW): Alaska, Hawaii, Inland Empire, Montana, Oregon, Pacific Northwest, Snake River, Wyoming
    - B. Four Corners (4C): Arizona, Colorado, New Mexico, Utah
  - .2 GOLD Central California, Pacific, San Diego Imperial, Sierra Nevada, Southern California.

    For administrative purposes, the GOLD Section may also use the designation of California/Nevada (CA/NV).

#### ARTICLE 2 – REPRESENTATION and MANAGEMENT

- 2.1 REPRESENTATION The Western Zone shall consist of the following LSC representations:
  - .1 In-Person: Each LSC in the Western Zone may send one or more delegates to the Annual House of Delegates (HOD) Meeting, or to any Special Meeting of the Western Zone for the purpose of casting its five (5) votes.
    - A. Each LSC General Chair shall designate up to five (5) voting members. Each voting member shall have one vote.
    - B. Requirement: Each LSC shall designate an Athlete Representative to cast one (1) of its five (5) votes. If no Athlete Representative is present, the LSC shall cast a maximum of four (4) votes.
  - .2 Electronic Vote: If unable to hold an in-person meeting, voting on any action which may be taken at any regular or special meetings of the Western Zone, will be taken by (1) email or (2) other electronic transmission, with a ballot distributed to every delegate entitled to vote on the matter. The ballot shall set forth the name of each candidate or proposed action. Action by ballot shall be valid only when the number of votes cast in favor of the proposed action within the time specified, constitutes a majority of the votes cast.
    - A. Each LSC shall furnish the Western Zone Secretary/Treasurer the names and e-mail addresses of the five (5) representatives to act for the LSC in electronic voting
    - B. If necessary, the LSC General Chair shall change the representative(s) by written notice to the Western Zone Secretary/Treasurer.
  - .3 Individuals not represented in 2.1.1 who attend the Annual Meeting, or any Special Meeting of the Western Zone, shall have a voice but not a vote.
- 2.2 MANAGEMENT Management of the Western Zone shall be as follows:
  - .1 General: Management of the affairs of the Western Zone is the responsibility of the LSC representatives as defined in 2.1.1 of these Administrative Procedures, subject to any limitation of the current <u>USA</u> Swimming Rules and Regulations.
  - .2 Financial:
    - A. Income derived from the promotion of swimming by members of USA Swimming, on behalf of the Western Zone, must be used in further promotion of swimming for the general welfare of the Western Zone as a whole. Two exceptions are: 1) income derived by the hosts of the Western Zone Swimming Championships and 2) any DEI-generated income.
  - .3 Fiscal Year: The fiscal year of the Western Zone shall be that adopted by USA Swimming.
  - .4 Dissolution: Upon dissolution of the Western Zone, all assets shall be distributed to the member LSCs in equal shares, or upon a majority vote of the LSC representatives, to USA Swimming. All funds reside with USA Swimming and will be sent from USA Swimming.

#### ARTICLE 3 – WESTERN ZONE BOARD of ELECTED OFFICERS

3.1 WESTERN ZONE BOARD of ELECTED OFFICERS - The Western Zone Board shall consist of the following elected

#### officers:

- .1 Western Zone Director (coach member) elected in even-numbered years.
- .2 Western Zone Director (non-coach member) elected in odd-numbered years.
- .3 Western Zone Swimming Championship Coordinator elected in odd-numbered years.
- .4 Western Zone Secretary / Treasurer elected in even-numbered years.
- .5 Western Zone Athlete Director elected in even-numbered years by one athlete from each represented LSC.
- .6 Western Zone Junior Athlete Representative elected in even-numbered years by one athlete from each represented LSC.

#### 3.2 ELIGIBILITY AND VOTING of ELECTED OFFICERS

- .1 Only current members in good standing of USA Swimming and a Western Zone LSC are eligible for election as a Western Zone Officer.
- .2 Elected officers shall have voice but not vote, unless designated to vote by an LSC, or as specifically designated to vote in another section of these Administrative Procedures.

#### 3.3 LIMITATION OF TERMS

- .1 **Athletes:** The Western Zone Athlete Director and the Western Zone Junior Athlete Representative shall be limited to one two-year term in the original position to which they are elected. Athletes may be elected to an additional two-year term in the athlete position which they have not previously held.
- .2 **Non-Athletes**: No person may be elected by the Western Zone HOD or appointed by the Western Zone Directors to more than two 2-year terms, except for the Secretary/Treasurer and the Historian, to whom no term limit shall apply.
- 3.4 VACANCIES A vacancy shall be filled by appointment by the remaining Zone Board members until the next Annual Meeting of the Western Zone. A vacancy of a Zone Director shall be filled in accordance with current <u>USA Swimming</u> Rules and Regulations
- 3.5 CONFLICT OF INTEREST All elected Officers will submit a signed copy of the Western Zone Conflict of Interest form to the Western Zone Secretary/Treasurer at the beginning of their term.

#### 3.6 DUTIES OF ELECTED OFFICERS

#### .1 Western Zone Directors

#### A. General Duties

- (1) Each Western Zone Director shall be elected for a two-year term.
- (2) The Western Zone Directors shall not be members of the same LSC.
- (3) One Western Zone Director shall be a non-athlete, non-coach member and one Western Zone Director shall be a non-athlete, coach member as specified in USA Swimming Bylaws.
- (4) The Western Zone Director in the second year of their term shall be the Senior Zone Director, with specific duties as described below, in 3.5.1.B.
- (5) The Western Zone Director in the first year of their term shall be the Junior Zone Director, with specific duties as described below, in 3.5.1.C.
- (6) The Western Zone Directors shall have the authority to enforce these Administrative Procedures and the Western Zone Swimming Championship Regulations in accordance with current <u>USA</u>

#### Swimming Rules and Regulations.

#### B. Senior Zone Director

- (1) Shall perform all duties set forth by <u>USA Swimming Rules and Regulations</u>.
- (2) Shall be an active member of the Zone Directors Council.
- (3) Shall chair all Western Zone meetings, unless specifically noted otherwise in these Administrative Procedures.
- (4) Shall serve as a consultant in the management of the Western Zone Swimming Championships and should attend the Western Zone Swimming Championships.
- (5) Shall contribute content to the Western Zone website.
- (6) Shall be notified with the Junior Western Zone Director of the competition sites selected by each Section.
- (7) Shall in cooperation with the Junior Western Zone Director support the governance of each Section by the designated Section Board.
- (8) If the Senior Zone Director attends the Championships, they shall be reimbursed according to Article 8 of these Administrative Policies.
- (9) At least one Western Zone Director should attend the General Meeting held before the competition of each Western Zone Swimming Championship and remain in attendance for the duration of the meet.
- (10) Shall attend the Western Zone Annual Business Meeting. If travel is required, reimbursement will apply according to Article 8 of these Administrative Policies.
- (11) At least one Western Zone Director should attend the USA Swimming Zone Workshops. If travel is required, reimbursement will apply according to Article 8 of these Administrative Policies.

#### C. Junior Zone Director

- (1) Shall perform all duties set forth by <u>USA Swimming Rules and Regulations</u>.
- (2) Shall be an active member of the Zone Directors Council.
- (3) In the absence of the Senior Director, shall chair the Annual Western Zone meeting, the Western Zone Technical Planning Meeting, and any Special Meetings of the Western Zone.
- (4) Shall serve as a consultant in the management of the Western Zone Swimming Championships and should attend the Western Zone Swimming Championships.
- (5) Shall contribute content to the Western Zone website.
- (6) Shall be notified with the Senior Western Zone Director of the competition sites selected by each Section.
- (7) Shall in cooperation with the Senior Western Zone Director support the governance of each Section by the designated Section Board.
- (8) If the Junior Zone Director attends the Championships, they shall be reimbursed according to Article 8 of these Administrative Policies.
- (9) At least one Western Zone Director should attend the General Meeting held before the competition of each Western Zone Swimming Championship and remain in attendance for the duration of the meet.
- (10) Shall attend the Western Zone Annual Business Meeting. If travel is required, reimbursement will apply according to Article 8 of these Administrative Policies.
- (11) At least one Western Zone Director should attend the USA Swimming Zone Workshops. If travel

is required, reimbursement will apply according to Article 8 of these Administrative Policies.

#### .2 Western Zone Swimming Championship Coordinator

- A. Shall serve as Coordinator for the Senior and Age Group Western Zone Swimming Championships.
- B. Shall provide background information, including the history of the meet, to the host for use in promoting and publicizing the meet to the local merchants and media.
- C. Shall provide the host LSC of the Age Group Championship Meet with current National Age Group Records, National Age Group Recognition Times and Western Zone Swimming Championship Records.
- D. Shall approve or establish, in conjunction with the Western Zone Directors and the Senior Championship Coaches Advisory Committee, the Western Zone Senior Championship Regulations, Section B of these Administrative Procedures.
- E. Shall approve or establish, in conjunction with the Western Zone Directors, the Age Group Championship Coaches Advisory Committee, and the HOD-approved recommendations of the Age Group Zone Business Meeting, the Western Zone Age Group Championship Regulations, Section C of these Administrative Procedures.
- F. Prepare and/or review the Western Zone Senior and Age Group Championships meet databases, including qualifying time standards, records, and event fees.
- G. At the request of the Zone Directors, approximately three (3) months prior to the meets, may visit the site(s) of the Senior and Age Group Championships to consult with the host(s) regarding preparations for the meet.
  - a. A Western Zone Director or other designee may be named for this visit.
  - b. The individual conducting the site visit shall be reimbursed according to Article 8 of these Administrative Policies.
- H. At the request of the Zone Directors, shall attend the Western Zone Senior and Age Group Swimming Championships. If travel is required, reimbursement will apply according to Article 8 of these Administrative Policies.
- I. Shall assist prospective meet hosts in preparing and submitting meet bids to the Western Zone Annual Meeting for consideration and vote by the HOD.
- J. Shall contribute content to the Western Zone website.
- K. Shall attend the Western Zone Annual Business Meeting. If travel is required, reimbursement will apply according to Article 8 of these Administrative Policies.
- L. At the request of the Zone Directors, should attend the USA Swimming Zone Workshops. If travel is required, reimbursement will apply according to Article 8 of these Administrative Policies.

#### .3 Western Zone Secretary / Treasurer

- A. Shall be responsible for record keeping and minutes of all meetings, and official correspondence.
- B. Shall issue notices of all meetings.
- C. Shall receive all moneys and send to USA Swimming for the Western Zone account. Shall advise USA Swimming with the consent of the directors or committee concerned, how to disburse as required by the Western Zone, shall maintain financial records for the Western Zone.
- D. Shall prepare, edit and distribute the annual budget and financial reports for review and approval by the Zone Directors.
- E. Shall contribute content to the Western Zone website.

- F. Shall prepare, edit and distribute reports as may be required by USA Swimming.
- G. Shall attend the Western Zone Annual Business Meeting. If travel is required, reimbursement will apply according to Article 8 of these Administrative Policies.
- H. At the request of the Zone Directors, should attend the USA Swimming Zone Workshops. If travel is required, reimbursement will apply according to Article 8 of these Administrative Policies.

#### .4 Western Zone Athlete Director

- A. Shall chair all Western Zone athlete meetings.
- B. Shall be an active member of the Zone Directors Council.
- C. Shall develop and maintain a communication tree of the Western Zone LSC Athlete Representatives to:
  - (1) Distribute information.
  - (2) Gather information and input.
- D. Shall serve as a consultant in the affairs of the athletes for the Western Zone Age Group Swimming Championship and should attend the Western Zone Age Group Swimming Championship. If the Western Zone Athlete Director attends the Western Zone Age Group Swimming Championship as a non-competitor, they shall be reimbursed according to Article 8 of these Administrative Policies.
- E. Shall contribute content to the Western Zone website.
- F. Shall attend the Western Zone Annual Business Meeting. If travel is required, reimbursement will apply according to Article 8 of these Administrative Policies.
- G. At the request of the Zone Directors, should attend the USA Swimming Zone Workshops. If travel is required, reimbursement will apply according to Article 8 of these Administrative Policies.

#### .5 Western Zone Junior Athlete Representative

- A. In the absence of the Western Zone Athlete Director, shall chair the Western Zone athlete meetings.
- B. Shall be an active member of the Zone Directors Council
- C. Shall assist the Western Zone Athlete Director in developing and maintaining a communication tree of the Western Zone LSC Athlete Representatives to:
  - (1) Distribute information.
  - (2) Gather information and input.
- D. Shall serve as a consultant in the affairs of the athletes for the Western Zone Age Group Swimming Championship and should attend the Western Zone Age Group Swimming Championship if the Western Zone Athlete Director is not able to do so. If the Junior Athlete Representative attends the Western Zone Age Group Swimming Championship as a non-competitor, they shall be reimbursed according to Article 8 of these Administrative Policies.
- D. Should contribute content to the Western Zone website.
- E. Shall attend the Western Zone Annual Business Meeting. If travel is required, reimbursement will apply according to Article 8 of these Administrative Policies.
- G. At the request of the Zone Directors, should attend the USA Swimming Zone Workshops. If travel is required, reimbursement will apply according to Article 8 of these Administrative Policies.
- .6 Western Zone Athlete Representative: Ex-Officio The immediate past Western Zone Athlete Director shall serve as an ex-officio member of the Western Zone Board, with voice but no vote.

#### ARTICLE 4 – WESTERN ZONE APPOINTED COORDINATORS

#### 4.1 APPOINTED COORDINATORS

- .1 The following Western Zone Coordinators shall be appointed in EVEN numbered years by the Western Zone Directors:
  - A. Disability Swimming Coordinator
  - B. Historian
- .2 The following Western Zone Coordinators shall be appointed in ODD numbered years by the Western Zone Directors:
  - A. Officials Coordinator
    - (1) Shall be appointed by the Western Zone Directors in consultation with the National Officials Chair
    - (2) Shall be a certified N3 National Official
  - B. Open Water Coordinator
- .3 The following Western Zone Coordinators shall be appointed by USA Swimming Staff:
  - A. Diversity, Equity, and Inclusion Coordinator
  - B. Safe Sport Coordinator

#### 4.2 ELIGIBILITY AND VOTING of APPOINTED COORDINATORS

- .1 Only current members in good standing of USA Swimming and a Western Zone LSC are eligible for appointment as a Western Zone Coordinator.
- .2 In business matters of the Western Zone, appointed positions shall have voice but not vote, unless designated to vote by an LSC, or as specifically designated to vote in another section of these Administrative Procedures.
- 4.3 VACANCIES A vacancy shall be filled by appointment by the remaining Zone Board members until the next Annual Meeting of the Western Zone.
- 4.4 CONFLICT OF INTEREST All appointed Coordinators will submit a signed copy of the Western Zone Conflict of Interest form to the Western Zone Secretary/Treasurer at the beginning of their appointed term.

#### 4.5 DUTIES OF APPOINTED COORDINATORS

#### .1 Disability Swimming Coordinator

- A. Shall maintain communication with and distribute information to the LSC Disability Swimming Chairs within the Western Zone.
- B. Shall contribute content to the Western Zone website.
- C. At the request of the Zone Directors, may attend the USA Swimming Zone Workshops. If travel is required, reimbursement will apply according to Article 8 of these Administrative Policies.

#### .2 Historian

- A. Shall maintain the history portion of the Western Zone Manual.
- B. Shall contribute content to the Western Zone website.
- C. At the request of the Zone Directors, may attend the USA Swimming Zone Workshops. If travel is required, reimbursement will apply according to Article 8 of these Administrative Policies.

#### .3 Officials Coordinator

- A. Shall maintain communication with and distribute information to the LSC Officials Chairs.
- B. Shall assist the Meet Referee and the LSC Officials Chair in the selection of officials for the Western Zone Swimming Championships.
- C. The Western Zone Senior and Age Group Championship meets should be designated as National Officials Qualifying Meets (OQM). The Western Zone Officials Coordinator shall assist the host LSC Officials Chair in obtaining the OQM approval.
- D. Shall administer the Western Zone Officials Assistance Fund.
- E. Whenever possible, attend the Western Zone Swimming Championships to assist in officiating and to further communication and education of officials.
- F. Shall contribute content to the Western Zone website.
- G. Shall assist the Host Team and LSC Officials Chair in the selection of the Meet Referee for each Sectional Championship within the Western Zone that is to offer National Championship officiating opportunities.
- H. At the request of the Zone Directors, may attend the USA Swimming Zone Workshops. If travel is required, reimbursement will apply according to Article 8 of these Administrative Policies.

#### .4 Open Water Coordinator

- A. Shall serve as Coordinator for the Western Zone Open Water Championships.
- B. Shall provide background information, including the history of the meet, to the host for use in promoting and publicizing the meet to the local merchants and media.
- C. Shall provide the host of the Open Water Championship Meet with current National Open Water Records and Western Zone Open Water Championship Records.
- D. Shall approve or establish, in conjunction with the Western Zone Directors and the Open Water Coaches Advisory Committee, the Western Zone Open Water Championship Regulations, Article (TBD) of these Administrative Procedures.
- E. Prepare and/or review the Open Water Championships meet database, including qualifying time standards, records, and event fees.
- F. Shall contribute content to the Western Zone website.
- G. At the request of the Zone Directors, approximately three (3) months prior to the meet, may visit the site of the Open Water Championships to consult with the host(s) regarding preparations for the meet.
  - a. A Western Zone Director or other designee may be named for this visit.
  - b. The individual conducting the site visit shall be reimbursed according to Article 8 of these Administrative Policies.
- H. Shall attend the Western Zone Open Water Championships. If travel is required, reimbursement shall be the responsibility of the host of the Open Water Championships.
- I. Assist prospective future meet hosts in preparing and submitting meet bids to the Annual Meeting for consideration and vote by the HOD.
- Shall attend the Western Zone Annual Business Meeting. If travel is required, reimbursement will
  apply according to Article 8 of these Administrative Policies.
- J. At the request of the Zone Directors, may attend the USA Swimming Zone Workshops. If travel is required, reimbursement will apply according to Article 8 of these Administrative Policies.

#### .5 Diversity, Equity, and Inclusion (DEI) Coordinator

- A. Shall maintain communication with and distribute information to the LSC Diversity, Equity, and Inclusion Chairs within the Western Zone.
- B. Shall contribute content to the Western Zone website.
- C. Shall coordinate the following:
  - a. DEI Camp
  - b. DEI All-Star Travel Team
  - c. DEI Summit
  - d. Oversight and spending authority for funds generated and expended by the WZ DEI Committee.
  - e. Other activities as designated
- D. Shall chair the Western Zone Diversity, Equity, and Inclusion Committee.
- E. At the request of the Zone Directors, may attend the USA Swimming Zone Workshops. If travel is required, reimbursement will apply according to Article 8 of these Administrative Policies.

#### .7 Safe Sport Coordinator

- A. Shall maintain communication with and distribute information to the LSC Safe Sport Chairs within the Western Zone.
- B. Shall contribute content to the Western Zone website.
- C. At the request of the Zone Directors, may attend the USA Swimming Zone Workshops. If travel is required, reimbursement will apply according to Article 8 of these Administrative Policies.

#### **ARTICLE 5 – ELECTIONS**

5.1 TIMING – Elections shall be held at the Annual Meeting of the Western Zone House of Delegates (HOD).

#### 5.2 NOMINATIONS

- .1 May be made from the floor at the Western Zone HOD by any HOD voting delegate of the Western Zone. Western Zone Director nominations may be made prior to the Western Zone HOD meeting by submission to the Western Zone Secretary / Treasurer.
- .2 Each candidate or their representative may present an introduction or statement not to exceed one minute and/or may prepare and distribute, with-in the Western Zone, a written statement regarding their qualifications for the office and views pertaining to Western Zone matters.

#### 5.3 VOTING

- .1 Shall be by secret ballot.
- .2 Election requires a majority of the votes cast.
- .3 If there is no majority on a ballot, the leading candidates whose votes total a majority shall advance to another ballot, continuing until one candidate receives a majority.
- .4 Proxy votes at Western Zone meetings shall not be allowed.
- .5 Email/Electronic vote:
  - A. Any action which may be taken at regular or special meetings, except amendment of these Administrative Procedures which include the Western Zone Championship Regulations, may be taken by email/electronic vote.
  - B. The Secretary/Treasurer shall distribute a written ballot to every member entitled to vote. The ballot

- shall set forth the proposed action, provide an opportunity for approval or disapproval and provide a reasonable time within which to return the ballot to the Secretary/Treasurer.
- C. Approval by this ballot shall be valid only when the number of votes cast within the time specified, constitutes a majority of the votes cast.

#### **ARTICLE 6 - MEETINGS**

#### 6.1 MEETINGS

- .1 Order of Business At all meetings of the Western Zone, the following shall be the Order of Business, unless specifically noted otherwise in these Administrative Procedures:
  - A. Roll Call
  - B. Approval of Minutes
  - C. Reports of Officers and Coordinators
  - D. Old Business
  - E. New Business
  - F. Elections (as appropriate)
  - G. Adjournment
- .2 Quorum A quorum at all meetings shall consist of a simple majority, defined as at least 50% + one (1) of those eligible to vote, who are present. "Present" is defined as either physically in person, or by electronic means.
- .3 Rules The procedural rules of all meetings shall be the current Robert's Rules of Order as amended.

#### .4 Annual Meeting

- A. The Annual Meeting of the Western Zone may be held in conjunction with the USA Swimming Annual Business Meeting.
- B. The purpose is to conduct the annual business of the Western Zone.

#### .5 Special Meetings

- A. A special meeting may be called by either or both Western Zone Directors, or by one-third of the LSC representatives.
- B. Notice Notice of any special meeting shall be sent at least thirty (30) days in advance of the meeting, setting forth the specific agenda of items to be considered and acted upon. The Secretary/Treasurer shall be responsible for notifying, via email the LSC's of the time of the meeting.

#### .6 Western Zone Technical Planning Meeting

- A. A Technical Planning meeting may be held prior to the Annual Business Meeting of the Western Zone.
- B. All Western Zone members present shall have voice and vote at this meeting.
- C. The purpose of this meeting is to review current Western Zone Swimming Championship operations and make advisory recommendations for consideration at the Annual Meeting.
- D. Order of Business:
  - (1) Review current Western Zone Swimming Championship formats.
  - (2) Open discussion and recommendations of ideas to be presented at the Annual Meeting.
  - (3) Recommendations must have a majority vote at this meeting to be presented for consideration as new business at the Annual Meeting

#### .7 Western Zone Age Group Championship Meet Business Meeting

- A. The Western Zone Age Group Championship Meet Business Meeting should be held in conjunction with the Western Zone Age Group Championship Meet.
- B. The purpose of this meeting is to review and make decisions regarding the Western Zone Age Group Championship Regulations, Section C of these Administrative Procedures.
- C. Order of Business:
  - (1) Review current Western Zone Age Group Championship Meet format and regulations.
  - (2) Discussion and approval of recommended changes, if any, to be presented at the Annual Meeting for confirmation.
- D. The Western Zone Swimming Championship Coordinator will be responsible for assembling ideas and proposals regarding the meet to bring to the Age Group Championship Meet Business Meeting for discussion.
- E. The meeting shall be chaired by the Western Zone Swimming Championship Coordinator, if present, or the Zone Director in attendance.
- F. Each LSC, each Western Zone Director, the Western Zone Athlete Director, and the Western Zone Junior Athlete Representative shall have one (1) vote, IF PRESENT at the meeting.
- G. Each LSC voting representative shall be named prior to the meeting by their General Chair. The voting representative chosen MUST have attended the Western Zone Age Group Championship immediately preceding the Western Zone Age Group Business Meeting.
- H. Voting by proxy is not permitted.
- I. Complete details of the meet format are described in the Western Zone Age Group Championship Meet Announcement Template, Appendix B of these Administrative Procedures.
  - (1) Items in the Meet Announcement Template that are highlighted in yellow are host-specific and may be changed annually per the needs and requirements of each specific meet host and meet referee.
  - (2) Except for sanctioning, governing rules, and meet entry fees, items that are NOT highlighted are meet specific. Changes to these details require a two-thirds (2/3) majority vote at the Western Zone Age Group Business Meeting, and a final vote of affirmation at the Western Zone Annual Business Meeting, per Article 6.1.7.J of these Administrative Procedures.
    - a) Consideration of meet format changes will be limited to once every three years.
    - b) Exception: If a meet format change has at least 95% support of the WZAG Business Meeting eligible voting body.
    - c) Year 1 will be 2023.
  - (3) Sanctioning and governing rules must meet the requirements set forth by USA Swimming and the host LSC.
  - (4) Meet entry fees may only be changed by a vote of the House of Delegates at the Western Zone Annual Business Meeting.
- J. Meet format changes approved at the Western Zone Age Group Business Meeting will be presented as an omnibus block motion at the Western Zone Annual Business Meeting for a vote of affirmation, with no discussion. A two-thirds (2/3) majority vote of eligible voters shall be required, with no discussion, to disallow the omnibus block motion and refer it back to the next Western Zone Age Group Championship Meet meeting.
  - (1) Meet format changes may be pulled from the omnibus block motion for individual consideration, with no discussion.
  - (2) A two-thirds (2/3) majority vote of the eligible voters shall be required to disallow the individual change and refer it back to the next Western Zone Age Group Championship Meet meeting.

#### ARTICLE 8 – TRAVEL REIMBURSEMENT

#### 8.1 WESTERN ZONE ANNUAL BUSINESS MEETING (HOD)

- .1 Board members shall be reimbursed for airfare (or mileage, at the established USA Swimming reimbursement rate), lodging, and a daily per diem of \$40.00, for attendance at the Annual Meeting, if in-person attendance is required.
- .2 Submission of expenses for reimbursement shall be made to both the Western Zone Secretary/Treasurer and at least one Western Zone Director, for approval of submitted expenses.

#### 8.2 WESTERN ZONE SENIOR and AGE GROUP CHAMPIONSHIP MEETS

- .1 **Appointed Officials**. The Meet Referee, Administrative Referee, and Team Lead Chief Judge shall be reimbursed for airfare (or mileage, at the established USA Swimming reimbursement rate), lodging, and a daily per diem of \$40.00 for the meet including up to two days prior to competition.
  - A. Submission of expenses for reimbursement shall be made to both the Western Zone Secretary/Treasurer and at least one Western Zone Director, for approval of submitted expenses.
- .2 **Board Members**. The Senior and Junior Western Zone Directors, the Western Zone Athlete Director, and, if requested by the Zone Directors, the Western Zone Championship Coordinator, shall be reimbursed for airfare (or mileage, at the established USA Swimming reimbursement rate), lodging, and a daily per diem of \$40.00 for the meet including up to two days prior to competition.
  - A. Submission of expenses for reimbursement shall be made to both the Western Zone Secretary/Treasurer and at least one Western Zone Director, for approval of submitted expenses.
- Pre-Meet Site Visits. At the discretion of the Zone Directors, approximately three (3) months prior to the events, a Zone Director, or the Western Zone Championship Coordinator, or another designated individual, may visit the site(s) of the Senior and Age Group Championships to consult with the host(s) regarding preparations for the meet. The individual performing the visit shall be reimbursed for airfare (or mileage, at the established USA Swimming reimbursement rate), lodging for up to two nights, and a daily per diem of \$40.00 for up to two days.
  - A. Submission of expenses for reimbursement shall be made to both the Western Zone Secretary/Treasurer and at least one Western Zone Director, for approval of submitted expenses.

#### 8.3 WESTERN ZONE OPEN WATER CHAMPIONSHIPS

- .1 **Appointed Officials**. Reimbursement of travel expenses for the Open Water Meet Referee and other essential Open Water Officials shall be the responsibility of the Open Water Meet Host. Reimbursed expenses may include travel, lodging, and other considerations. All reimbursed expenses shall be agreed upon by the Host and the Open Water Meet Referee well in advance of the event and shall include guidance from the Western Zone Open Water Championship Coordinator.
- .2 Western Zone Open Water Coordinator. The Western Zone Open Water Coordinator shall attend the Western Zone Open Water Championships. Reimbursement of travel expenses for the Open Water Coordinator shall be the responsibility of the Open Water Meet Host. Reimbursed expenses may include travel, lodging, and other considerations.
- .3 **Pre-Meet Site Visit.** At the discretion of the Zone Directors, approximately three (3) months prior to the events, a Zone Director, or the Western Zone Open Water Coordinator, or another designated individual, may visit the site of the Open Water Championships to consult with the host regarding preparations for the meet. The individual performing the visit shall be reimbursed for airfare (or mileage, at the established USA Swimming reimbursement rate), lodging for up to two nights, and a daily per diem of

\$40.00 for up to two days.

.4 **Board Members**. At the discretion of the Zone Directors, either of the Western Zone Directors, or both, or the Western Zone Athlete Director, or all three, may attend the Western Zone Open Water Championships. The individuals who attend shall be reimbursed for airfare (or mileage, at the established USA Swimming reimbursement rate), lodging for up to two nights, and a daily per diem of \$40.00 for up to two days.

#### ARTICLE 9 – DIVERSITY, EQUITY, and INCLUSION (DEI)

#### 9.1 Western Zone DEI Committee

- .1 The Western Zone DEI Committee shall consist of the following voting members:
  - A. The DEI Chair from each Western Zone LSC
  - B. One athlete from each Western Zone LSC
  - C. The Western Zone DEI Coordinator
- .2 The Committee will be chaired by the Western Zone DEI Coordinator.
- .3 The Committee should meet on a regular basis, as best fits the Committee members' schedules. Monthly meetings are recommended.
- .4 Every LSC is encouraged to fund their DEI Chair, or the chair's designee, to attend and participate in DEI educational tracks that may be offered at the national level, including the USA Swimming Zone Workshops, and the USA Swimming Annual Business Meeting.

#### 9.2 Western Zone DEI Fund

- .1 **Purpose:** This fund provides financial resources for the expenses generated from planning and hosting the following events:
  - A. The Western Zone DEI Camp and Summit, recommended to be held every two years, when possible.
  - B. The Western Zone DEI All Star Team.
  - C. Other Western Zone DEI-related activities, as organized by the Western Zone DEI Committee.
- .2 **Source of Funds**. Each Western Zone LSC will annually submit a surcharge payment of \$0.20 per registered athlete for the support of the Western Zone DEI Fund.
  - A. Each Western Zone LSC will be sent an annual billing statement of funds due, no later than October 31 of the current year.
  - B. The billing will be sent to each LSC by the Western Zone DEI Coordinator in conjunction with the Western Zone Secretary/Treasurer, based on the annual accounting of registered athletes as provided by USA Swimming for each LSC.
  - C. The annual accounting of registered athletes will be from September 1 of the previous year through August 31 of the current year in which the billing statement is generated.
  - D. Payment of the LSC DEI Funds surcharge is due by December 1 of the current year.
  - E. Payment of the LSC DEI Funds surcharge will be by check, payable to the Western Zone / USA Swimming, sent to the Western Zone Secretary/Treasurer for deposit in the Western Zone General Fund, held with USA Swimming.
  - F. A copy of the check should also be sent to the Western Zone DEI Coordinator, to assist with accounting of funds paid, and funds still due, from each LSC.

#### .3 Distribution of Funds.

A. Any distribution of funds will be coordinated with the WZ Sec/Treas. The funds will be administered by the Western Zone DEI Coordinator, as specified in Article 4.5.6.C.d of these Administrative Procedures.

#### 9.3 Western Zone DEI Camp and Summit

- .1 Purpose: The Western Zone DEI Committee hosts the Western Zone DEI Camp and Summit to instill a vision of success and inspire athletes from under-represented populations to become leaders in the sport of swimming. The Western Zone DEI camp is a part of the DEI camp progression from the LSC level to the USA Swimming Regional and National Diversity Select Camps.
- .2 **Eligibility:** The Western Zone DEI Camp and Summit is open to athletes who represent an ethnically under-represented population, including African American, Native American, Hispanic/Latino, Asian, Pacific Islander, Native Alaskan, Native Hawaiian, or athletes who are outreach members (low income), LGBTQ+, or diverse in another way.
- .3 Athlete & Event Host Selection Criteria, and General Event Management: The Western Zone DEI committee along with the Western Zone DEI Camp and Summit Sub-Committee will:
  - A. Establish the criteria for hosting a Western Zone DEI Camp and Summit.
  - B. Select the camp/summit host and establish an event budget.
  - C. Establish criteria for the athletes and summit participants.
  - D. Develop, publish, and distribute Camp and Summit applications.
  - E. Select coaches, speakers, athlete alternates, and camp staff.
  - F. Develop the camp schedule, and any other necessary components of the camp and summit.

#### .4 LSC Responsibilities:

- A. Provide funding to cover the Camp and Summit attendance fee and the cost of round-trip transportation for each of two athletes of the LSC's choosing.
- B. LSCs may also nominate up to four (4) additional alternates to attend the Camp and Summit, with a potential of up to six (6) athletes invited to attend and represent the LSC.
- C. Alternates nominated by the LSC will be selected by the Western Zone DEI Camp and Summit Committee; therefore, LSC budgeting flexibility for this event is recommended and encouraged.
- D. Provide funding to cover attendance at the Summit portion of the event, including the Summit fee and round-trip transportation, for the LSC DEI Chair or designee, and one other adult non-athlete member selected by the LSC.
- E. If space is available, additional non-athletes may be accepted to attend the Summit portion of the event, with funding support of the LSC.

#### 9.4 Western Zone DEI All-Star Team

- .1 **Purpose:** The Western Zone DEI All-Star Team provides an opportunity for athletes of diverse ethnic backgrounds to participate in competitions celebrating their heritage.
  - A. The Western Zone DEI Committee may organize a Western Zone DEI All-Star Team to compete at a multicultural meet at (a) location(s) across the country.
  - B. LSCs are expected to offset a portion of the costs for travel and accommodation for athletes and others attending from their LSC. Team fees will be paid by the LSC, and the athlete or the athlete's team as specified in the team information.
- .2 **Eligibility and Selection:** Qualifications for the All-Star Team, selection of the meet, selection of coaches and chaperones, travel information, and other criteria will be set by the Western Zone DEI Committee.

#### ARTICLE 10 – OFFICIALS ASSISTANCE FUND

#### 10.1 Western Zone Officials Assistance Fund.

- .1 This fund aids with expenses to attend the Western Zone Senior Championship Meet and the Western Zone Age Group Championship Meet, to officials who:
  - A. Work at least 80% of the meet sessions.
  - B. Are not being reimbursed from another source (e.g., their LSC or the Western Zone) for their expenses.
  - C. Eligibility. Must be a current USA Swimming Member Official in good standing within a LSC in the Western Zone.
- .2 **Source of Funds**. \$2.50 of each individual entry fee and \$1.00 of each relay entry fee from the Senior and Age Group Championship Meets are designated for the Officials Assistance Fund.

#### .3 Distribution of Funds.

- A. Any distribution of funds will be coordinated with the WZ Sec/Treas. This fund will be administered by the Western Zone Officials Coordinator, subject to the requirements specified in Article 10
- B. The funds generated from the Meet are shared equally across all applicants who have met the sessions worked requirements.
- C. The Assistance Fund has been designated to help officials who travel to the Western Zone Senior and Age Group Championship Meets with travel expenses such as airfare, hotels, etc. The maximum amount of this reimbursement shall not exceed \$1,000.00.
- D. Local officials that live in the LSC in which the Championship Meet is held and who work the required 80% of the sessions offered will receive a \$150.00 stipend ("Local" is defined as the official is able to stay in their own home).
- E. Officials that have met the qualification shall be notified by the Western Zone Officials Coordinator after the Meet that they are eligible. There is no application process necessary to receive funds, as the sessions are provided to the Western Zone Officials Coordinator by the Team Lead Chief Judge(s) at each of the Championship Meets.
- F. The Western Zone Treasurer will receive from the Western Zone Officials Coordinator the list of eligible officials, their LSC and the amount of each official's reimbursement. The assistance checks are sent to each LSC for distribution to the designated officials.

#### ARTICLE 11 – OFFICIALS POLICIES for WESTERN ZONE CHAMPIONSHIP MEETS

#### 11.1 Western Zone Senior and Age Group Championships

- .1 Appointed Officials.
  - A. Meet Referee.
    - (1) Shall be appointed by the Western Zone Directors and the Western Zone Officials Coordinator by January 1 of the year of the meet in consultation with the Meet Host.
    - (2) Shall have attended at least one Junior, National, or US Open Championship as an assigned official and have extensive experience as a Meet Referee.
    - (3) Shall conduct the General Meeting in conjunction with the respective Meet Director(s).
    - (4) Shall prepare a proposed timeline for all sessions to be distributed at the General Meeting.
    - (5) Shall prepare estimated timelines for each session for inclusion in the session heat sheets.
    - (6) Shall be reimbursed according to Article 8.2.1 of these Administrative Procedures.

- B. Administrative Official and Team Lead Chief Judge.
  - (1) Shall be named well in advance of each meet.
  - (2) Shall be according to Article 8.2.1 of these Administrative Procedures.
  - (3) Within ten (10) days of the completion of each meet, the Team Lead Chief Judge shall give the Western Zone Officials Coordinator a list of:
    - a. The names of all officials who worked at least 80% of the sessions.
    - b. The position(s) in which they worked.
    - c. Each official's LSC.
    - d. Contact information for each official if available (email and cell phone preferred).
- .2 Officials Meetings. All officials shall attend the officials meeting prior to the session for which they are assigned.
- .3 Applications to Officiate shall be included in the meet announcement packet.

#### **ARTICLE 12 – CHAMPIONSHIP MEETS**

- 12.1 WESTERN ZONE AGE GROUP CHAMPIONSHIP MEET The Western Zone should conduct an annual age group championship meet, in accordance with <u>USA Swimming Rules and Regulations</u> Article 205.6.
- 12.2 WESTERN ZONE SENIOR CHAMPIONSHIP MEETS The Western Zone may conduct an annual senior LCM championship meet and an annual SCY championship meet, in accordance with <u>USA Swimming Rules and Regulations Article 205.7.</u>
- 12.3 WESTERN ZONE OPEN WATER CHAMPIONSHIP MEET The Western Zone may conduct an annual open water championship meet, in accordance with the procedures determined by the Western Zone, and in accordance with USA Swimming Rules and Regulations Article 704.
- 12.4 SECTIONAL CHAMPIONSHIP MEETS Each Section (Blue and Gold, as defined in Administrative Procedures 1.3.1 and 1.3.2) should host two (2) meets per year, one in the spring and one in the summer, in accordance with <u>USA Swimming Rules and Regulations Article</u> 204, Senior Program 204.9.6.

#### **ARTICLE 13 – SECTION ADMINISTRATIVE PROCEDURES**

- 13.1 SECTION ADMINISTRATIVE PROCEDURES Each Section should develop and adopt administrative procedures to govern:
  - A. Athlete eligibility
  - B. Officers and their respective duties
  - C. Site selection procedures
  - D. Meet format
  - E. Scoring
  - F. Time standards (to accommodate no fewer than 400 participants)
  - G. Each Section shall maintain a current and correct copy of their admin procedures with the WesternZone Secretary/Treasurer.

## ARTICLE 14 - APPROVAL and AMENDMENT

14.1	Any provision of these Western Zone Administrative Procedures not prescribed by USA Swimming may be amended by majority approval of the Executive Board of Directors or by majority vote at the WZ HOD.

## **SECTION B**

#### WESTERN ZONE SWIMMING ADMINISTRATIVE PROCEDURES

#### WESTERN ZONE SENIOR CHAMPIONSHIP PROCEDURES Updated 5.7.25

#### Senior Championship Coaches Advisory Committee

#### 1. Responsibilities.

- a. To provide representation and voice on the behalf of Western Zone teams, coaches, athletes, and officials in prescribing the format and conduct of the Western Zone Senior Championship meets.
- b. To develop, promote, and assist in the format and conduct of the Western Zone Senior Championship meets.
- c. To aid and assist in the distribution of information specifically regarding the Western Zone Senior Championship meets to the LSCs within the Western Zone.

#### 2. Membership.

#### a. Athlete Members:

- 1) The Western Zone Athlete Director and the Western Zone Junior Athlete Representative shall be active members of the committee throughout their regular elected term, with voice and vote.
- 2) At their discretion, the Western Zone Athlete Director and the Western Zone Junior Athlete Representative may appoint other athlete members of the Western Zone to serve as their designee(s) on the committee, with voice and vote.
- 3) If the Western Zone Athlete Director and the Western Zone Junior Athlete Representative appoint other athlete members of the Western Zone to serve as their designee(s) on this committee, the term of service of the appointed athlete(s) will be the same as that of the Western Zone Athlete Director and the Western Zone Junior Athlete Representative.
- 4) If the Western Zone Athlete Director and the Western Zone Junior Athlete Representative appoint other athlete members of the Western Zone to serve as their designee(s) on this committee, it is recommended that the appointed athlete(s) have direct experience with competing at the Western Zone Senior Championships.

#### b. Non-Athlete Members.

- 1) Appointed Coaches. Three coach members shall be appointed to the committee, as follows:
  - a) At the beginning of their two-year term, the Western Zone Directors and the Western Zone Championship Coordinator shall each appoint one coach member to serve on the committee for a twoyear term.
  - b) Appointed coach members shall have voice and vote.
  - c) There shall be no limit to the number of two-year terms that an appointed coach may serve on the
  - d) The two-year term for appointed coaches shall begin immediately following the Western Zone Annual House of Delegates meeting and shall conclude at the Western Zone Annual House of Delegates meeting two years after appointment, unless re-appointed to another two-year term.
  - e) It is recommended that the coaches appointed to the committee reflect the following attributes:
    - i. Have at least three years of experience as a coach of athletes competing at the Western Zone Senior Championship.
    - ii. Represent the variety of team sizes that attend the Western Zone Senior Championship, i.e., teams under 10 athletes ("small"), teams between 10 25 athletes ("medium"), and teams with more than 25 athletes ("large").
    - Represent the three Sectional regions of the Western Zone, i.e., California/Nevada, Four Corners, and Northwest.

#### 2) The Meet Referees for upcoming years' events (two selections).

- a) The incoming Meet Referee(s) shall join the committee following the current year's Western Zone Annual House of Delegates.
- b) Upon joining the committee, the incoming Meet Referee(s) shall have voice and vote.
- c) The term on the committee for outgoing Meet Referee shall be completed when:
  - i. All reports on the current years' events have been presented at the Western Zone Annual House of Delegates
  - ii. The incoming Meet Referee(s) have joined the committee.

- d) It is recommended that, whenever possible, the incoming Meet Referee(s) be named prior to the current year's Western Zone Annual House of Delegates.
- 3) The Meet Host Representative of upcoming years' meets (two selections).
  - a) The incoming Meet Host Representatives shall join the committee following the current year's Western Zone Annual House of Delegates.
  - b) Upon joining the committee, the incoming Meet Host Representatives shall have voice and vote.
  - c) The term on the committee for outgoing Meet Host Representatives shall be completed when:
    - i. All reports on the current year's event have been presented at the Western Zone Annual House of Delegates
    - ii. The incoming Meet Host Representatives have joined the committee.
  - d) It is recommended that, whenever possible, the incoming Meet Host Representatives be named prior to the current year's Western Zone Annual House of Delegates.
- 4) The Senior Western Zone Director shall serve as an active member of the committee with voice and vote.
- 5) The Western Zone Championship Coordinator.
  - a) The Western Zone Championship Coordinator shall serve as an ex officio member of the committee, with voice but no vote. *Exception:* In the event of a tie vote, the Championship Coordinator will cast the tie-breaking vote.
  - b) The Western Zone Championship Coordinator shall serve as the chair of the committee, with the following responsibilities:
    - i. Coordinate with committee members regarding meeting times and agenda items to be addressed.
    - ii. Prepare a written agenda for all committee meetings.
    - iii. Distribute minutes following the meeting to committee members for review to ensure accuracy.
    - iv. Maintain a current and correct copy of the Western Zone Senior Championship Meet Announcement Template, Appendices A and D of these Administrative Procedures.
    - v. Provide reports on committee actions as requested by the Western Zone Directors for distribution to the Western Zone LSCs.
- 5) The Junior Western Zone Director, and the Western Zone Officials Coordinator shall serve as ex officio members of the committee, with voice but no vote.

#### **Meet Host Bids**

#### 1. Requirements to bid:

- a. It is recommended that meet host bids include a facility that meets or exceeds the requirements noted in the Senior Championship Facility Requirements, Article (TBD)
- b. Potential meet hosts must be willing and able to meet the requirements outlined in the USA Swimming Zone Championship contract.
- c. Potential meet hosts must be willing and able to provide a National Officials Evaluator, as noted below:
  - 1) The selection of the National Official Evaluator shall be approved by the Western Zone Officials Coordinator in consultation with the host LSC Officials Chair.
  - 2) Travel and lodging expenses for the National Officials Evaluator will be the responsibility of the meet host.
- d. Potential meet hosts must be willing and able, at the expense of the host, to provide the following essential meet staff as noted below and further described in Article 102 of the current USA Swimming Rulebook:
  - 1) Meet Director(s), experienced in the management of championship-level events.
  - 2) Lane Timing Personnel
    - a. Chief Timer (minimum of one recommended two or more encouraged)
    - b. Lane Timers (minimum of one per lane recommended two per lane encouraged)
  - 3) Timing Equipment Operator(s), experienced in the management and operations of championship-level events (minimum of two recommended)
  - 4) Results Computer Operator(s), experienced in the management and operations of championship-level events (minimum of two recommended)
  - 5) Marshals (minimum of two, with at least one of each gender, throughout the event four or more, with at least one of each gender, are recommended)
  - 6) Clerk of Course
  - 7) Announcer

- 8) Additional administrative personnel, as necessary, experienced in the management of championship-level events.
- e. Potential meet hosts must be willing and able to provide the following additional items, at the expense of the host:
  - 1) *Meet credentials (meet-specific identification)* for athletes, coaches, officials and meet staff, including any designated meet volunteers.
  - 2) Hospitality for credentialed coaches and officials
    - a. The host shall provide breakfast and lunch for credentialed officials and coaches on competition days.
    - b. A light dinner on competition days is recommended.
    - c. A separate hospitality area is recommended.
  - 3) Awards, as determined by the Senior Championship Coaches Advisory Committee for this event.
  - 4) Meet-specific Officials Polo or other designated Officials "thank you" item.
    - a. It is recommended that the meet host and meet referee work together to determine the nature and parameters of the designated Officials "thank you" item (traditionally a meet-specific Officials Polo).
    - b. Parameters for the Officials "thank you" item should include such detail as cost to the host, design of the "thank you" item, and availability.

#### 2. Senior Championship Facility Requirements.

It is recommended that the host facility:

- a. Meet the standards preferred for National Championships, Article 103, Facilities Standards, USA Swimming Rules and Regulations.
- b. Have sufficient venue space to host an event of approximately 1500 athletes, coaches, and officials over five (5) full days of competition, including:
  - 1) Team seating areas and athlete locker room space.
  - 2) A warm-up pool with a minimum of six (6), 25-yard lanes available throughout the event during warmups and competition.
  - 3) Coach-supervised practice time in the competition pool on the day prior to the start of the meet.
- c. Have automatic timing and judging equipment capable of running the meet from both ends of the pool, including timing machines with stored memory capability, touch pads, two button backup and a scoreboard.
- d. Have sufficient back-up automatic timing and judging equipment available on-site to prevent disruption of the meet.
- e. Have a meeting room with a minimum capacity of 50 people.
- f. Have spectator seating to accommodate a minimum of 1000 people.

#### 3. Submission of Meet Bids.

It is recommended that:

- a. The Senior Zone Committee will solicit and receive bids for meets on a quadrennial basis.
- b. The committee will work with potential host sites to secure acceptable dates and develop a quadrennial calendar.
- c. Potential meet hosts will prepare a presentation demonstrating how the requirements for hosting will be met.
- d. A representative from the potential meet host will present to the Senior Zone Committee to deliver the meet host bid and answer any questions that may arise regarding the meet bid.

#### 4. Awarding of Meet Bids.

- a. The Senior Zone Committee will submit the slate of event hosts for the following quadrennial at the Western Zone Annual House of Delegates.
- b. The voting delegates present at the Western Zone Annual Meeting shall confirm the quadrennial meet hosts for the Western Zone Senior Championship by secret ballot from the meet host bids presented at that meeting.
- c. The results of the secret ballot shall be announced, and the awarding of the meet bids shall take place prior to the adjournment of the Western Zone Annual Meeting in which the voting takes place.
- d. If the quadrennial calendar has not been filled, the Senior Zone Committee will be charged with filling open meets as soon as reasonably possible and present an updated schedule of quadrennial meet hosts at the subsequent Western Zone Annual Meeting.

#### **Meet Host Responsibilities**

#### 1. Contractual Obligations.

- a. The awarded meet host shall execute the USA Swimming Zone Championship contract within 30 days of receipt from USA Swimming.
- b. The awarded meet host shall receive any funds due from USA Swimming upon successfully completing all contractual terms.
- c. The awarded meet host shall not be obligated by contracts between other member LSCs of the Western Zone and any of their vendors or suppliers.
- d. The meet host will reimburse the travel expenses of the National Evaluator assigned to the meet.

#### 2. Pre-Meet Responsibilities.

- a. It is recommended that information on key facility details as well as travel and lodging resources be shared at the Western Zone Annual Meeting prior to the event.
- b. The Western Zone Senior Championship Meet Announcement Template, Appendices A and E of these Administrative Procedures, should be used to create the sanctioned meet announcement for the event.
- c. The sanctioned meet announcement for the event shall contain all the information detailed in Western Zone Senior Championship Meet Announcement Template, Appendices A and E of these Administrative Procedures, as well as any host LSC requirements for sanctioning.
- d. It is recommended that the sanctioned meet announcement be distributed to the Western Zone LSCs no later than ninety (90) days prior to the event.

#### 3. Post-Meet Responsibilities.

- a. The meet host shall ensure that a complete electronic copy of final meet results is provided to the host LSC via email immediately following the conclusion of the event.
- b. The meet host should work with the host LSC to ensure that the final meet results are loaded to SWIMS within 48 hours of the conclusion of the event, so that times achieved at the event are available for entry into USA Swimming National Championships.
- c. The meet host shall ensure that a full and unlocked copy of the final meet database is provided via email to the Western Zone Championship Coordinator immediately following the conclusion of the event.
- d. The meet host shall ensure that event results are posted to the Western Zone website after the conclusion of event
- e. The meet host shall submit a final report of the meet athlete/entry count via email to the Western Zone Secretary/Treasurer within thirty (30) days of the completion of the event.
- f. Payment of required Western Zone fees shall accompany a hard copy of the meet athlete/entry count and shall be received the Western Zone Secretary/Treasurer via certified mail within seven (7) days of receiving the electronic copy of the athlete/entry count report.
- g. It is recommended that the meet host present a summary report at the Western Zone Annual Meeting following the completed event, that includes the following information:
  - 1) Number of LSCs, teams, and athletes participating
  - 2) Number of coaches and officials
  - 3) Athlete entry count including total individual and relay entries.
  - 4) Event highlights, including challenges encountered and solutions implemented.
- h. It is requested that the meet host be available for consultation with future meet hosts, as needed.

#### **Sanction and Governing Rules**

- 1. The meet host shall obtain a USA Swimming sanction for the meet from the LSC in which the event will take place.
- 2. The conduct of the sanctioned meet shall conform in every respect to all technical and administrative rules of USA Swimming and the Minor Athlete Abuse Prevention Policy ("MAAPP").
- 3. The conduct of sanctioned meet shall conform to any requirements of the host LSC specified for sanctioning.

#### Eligibility

- 1. This meet is open to all athletes ages 19 and under who:
  - a. Are currently registered as Premium or Outreach members of USA Swimming. There will be no on-deck USA Swimming registration.

- b. Are currently registered within the LSCs of the Western Zone as of the date entries close. On-deck transfer into an eligible LSC is not allowed.
- c. Have qualifying entry times achieved at USA Swimming sanctioned, approved, or observed competitions:
  - 1) For the LCM Championship: Between June 1 of the year prior to the current meet (13 months), and the close of entries.
  - 2) For the SCY Championship: Between February 1 of the year prior to the current meet (13 months), and the close of entries.
- 2. The complete list of eligibility requirements is found under <u>Eligibility</u> in the Western Zone Senior Championship Meet Announcement Template, Appendices A and E of these Administrative Procedures.

#### **Meet Dates**

- 1. The Senior Championship Coaches Advisory Committee will develop a three-year schedule of meet dates, to be updated annually and presented at the Western Zone Annual Business Meeting.
- 2. The three-year schedule should include the following recommendations:
  - a. The Senior Zone LCM Championship meet should be scheduled after the conclusion of the summer championships of the Western Zone LSCs.
  - b. The Senior Zone LCM Championship meet should be scheduled to conclude on the Saturday immediately preceding the USA Swimming Junior National Championships.
  - c. The Senior Zone SCY Championship meet should be scheduled sometime between mid-February and early April.

#### **Meet Format**

- 1. The Senior Championship Coaches Advisory Committee will develop and oversee the meet format for the Senior Zone Championship meets, to be reviewed annually and presented at the Western Zone Annual Business Meeting.
- 2. The annual review of the meet format should include the following:
  - a. Input from teams, coaches, and athletes in attendance at that years' events.
  - b. Input from the Meet Referees and Meet Hosts of that year's event.
- 3. Complete details of the meet format are described in the Western Zone Senior Championship Meet Announcement Templates, Appendices A and E of these Administrative Procedures.
  - a. Items in the Meet Announcement Template that are highlighted in yellow are host-specific or official-specific and may be changed annually per the needs and requirements of that year's meet host or meet referee.
  - b. Except for sanctioning, governing rules, and meet entry fees, items that are NOT highlighted in yellow are meet-specific and may only be changed by the Senior Championship Coaches Advisory Committee.
  - c. Sanctioning and governing rules must meet the requirements set forth by USA Swimming and the host LSC.
  - d. Meet entry fees may only be changed by a vote of the House of Delegates at the Western Zone Annual Business Meeting.

#### **Meet Fees**

- 1. Regular Entry Fees.
  - a. Senior Zone LCM Championships:
    - i. Athlete Surcharge: \$25.00 per athlete (\$20.00 of which is to be retained by meet host and \$5.00 paid to Western Zone treasury, and designated for the funding of Zone meets).
    - ii. Individual Entry Fees: \$20.00 per individual event (\$15.00 retained by meet host / \$5.00 paid to Western Zone treasury, of which \$2.50 is designated for support of the Western Zone Officials Assistance Fund).
    - iii. Relay Entry Fees: \$30.00 per relay event (\$25.00 retained by meet host / \$5.00 paid to Western Zone treasury, of which \$1.00 is designated for support of the Western Zone Officials Assistance Fund)
  - b. Senior Zone SCY Championships:

    - ii. Individual Entry Fees: \$20.00 per individual event (\$15.00 retained by meet host / \$5.00 paid to Western Zone treasury, of which \$2.50 is designated for support of the Western Zone Officials Assistance Fund).
    - iii. Relay Entry Fees: \$40.00 per relay event (\$25.00 retained by meet host / \$5.00 paid to Western Zone treasury, of which \$1.00 is designated for support of the Western Zone Officials

#### Assistance Fund)

#### 2. Late Entry Fees.

- a. Late Entry Fine: \$100.00 per athlete with entries submitted after the regular entry deadline (all funds retained by meet host).
- b. Late Athlete Surcharge: \$45.00 per athlete entered after the regular entry deadline (\$40 of which is retained by meet host and \$5.00 paid to Western Zone treasury, and designated for the funding of Zone meets).
- c. Late Individual Entry Fees: \$40.00 per individual event submitted after the regular entry deadline (\$35.00 retained by meet host / \$5.00 paid to Western Zone treasury, of which \$2.50 is designated for support of the Western Zone Officials Assistance Fund.
- d. Late Relay Entry Fees: \$60.00 per relay event submitted after the regular entry deadline (\$55.00 retained by meet host / \$5.00 paid to Western Zone treasury, of which \$1.00 is designated for support of the Western Zone Officials Assistance Fund)

#### 3. Spectator Fees.

- a. Meet hosts may choose to charge a spectator fee for this event.
- b. If a spectator fee is charged by the host, the maximum fee is \$15 per adult, per day.

  - 4) If the Western Zone Athlete Director and the Western Zone Junior Athlete Representative appoint other athlete members of the Western Zone to serve as their designee(s) on this committee, the term of service of the appointed athlete(s) will be the same as that of the Western Zone Athlete Director and the Western Zone Junior Athlete Representative.
  - 5) If the Western Zone Athlete Director and the Western Zone Junior Athlete Representative appoint other athlete members of the Western Zone to serve as their designee(s) on this committee, it is recommended that the appointed athlete(s):
    - a) Have direct experience with competing at the Western Zone Age Group Championships.
    - b) Be at least sixteen (16) years of age.

#### b) Non-Athlete Members.

- 1) Appointed Coaches. Three coach members shall be appointed to the committee, as follows:
  - a) At the beginning of their two-year term, the Western Zone Directors and the Western Zone Championship Coordinator shall each appoint one coach member to serve on the committee for a twoyear term.
  - b) Appointed coach members shall have voice and vote.
  - c) There shall be no limit to the number of two-year terms that an appointed coach may serve on the committee.
  - d) The two-year term for appointed coaches shall begin immediately following the Western Zone Annual House of Delegates meeting and shall conclude at the Western Zone Annual House of Delegates meeting two years after appointment, unless re-appointed to another two-year term.
  - e) It is recommended that the coaches appointed to the committee reflect the following attributes:
    - i. Have at least three years of experience as a coach of athletes competing at the Western Zone Age Group Championship.
    - ii. Represent the variety of LSC team sizes that attend the Western Zone Age Group Championship, i.e., teams under 25 athletes ("small"), teams between 25 45 athletes ("medium"), and teams with more than 45 athletes ("large").
    - iii. Represent the three Sectional regions of the Western Zone, i.e., California/Nevada, Four Corners, and Northwest.
- 2) The Meet Referee of upcoming year's event.
  - a) The incoming Meet Referee shall join the committee following the current year's Western Zone Annual House of Delegates.
  - b) Upon joining the committee, the incoming Meet Referee shall have voice and vote.

- c) The term on the committee for outgoing Meet Referee shall be completed when:
  - i. All reports on the current year's event have been presented at the Western Zone Annual House of Delegates

- d) It is recommended that, whenever possible, the incoming Meet Referee be named prior to the current year's Western Zone Annual House of Delegates.
- 3) The Meet Host Representative of upcoming year's meet.
  - a) The incoming Meet Host Representative shall join the committee following the current year's Western Zone Annual House of Delegates.
  - b) Upon joining the committee, the incoming Meet Host Representative shall have voice and vote.
  - c) The term on the committee for outgoing Meet Host Representative shall be completed when:
    - i. All reports on the current year's event have been presented at the Western Zone Annual House of Delegates
    - ii. The incoming Meet Host Representative has joined the committee.
  - d) It is recommended that, whenever possible, the incoming Meet Host Representative be named prior to the current year's Western Zone Annual House of Delegates.
- 4) The Senior Western Zone Director shall serve as an active member of the committee with voice and vote.
- 5) The Western Zone Championship Coordinator.
  - a) The Western Zone Championship Coordinator shall serve as an ex officio member of the committee, with voice but no vote. *Exception:* In the event of a tie vote, the Championship Coordinator shall cast the tie-breaking vote.
  - b) The Western Zone Championship Coordinator shall serve as the chair of the committee, with the following responsibilities:
    - Coordinate with committee members regarding meeting times and agenda items to be addressed
    - ii. Prepare a written agenda for all committee meetings.
    - iii. Distribute minutes following the meeting to committee members for review to ensure accuracy.
    - iv. Maintain a current and correct copy of the Western Zone Age Group Championship Meet Announcement Template, Appendix B of these Administrative Procedures.
    - Provide reports on committee actions as requested by the Western Zone Directors for distribution to the Western Zone LSCs.

    - c. SPECIAL REQUIREMENT: It is highly recommended that all participating LSCs provide timers (two preferred) to cover one lane for all sessions for the duration of the event.
  - 3) *Timing Equipment Operator(s)*, experienced in the management and operations of championship-level events (minimum of two recommended)

  - a. Are currently registered as Premium or Outreach members of USA Swimming. There will be no on-deck USA Swimming registration.
  - b. Are currently registered within the LSCs of the Western Zone as of the date entries close. On-deck transfer into an eligible LSC is not allowed.
  - c. Are no older than 14 years of age as of the first day of competition.
  - d. Have been selected by their LSC to participate in this meet as a member of their designated LSC team.
  - e. Have qualifying entry times achieved at USA Swimming sanctioned, approved, or observed competitions between the first day of competition of the Western Zone Age Group Championship of the prior year and the close of entries.
- 2. The complete list of eligibility requirements is found under <u>Eligibility</u> in the Western Zone Age Group Championship Meet Announcement Template, Appendix B of these Administrative Procedures.

#### **Meet Dates**

- 1. The Age Group Championship Coaches Advisory Committee will develop a three-year schedule of meet dates, to be updated annually and presented at the Western Zone Age Group Annual Business Meeting, for approval at the Western Zone Annual House of Delegates.
- 2. The three-year schedule should include the following recommendation: The Age Group Zone Championships should be scheduled after the conclusion of the summer championships of the Western Zone LSCs.

#### **Meet Format**

The Age Group Championship Coaches Advisory Committee will develop recommendations regarding the Age Group Zone Championship meet format, to be presented at the Western Zone Age Group Annual Business Meeting for consideration per the guidelines in Article 6.1.7. of these Administrative Procedures.

- b. Except for sanctioning, governing rules, and meet entry fees, items that are NOT highlighted are meet-specific and may only be changed at the Western Zone Age Group Annual Business Meeting per the guidelines in Article 6.1.7. of these Administrative Procedures
- c. Sanctioning and governing rules must meet the requirements set forth by USA Swimming and the host LSC.
- d. Meet entry fees may only be changed by a vote of the House of Delegates at the Western Zone Annual Business Meeting.

#### **Meet Fees**

- 1. Regular Entry Fees.
  - a. Athlete Surcharge: \$25.00 per athlete (\$20 of which is retained by meet host and \$5.00 paid to Western Zone treasury, and designated for funding of Zone meets).
  - b. Individual Entry Fees: \$20.00 per individual event (\$15.00 retained by meet host / \$5.00 paid to Western Zone treasury, of which \$2.50 is designated for support of the Western Zone Officials Assistance Fund.)
  - c. Relay Entry Fees: \$30.00 per relay event (\$25.00 retained by meet host / \$5.00 paid to Western Zone treasury, of which \$1.00 is designated for support of the Western Zone Officials Assistance Fund)
- 2. Late Entry Fees and Fines.
  - a. An LSC whose entire entry is received no more than 24 hours late, may enter its athletes into the Western Zone Age Group Swimming Championship subject to the following:
    - 1) Late Entry Fee: The late LSC shall pay to the meet host an administrative penalty equal to that LSC's total entry fees.
    - 2) The late LSC shall not score points for its individual swims but shall receive points from all its swum relays.
    - 3) The late LSC's swimmers shall be seeded correctly, shall earn individual awards and times of record.
  - b. An LSC whose entire entry is received more than 24 hours late will not be entered into the Western Zone Age Group Swimming Championship.
- 3. Failure to provide valid Proof of Time for an athlete's entry:
  - a. Entry times not in the SWIMS database must be proven to the Administrative Referee or designated representative by the LSC upon request.
  - b. Failure to provide such proof of time will result in a \$250.00 fine to the athlete's LSC.
  - c. The athlete will not be allowed to compete in an event that does not have a proven time. It is the responsibility of the entering LSC to verify that entry times are in SWIMS or to provide proof of times.
- 4. Coaches Heat Sheet Fees.
  - a. Meet hosts may choose to charge a heat sheet fee for teams requesting more than six (6) copies of the session heat sheet for their team.
  - b. If a heat sheet fee is charged, the maximum fee is \$5 per coach for every coach over seven (7) per team for the entire event, for seven (7) or more copies per session.
- 5. Spectator Fees.
  - a. Meet hosts may choose to charge a spectator fee for this event.
  - b. If a spectator fee is charged by the host, the maximum fee is \$15 per adult, per day.

#### **Open Water Championship Coaches Advisory Committee**

#### 1. Responsibilities.

- a. To provide representation and voice on the behalf of Western Zone teams, coaches, athletes, and officials in prescribing the format and conduct of the Western Zone Open Water Championships.
- b. To develop, promote, and assist in the format and conduct of the Western Zone Open Water Championships.
- c. To aid and assist in the distribution of information specifically regarding the Western Zone Open Water Championships to the LSCs within the Western Zone.

#### 2. Membership.

- a. Athlete Members:
  - 1) The Western Zone Athlete Director and the Western Zone Junior Athlete Representative shall be active members of the committee throughout their regular elected term, with voice and vote.
  - 2) At their discretion, the Western Zone Athlete Director and the Western Zone Junior Athlete Representative may appoint other athlete members of the Western Zone to serve as their designee(s) on the committee, with voice and vote.
  - 3) If the Western Zone Athlete Director and the Western Zone Junior Athlete Representative appoint other athlete members of the Western Zone to serve as their designee(s) on this committee, the term of service of the appointed athlete(s) will be the same as that of the Western Zone Athlete Director and the Western Zone Junior Athlete Representative.
  - 4) If the Western Zone Athlete Director and the Western Zone Junior Athlete Representative appoint other athlete members of the Western Zone to serve as their designee(s) on this committee, it is recommended that the appointed athlete(s) have direct experience with competing at the Western Zone Senior Championships.

#### b. Non-Athlete Members.

- 1) Appointed Coaches. Three coach members shall be appointed to the committee, as follows:
  - a) At the beginning of their two-year term, the Western Zone Directors and the Western Zone Open Water Coordinator shall each appoint one coach member to serve on the committee for a two-year term.
  - b) Appointed coach members shall have voice and vote.
  - c) There shall be no limit to the number of two-year terms that an appointed coach may serve on the
  - d) The two-year term for appointed coaches shall begin immediately following the Western Zone Annual House of Delegates meeting and shall conclude at the Western Zone Annual House of Delegates meeting two years after appointment, unless re-appointed to another two-year term.
  - e) It is recommended that the coaches appointed to the committee reflect the following attributes:
    - i. Have at least three years of experience as a coach of athletes competing at the Western Zone Open Water Championships.
    - ii. Represent the variety of team sizes that attend the Western Zone Senior Championship, i.e., teams under 10 athletes ("small"), teams between 10 25 athletes ("medium"), and teams with more than 25 athletes ("large").
    - iii. Represent the three Sectional regions of the Western Zone, i.e., California/Nevada, Four Corners, and Northwest.
- 2) The Meet Referee of upcoming year's event.
  - a) The incoming Meet Referee shall join the committee following the current year's Western Zone Annual House of Delegates.
  - b) Upon joining the committee, the incoming Meet Referee shall have voice and vote.
  - c) The term on the committee for outgoing Meet Referee shall be completed when:
    - i. All reports on the current year's event have been presented at the Western Zone Annual

- ii. The incoming Meet Referee has joined the committee.
- d) It is recommended that, whenever possible, the incoming Meet Referee be named prior to the current year's Western Zone Annual House of Delegates.
- 3) The Meet Host Representative of upcoming year's meet.
  - a) The incoming Meet Host Representative shall join the committee following the current year's Western Zone Annual House of Delegates.
  - b) Upon joining the committee, the incoming Meet Host Representative shall have voice and vote.
  - c) The term on the committee for outgoing Meet Host Representative shall be completed when:
    - i. All reports on the current year's event have been presented at the Western Zone Annual House of Delegates
    - ii. The incoming Meet Host Representative has joined the committee.
  - d) It is recommended that, whenever possible, the incoming Meet Host Representative be named prior to the current year's Western Zone Annual House of Delegates.
- 4) The Senior Western Zone Director shall serve as an active member of the committee with voice and vote.
- 5) The Western Zone Open Water Coordinator.
  - a) The Western Zone Open Water Coordinator shall serve as an ex officio member of the committee, with voice but no vote. *Exception:* In the event of a tie vote, the Open Water Coordinator shall cast the tie-breaking vote.
  - b) The Western Zone Open Water Coordinator shall serve as the chair of the committee, with the following responsibilities:
    - i. Coordinate with committee members regarding meeting times and agenda items to be addressed.
    - ii. Prepare a written agenda for all committee meetings.
    - iii. Distribute minutes following the meeting to committee members for review to ensure accuracy.
    - iv. Maintain a current and correct copy of the Western Zone Open Water Championship Meet Announcement Template, Appendix C of these Administrative Procedures.
    - v. Provide reports on committee actions as requested by the Western Zone Directors for distribution to the Western Zone LSCs.
- 5) The Junior Western Zone Director, and the Western Zone Officials Coordinator shall serve as ex officio members of the committee, with voice but no vote.

#### **Meet Host Bids**

#### 1. Requirements to bid:

- a. Meet host bids shall include a venue that meets or exceeds the requirements stated in USA Swimming Rules and Regulations, Article 702.
- b. Potential meet hosts must be willing and able to meet the requirements outlined in the USA Swimming Zone Championship contract.
- c. Potential meet hosts must be willing and able, at the expense of the host, to provide the essential meet staff as described in Articles 701.7 through 701.23 of the current USA Swimming Rulebook, and as noted below:
  - 1) Western Zone Open Water Coordinator
  - 2) Additional administrative personnel as necessary, experienced in the management of championship-level open water events.
- d. Potential meet hosts must be willing and able to provide the following additional items, at the expense of the host:
  - 1) *Meet credentials (meet-specific identification)* for athletes, coaches, officials and meet staff, including any designated meet volunteers.
  - 2) Hospitality for credentialed coaches and officials
  - 3) Awards, as determined by the Open Water Championship Coaches Advisory Committee for this event.
  - 4) Meet-specific Officials Polo or other designated Officials "thank you" item.
    - a. It is recommended that the meet host and meet referee work together to determine the nature and parameters of the designated Officials "thank you" item (traditionally a meet-specific Officials Polo).
    - b. Parameters for the Officials "thank you" item should include such detail as cost to the host, design

of the "thank you" item, and availability.

#### 2. Submission of Meet Bids.

It is recommended that:

- a. Meet Host Bids for the Western Zone Open Water Championships be placed on the Agenda of the Western Zone Annual House of Delegates two years prior to the scheduled date of the event.
- b. Potential meet hosts prepare a presentation demonstrating how the requirements for bidding will be met.
- c. A representative from the potential meet host be present at the Western Zone Annual House of Delegates to deliver the meet host bid and answer any questions that may arise regarding the meet bid.

#### 3. Awarding of Meet Bids.

- a. The voting delegates present at the Western Zone Annual Meeting shall choose the meet host for the Western Zone Open Water Championships by secret ballot from the meet host bids presented at that meeting.
- b. The results of the secret ballot shall be announced, and the awarding of the meet bid shall take place prior to the adjournment of the Western Zone Annual Meeting in which the voting takes place.

#### **Meet Host Responsibilities**

#### 1. Contractual Obligations.

- a. The awarded meet host shall execute the USA Swimming Zone Championship contract within 30 days of receipt from USA Swimming.
- b. The awarded meet host shall receive any funds due from USA Swimming upon successfully completing all contractual terms.
- c. The awarded meet host shall not be obligated by contracts between other member LSCs of the Western Zone and any of their vendors or suppliers.

#### 2. Pre-Meet Responsibilities.

- a. It is recommended that information on key facility details as well as travel and lodging resources be shared at the Western Zone Annual Meeting prior to the event.

- d. It is recommended that the meet host present a summary report at the Western Zone Annual Meeting following the completed event, that includes the following information:
  - 1) Number of LSCs, teams, and athletes participating
  - 2) Number of coaches and officials
  - 3) Athlete entry count including total individual and relay entries.
  - 4) Event highlights, including challenges encountered and solutions implemented.
- e. It is requested that the meet host be available for consultation with future meet hosts, as needed.

#### **Sanction and Governing Rules**

- 1. The meet host shall obtain a USA Swimming approval for the open water event.
- 2. Following the approval of the open water event by USA Swimming, the meet host shall then obtain a sanction from

#### **Eligibility**

- 1. This meet is open to all athletes who:

  - b. Are currently registered within the LSCs of the Western Zone as of the date entries close. On-deck transfer into an eligible LSC is not allowed.
  - c. Have qualifying entry times achieved at USA Swimming sanctioned, approved, or observed competitions between June 1 of the year prior to the current meet (13 months), and the close of entries.
- 2. Complete eligibility requirements for this event are found under <u>Eligibility</u> in the Western Zone Open Water Championship Meet Announcement Template, Appendix C of these Administrative Procedures.

#### Meet Dates

- 1. The Open Water Championship Coaches Advisory Committee will develop a three-year schedule of meet dates, to be updated annually and presented at the Western Zone Annual Business Meeting.
- 2. The three-year schedule should include the following recommendation: the event should fall between May 1<sup>st</sup> and September 30<sup>th</sup> as determined by the awarded meet host bids.

#### **Meet Format**

  - b. Input from the Meet Referee and Meet Host of that year's event.
- 3. Complete details of the meet format are described in the Western Zone Open Water Championship Meet Announcement Template, Appendix C of these Administrative Procedures.
  - a. Items in the Meet Announcement Template that are highlighted in yellow are host-specific or official-specific and may be changed annually per the needs and requirements of that year's meet host or meet referee.
  - b. Except for sanctioning, governing rules and meet entry fees, items that are NOT highlighted in yellow are meet-specific and may only be changed by the Open Water Championship Coaches Advisory Committee.
  - c. Sanctioning and governing rules must meet the requirements set forth by USA Swimming and the host LSC.
  - d. Meet entry fees may be changed at the discretion of the meet host, in consultation with the Western Zone Open Water Coordinator.

A: The 1500M Freestyles will be conducted as Timed Finals, with the fastest heat of women and the fastest heat of men swimming in Finals, in Event Order.

All other heats will be swum **fastest to slowest,** alternating women's and men's heats, at the end of the Preliminary session, following relays.

### **RULES**

- Conduct of the sanctioned event shall conform in every respect to current rules of USA Swimming including technical and administrative rules and the Minor Athlete Abuse Prevention Policy ("MAAPP"). All adults participating in or associated with this meet acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with MAAPP is a condition of participation in the conduct of this competition. Additional details regarding Safe Sport compliance can be found on p. 10 of this meet announcement. Current Central California Swimming Policies & Procedures will also apply.
- All athletes ages 18-19 must have completed and be current with the USA Swimming Athlete Protection Training certification to compete.
- The age of the athlete will be his/her age as of July 25, 2023 (the first day of competition).
- All athletes entered in the meet must be under the supervision of a USA Swimming member coach during warm-up, competition, and warm-down. Any athlete without a coach in attendance must report to the Meet Director or Meet Referee who may assist an athlete in making supervision arrangements, but it is the athlete's responsibility to make these arrangements prior to the start of the meet and to so notify the Meet Referee.
- Any athlete entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start, including both a Forward Start and a Backstroke Start, or must start each race from within the water without the use of the backstroke ledge. When unaccompanied by a member-coach, it is the responsibility of the athlete or the athlete's legal guardian to ensure compliance with this requirement and to bring proof of such certification to the meet.
- It shall be the athletes' and coaches' responsibility to acquaint themselves with all the information in this Meet Announcement and any information and changes announced at the General Meeting.
- Athletes and coaches are responsible for being familiar with this meet's scratch rules.
- Deck changes are prohibited.
- All athletes entered in the competition must comply with current USA Swimming rules regarding swimwear.
- The use of audio or visual recording devices, including a cell phone, is not allowed in changing areas, restrooms, or locker rooms.
- Per CCS Policies and Procedures, photography, including visual recordings, is not allowed behind the blocks during the entire event.

- 1. Are currently registered Premium or Outreach members of USA Swimming. There will be no on-deck USA Swimming registration.
- This is a closed meet and open only to athletes currently registered within the LSCs of the Western Zone as of the date entries close. On-deck transfer into an eligible LSC is not allowed.
  - Per CCS Policies and Procedures, all athletes must be registered for a minimum of 36 hours prior to the start of the meet; ie. no later than 12:00 pm Noon PDT on Sunday, July 23, 2023
- 3. Have qualifying entry times achieved at USA Swimming sanctioned, approved, or observed competitions between June 1, 2022, and the close of entries. Qualifying times for this meet will be the 2023 Western Zone Senior LC Championship "A" standards and Bonus standards for individual events. These are attached to this meet announcement on p. 11 12. There will be NO relay only athletes.
- 4. **De-qualification by Event**: Any athlete who has achieved a 2023 USA Swimming Junior National qualifying time or faster prior to the entry deadline (July 17, 2023) may not compete in that event, nor in that stroke and distance in a relay, at this meet. These standards are attached to this meet announcement on p.13.
- 5. Entry times must meet the proven times requirements listed below. It is the responsibility of the entering club, or individual if entering unattached, to verify that entry times meet these proven times requirements.
  - Meet Management reserves the right to request proof of times documentation at any point.

- To receive an evaluation, you must work a minimum of four sessions, have all your credentials up to date, and have completed the necessary USA Swimming requirements.
- Requests for evaluations must be received by July 5, 2023.

# **Officials Uniform**

The uniform for officials for the meet will be:

- Prelims & Finals: White polo shirt \* khaki shorts, skirt/skort, or pants \* white, closed toe shoes with white socks
- Meet-specific Officials Polo & Name Tag: All officials who have submitted their application by June 25, 2023, will receive a meet-specific Officials Polo for Finals & a personalized Name Tag. Please visit 2023 Western Zone Senior Championships Officials Application for additional information.

# **Officials Meetings**

ALL OFFICIALS MUST ATTEND THE MANDATORY OFFICIALS BRIEFINGS BEFORE EACH SESSION. Officials Meetings will be one hour before each day's sessions; location and exact times TBA.

### Officials Reimbursement Fund

This fund provides reimbursement assistance to officials who work at least 80% of the meet sessions including time trial sessions and who are not being reimbursed from another source for their expenses to attend the Western Zone Senior Championship Meet.

- > To be eligible, an official must be a USA Swimming member and in good standing with a Western Zone LSC.
- > The funds generated from this meet are shared equally across all applicants who have met the work requirements.
- NOTE: Any official from the host LSC is only eligible for \$150 stipend.

# SAFE SPORT

The Safe Sport program is USA Swimming's comprehensive abuse prevention program dedicated to reducing the risk of sexual, emotional and physical abuse to athletes. Components of the program include, but are not limited to, providing education and training, enforcing policies, rules and best practice guidelines, promoting healthy boundaries and mandated reporting of violations.

A quality control system has been implemented to ensure that individuals who are ineligible for participation are unable to participate in this competition. Additionally, all adult members of USA Swimming who have not completed their Athlete Protection Training will not be able to participate in this competition.

The Minor Athlete Abuse Prevention Policy ("MAAPP") (<a href="www.usaswimming.org/maapp">www.usaswimming.org/maapp</a>) prohibits Adult Participants (as defined) from having one-on-one interaction with minor athletes that is not within an observable and interruptible distance from another adult. Adult Participants are required to abide by this policy in full during this meet.

Pursuant to USA Swimming Rules and Regulations and federal law, it is every member's responsibility to immediately (i.e., within 24 hours) report any incident of child abuse, including physical or sexual abuse, to law enforcement and the U.S. Center for SafeSport. Reporting must occur when an individual has firsthand knowledge of misconduct or where specific and credible information has been received from a victim or knowledgeable third party. A report to the U.S. Center for SafeSport may be made via telephone at 833-5US-SAFE (833-587-7233) or online at <a href="https://www.uscenterforsafesport.org/report-a-concern">www.uscenterforsafesport.org/report-a-concern</a>. Various state laws may also require reporting to law enforcement or to a designated child protection agency.

For information on how to report other alleged violations, including without limitation, the USA Swimming Code of Conduct and the Minor Athlete Abuse Prevention Policy, please visit www.usaswimming.org/report.

All athletes age 18 and older must complete Athlete Protection Training ("APT") to be a USA Swimming registered member in good standing. Any athlete who turns 18 on or before July 25, 2023, who has not completed APT by the first day of competition, will be prohibited from participating in the competition until such time as all membership requirements are completed.

Times achieved by an athlete who turns age 18 on or before July 25, 2023, who competes in this USA Swimming sanctioned event without completing this membership requirement, will NOT count for qualification or recognition. This includes participation as a member of a relay.

# **RULES**

- Conduct of the sanctioned event shall conform in every respect to current rules of USA Swimming including technical and administrative rules and the Minor Athlete Abuse Prevention Policy ("MAAPP"). All adults participating in or associated with this meet acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with MAAPP is a condition of participation in the conduct of this competition. Additional details regarding Safe Sport compliance can be found on p. 13 of this meet announcement. Current Snake River Swimming Policies & Procedures will also apply.
- The age of the athlete will be his/her age as of August 2, 2023, the first day of competition.
- All athletes entered in the meet must be under the supervision of a USA Swimming member coach during warm-up, competition, and warm-down.
- Any athlete entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start, including both a Forward Start and a Backstroke Start, or must start each race from within the water without the use of the backstroke ledge.
- It shall be the athletes' and coaches' responsibility to acquaint themselves with all the information in this Meet Announcement and any information and changes announced at the General Meeting.
- Athletes and coaches are responsible for being familiar with this meet's scratch rules and procedures.
- Deck changes are prohibited.
- The use of audio or visual recording devices, including a cell phone, is not allowed in changing areas, restrooms, or locker rooms.
- Photography, including visual recordings, is not allowed behind the starting blocks during the start of a race or relay exchange.
- Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open-ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.
- Medical supervision will be available to all athletes participating in the meet. Personnel with current Red Cross lifeguarding, first aid, and CPR/AED certification will be available throughout warm-ups and competition. The facility's AEDs are located in the Northeast corner under the scoreboard and in the Southwest corner adjacent to the lobby doors.
- All athletes entered in the competition must comply with current USA Swimming rules regarding swimwear. Important Information on USA Swimming's Rules for Tech Suit Use for 12U Athletes can be found HERE on the USA Swimming website. Compliance with these rules is the responsibility of athletes, coaches, and parents.

# **RESTRICTIONS**

- This is a CLOSED-DECK meet.
  - Only athletes, coaches, officials, team chaperones, and assigned meet volunteers will be permitted on the competition deck.
  - Only athletes, coaches, officials, team chaperones, and others with appropriate credentials will be permitted in the Team Areas.
- Tobacco products of any kind, vaping, alcoholic beverages, and glass containers are not allowed in the swimming venue.
- Shaving is not permitted anywhere in the facility.
- Service animals only are allowed in the facility.

# **Athlete Supervision and Safety**

Per Western Zone policy, each LSC is required to have at least one adult chaperone in the Team Area supervising their LSC athletes whenever their athletes are in the Team Area. Teams are encouraged to monitor the location of their athletes in the venue when they are not actively competing.

Meet Marshals will be present to assist in the monitoring of athletes in the warm-up area, and on the competition deck. Additionally, occasional sweeps of the locker rooms will be performed (women checking girls locker rooms & men checking boys locker rooms).

# **ELIGIBILITY**

This meet is open to athletes who:

- 1. Are currently registered Premium or Outreach members of USA Swimming. There will be no on-deck USA Swimming registration.
- 2. Are currently registered with a USA Swimming LSC of the Western Zone as of the day meet entries close, July 26, 2023.
- 3. Are no older than 14 years of age as of the first day of the meet, August 2, 2023.
- 4. Have been selected by their LSC to participate in this meet as a member of their designated LSC team.
- 5. Have met the appropriate 2023 qualifying times in competition between August 3, 2022, and the entry deadline, July 26, 2023.
- 6. Have qualifying entry times achieved at USA Swimming sanctioned, approved, or observed competitions. Entry times not in the SWIMS database must be proven to the Administrative Referee or designated representative by the LSC upon request. Failure to provide such proof of time will result in a \$250.00 fine to the athlete's LSC. The athlete will not be allowed to compete in an event that does not have a proven time. It is the responsibility of the entering LSC to verify that entry times are in SWIMS or to provide proof of times. Proof of relay entry times is not required.
- 7. Athletes with disabilities: Each LSC may bring two (2) athletes with disabilities ages 12 and under, and two (2) athletes with disabilities, ages 13-14. Athletes with disabilities are not required to meet the qualifying time standards for their age group; however, they must provide a time for each event entered. - LSCs with entries exceeding 400 individual events and/or 160 "bonus" events, shall scratch down to the stated limits prior to Wednesday's Scratch Deadline of 6:00 pm on Tuesday, August 1st see Scratch Procedures, p.9. Failure to comply shall be deemed to have given the Meet Referee the authority to eliminate entries to comply with the stated limits. "Bonus" swims will be scratched first. Entries for athletes with disabilities are not included in the stated LSC limits.
- Each LSC is limited to one (1) "bonus" swim per gender, per age group, for individual events 400M or longer. Entries exceeding this limit must be scratched prior to the close of the scratch deadline for the event. If the LSC fails to scratch excessive entries, the Administrative Referee shall have the authority to eliminate entries to comply with the stated limits. "Bonus" swims will be scratched first. Entries for athletes with disabilities are not included in the stated LSC limits.

# Entry Limits, con't

- Relay Entries
  - Each LSC is limited to two (2) relays per relay event for **single** gender relays.
  - Each LSC is limited to three (3) relays per relay event for **mixed** gender relays.
    - Mixed gender relays must be comprised of two female athletes and two male athletes.
    - If an LSC enters three mixed gender relays, only the top two (2) finishing relays are eligible to score.
  - > Entry times for relays are required when meet entries are submitted. Proof of relay entry times is not required.
  - > Relays must be made up of athletes entered in the meet whose age and gender meet the event description. Athletes are limited to one age group relay per session.
  - > Relays will be scored, awards presented, and records kept for the following age groups: 10&U, 12&U, 14&U.

**NO REFUNDS** will be given for submitted entries that are subsequently scratched by an LSC's coach, the Meet Referee, or the Administrative Referee.

# **Administrative Entry Errors**

Entries for an athlete that are incorrect due to administrative error may be corrected if the following requirements are met:

- 1. The LSC entering the athlete can prove, with documentary evidence, to the satisfaction of both the Meet Referee and the Administrative Referee that the administrative error is exclusively the fault of the LSC and not in any way the fault of the athlete.
- Such documentary evidence must be submitted to the Meet Referee or the Administrative Referee <u>prior</u> to 6:00 pm, Tuesday, August 1<sup>st</sup> (NOexceptions) where it will be subject to approval. If approved, the athlete shall be seeded correctly.

### **Late Entries**

Late entries will only be accepted in accordance with the Western Zone Swimming Championship Regulations, Section VII.9.5.10.

# In summary:

- If the meet reaches capacity prior to the entry deadline, swimmers already entered in the meet may continue to add events up until the entry deadline.
- Entry times may be updated via OME up until the entry deadline. Entry times may not be updated after the entry deadline.

# **OME Information:**

- OME only permits entering 5 relays for the mixed gender relays. Teams that need to add an F relay to the mixed gender relay events must email Patrick Hunter, <a href="mailto:phunter.usaswimming@gmail.com">phunter.usaswimming@gmail.com</a>, to enter the additional relays.
- With the submission of entries, the coach/team representative attests that all athletes entered are registered with USA Swimming.
- Once you complete your online entry, you will be sent a confirmation email. Your entry is not considered to be
  accepted into the meet until you have checked-out and received this email. Bring it and all communications with
  you to the meet in case of any entry problems. When entering an individual time not yet in SWIMS, please try to
  ensure that the missing data is downloaded into SWIMS as soon as possible. An entry that is pending but not
  submitted/confirmed does not constitute entry into the meet.
- Please note that OME will not update entry times as new results are entered into SWIMS. You can return to your entry after you have checked out to modify entry times should they improve during the entry period or to add events to your entry, but you cannot delete events after you have checked out.\_-All entry modifications (i.e. adding events for swimmers already entered in the meet and/or updating entry times for qualified swims) must be made before the entry deadline.
- Check all entries prior to submission! Enter each one with an accurate time achieved in the proper course; converted times will not be accepted. Once an entry is submitted, the entering party is responsible for payment regardless of whether or not the athlete/team competes. Once entries are submitted, they may only be scratched, not removed. If you have trouble using OME, please contact Macie McNichols at USA Swimming: mmcnichols@usaswimming.org, (719) 866-3506.

Entry times not in the SWIMS database must be proven to the Administrative Referee or designated representative prior to the entry deadline for the event. Failure to provide such proof of time prior to that deadline will result in the athlete being removed from the event. It is the responsibility of the entering club, or individual if entering unattached, to verify that entry times are in SWIMS.

Whether entries are submitted electronically or on paper, by the action of entering the swimmer in the meet, the submitter, whether the swimmer, coach, parent or team representative, certifies that the swimmer is a currently registered member of USA Swimming and that all times stated in the entry are true and correct. The submitter further assumes responsibility for any false or incorrect times and understands that all listed entry times are subject to Utah Swimming Time Verification Procedures, and that a fine of \$20.00 shall be paid to Utah Swimming, Inc. for each incorrect time submitted. It is understood that an automatic call before the review section may be the result for a third entry time that cannot be verified. The submitter further agrees that a penalty of \$100.00 shall be assessed to anyone entering a swimmer in a meet sanctioned by Utah Swimming, Inc. who is not registered with USA Swimming at the time of entry, upon it being proven that the swimmer was not so registered.

- Entries must be submitted in the course in which they were achieved. Converted times may not be used.
- The person submitting a team's entry is the team entry representative and the received email implies the official signature of the team entry representative. Said person will be the only person to make changes and will be responsible for all fines and penalties resulting from inaccurate times and unregistered swimmers.

# Seeding:

- The top 3 heats of preliminary individual events 200 or less, and top 2 heats of preliminary individual events of 400 or more, will be circle-seeded
- The fastest athlete race in heat 1.
- Seeding order will be SCY, LCM, SCM, B-SCY, B-LCM, B-SCM
- 1650 Seeding order will be 1650Y-1500M-1000Y-800M

# **Scratch Procedure:**

The USA Swimming National Championship scratch procedure and no-show rules will be used at this meet. These rules are described in USA Swimming Rule 207.11.6 in the current Rulebook.

- Athletes are considered checked in for all individual events unless scratched.
- All scratches for preliminary and timed finals events may be made on site at the meet, or via email to the Admin Referee, Dale Ammon, dcammon5@gmail.com.
- The deadline for scratches for all Preliminary and Timed Finals Events, including Relays and the 1650Y Freestyles, will be 6:00 pm of the day PRIOR to the event being swum.
- Relays will follow the same scratch procedures as Individual Events Scratches for and are due to the Admin Referee prior to the scratch deadline for that day's events.

# Scratching From Finals

• All scratches from Finals must be completed within the deadlines specified by the USA Swimming Rule 207.11.6 and must be made on-site with the Administrative Referee at the meet.

# Warm-up Procedures:

USA Swimming and Utah Swimming warm-up procedures UTSI RR 1.9 will be enforced throughout the meet. Warm-up details will be distributed to coaches following the close of entries. However, the Meet Referee reserves the right to modify warm-ups as determined to be in the best interest of the safety of the athletes and the conduct of the meet.

Warm-ups are subject to the following procedures:

- Dive start times will be announced at the general meeting as well as listed in the meet director notes.
- Coaches have the responsibility of ensuring that all their swimmers are instructed in warm-up procedures and that the swimmers follow all Utah Swimming safety procedures. All swimmers will enter the pool from a sitting or 3-point position. No pushing, splashing, running or any other general horseplay. Swimmers engaging in such activities will be asked to leave the pool.
- All USA Swimming athletes must be under the supervision of a USA Swimming member coach during warm-up, competition, and warm-down. The Meet Director or Meet Referee may assist unaccompanied swimmers make arrangements for such supervision, but it is the swimmer's responsibility to make such arrangements prior to the start of the meet. 202.5.3.
- A separate warm-up and cool down area will be available throughout the meet.

# **Timers & Counters:**

- Timers will be provided for individual Finals events, including the 500 Freestyle and 400 Individual Medley
  events.
- Participating teams may be assigned lanes for assisting with timing for all Preliminary events including relays.
- Athletes will need to provide their own timers for Time Trials and the 1650Y Freestyles.

# **Time Trials Info:**

- Time Trials will be held under a separate sanction of Utah Swimming, Inc.
- SCY Time Trials will be conducted on a time-available basis and are limited to approximately one hour.
- Athletes must be entered in the 2025 SC Western Age Group Championships and have paid the athlete surcharge to swim in Time Trials.
- Athletes may enter any number of time trials during the meet but may not exceed the limit of three 3 individual
  events per day with a combination of time trials and individual meet events.
- Fees: \$20.00 per individual event \$40.00 per relay event

# Adaptive Swimming:

Adaptive swimming: In accordance with USA Swimming rule 202.4.15 & Article 105.1, and USI P&P 151, the Meet Referee has the authority to accommodate swimmers with disabilities. The coach or person in charge of team entries must notify the meet referee and meet entry contact of accommodations requests at the time of entry submission.

# **Image Authorization:**

All participants agree to be filmed and photographed by the official photographer(s) and network(s) of USA Swimming and Utah Swimming under the conditions authorized by USA Swimming, and allow event organizers the right to use names, pictures, likenesses, and biographical information before, during or after the period of participation in USA Swimming competitions to promote such competitions. All participants agree not to use medals or photos, or portraits or films with the medals, which are received for performances in this competition, for the purpose of trade.

# **Broadcast Statement:**

Photographs, videotape, audio, and/or other visual recordings of the event created by a spectator may be used solely for such spectator's personal non-commercial use and may not be broadcast, published, disseminated, or used for any commercial purpose without the prior consent of USA Swimming.

# Photography and Videos:

Photographers and/or videographers may be present on deck at this meet. Photographers and videographers are strongly encouraged to stay out of the area immediately behind the starting blocks, but if present are *specifically prohibited from making shots during the start phase of any race including relay exchanges*.

# Safety:

Meet marshals will be in place during the warm-up periods. Coaches have the responsibility of ensuring that all their swimmers follow all USA Swimming and Utah Swimming safety procedures. When unaccompanied by a member coach, it is the responsibility of the swimmer's legal guardian to ensure compliance.

# Rules:

- No swimmer will be permitted to compete unless the swimmer is a member as provided in Article 302.
- Deck entries will not be accepted.
- Deck registration will not be accepted as swimmers must be registered at time of entry.
- Current USA Swimming rules and regulations will govern this meet.
- All adults participating in or associated with this meet acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy (MAAPP), and that they understand that compliance with the MAAPP policy is a condition of participation in the conduct of this competition.
- Any swimmer under the age of 18 entered in the meet must have a current (within the year), athlete and parent signed Concussion Informed Consent Acknowledgement. If affiliated with a member club, it must be on file with the club. If unaffiliated with a member club, it is the responsibility of the swimmer or the swimmer's parent or legal guardian to ensure compliance with this requirement. UTSI P&P 303. Required Form: CONCUSSION IN YOUTH SPORTS Informed Consent Acknowledgement
- Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in
  performing a racing start or must start each race from within the water. When unaccompanied by a member
  coach, it is the responsibility of the swimmer or the swimmer's parent or legal guardian to ensure compliance
  with this requirement. 202.4.11D
- It shall be the athletes' and coaches' responsibility to acquaint themselves with all the information in this Meet Announcement and any information and changes announced at the General Meeting.

# **Restrictions:**

- This is a CLOSED-DECK meet. Only athletes, coaches, officials, and assigned meet volunteers will be permitted
  on the competition deck.
- Deck changes are prohibited. 202.4.111
- Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms. 202.4.11H
- Use of audio or visual recording devices, including a cell phone, is not permitted behind the starting area of the competition pool.
- Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coach, officials and/or spectators are present. 202.4.11J
- Only USA Swimming legal competition suits may be worn during competition. Drag suits may be added during warm-up.
- The sale and use of alcoholic beverages is prohibited in all areas of the meet venue.
- Smoking and the use of other tobacco products, (including e-cigarettes/vaping), is prohibited on the pool deck, in the locker rooms, in spectator seating, in standing areas and in all areas used by athletes during the meet and during warm up periods.

# **SAFE SPORT**

The Safe Sport program is USA Swimming's comprehensive abuse prevention program dedicated to reducing the risk of sexual, emotional and physical abuse to athletes. All athletes aged 18 and older must complete Athlete Protection Training ("APT") to be a USA Swimming registered member in good standing. Any athlete who turns 18 on or before **April 2**, **2025**, who has not completed APT by the first day of competition, will be prohibited from participating in the competition until such time as all membership requirements are completed.

Times achieved by an athlete who turns age 18 on or before **April 2, 2025**, who competes in this USA Swimming sanctioned event without completing this membership requirement, will NOT count for qualification or recognition. This includes participation as a member of a relay.
