#### WZ official Chair assistant:

### Jr Rep Athlete:

The position of Jr athlete rep was added, but clarifying if it is to be a non-voting position? Jackson stated it to be non-voting.

Keith States this is necessary as we need an odd number of voting delegates for "tie" purposes. This would keep the executive committee with a total of 5 voting members.

- Need a budget for any expected expenditure zone meets included who is paying what: host/zone?
- o Meet contracts should state who is paying the evaluator?
- Reserve general fund
  - set a base of \$30K? Currently at 27K (earmarked general fund\*)
- Lisa will email the reports from 2019 forward, only 2023 will have actual data in accounts as learned during this first term.

## Meet expenses- officials

- Discussion of expenditures the zone has been paying for assigned officials at meets/evaluators who pays?
  - Sectional meets, expenditures have been higher than zone meets.
  - Do not want to discourage hosts from bidding zone meets due to increased expenses.
    - o prefer to have multiple bidders and not restricted by these expenses

## Funding of meets via USA Swimming:

- 11 meets allowed, asking for a 12<sup>th</sup>.
  - o Note WZ most LSC's. may have the most athletes
    - keep reaching cap level of athletes so need to add another meet
